- 11 term as president? Go ahead and tell us the names of
- 12 the ones you remember.
- 13 A. Okay. There was HRCBM-P,
- 14 HRCBM-K, HRCBM-I, HRCBM-T, HRCBM-D.
- 15 That's all I can remember.
- 16 Q. Is there a Mr. HRCBM-Q?
- 17 A. Yes. HRCBM-Q . Thank you.
- 18 Q. Anyone else that you can recall?
- 19 A. None that I can recall.
- 20 Q. What area of your -- of the Houston Racquet
- 21 Club has the most water?
- 22 A. I'm sorry. Which area of the Racquet Club
- 23 has the most water?
- 24 Q. Yes, sir.
- 25 A. We have two pools that carry the most --

- 1 water, I'm not sure which one carries more water than
- 2 the other.
- 3 Q. And which pool with water would have the
- 4 most young children in it?
- 5 A. It can be equal at times, but the resort
- 6 pool.

- 7 Q. The family pool?
- 8 A. Yeah. Whichever you call it, yeah. I've
- 9 always called it the resort pool. I'm sorry.
- 10 Q. I mean, it's designed for children more so
- 11 than the lap pool; wouldn't you agree? It's got all
- 12 the water features and all that?
- 13 A. More so than the lap pool, but teaching does
- 14 go on in the lap pool.
- 15 Q. Okay. And as far as young children, what do
- 16 you think the most dangerous part of the Club
- 17 premises is, where the most risk is?
- 18 A. The pool does have risk to it, so the pool.
- 19 Q. That would be --
- 20 A. There's a playground, but...
- 21 Q. The pool would be -- one or both of the
- 22 pools at the Houston Racquet Club would be the area
- 23 of the Club that would be the riskiest for young
- 24 children. Would you agree with that?
- 25 A. Yes.

- 1 Q. And of course, if you have an area of the
- 2 Houston Racquet Club that's -- has safety risks for
- 3 young children, you certainly want to make sure that
- 4 you have a committee that's devoted to focusing on
- 5 those risks, wouldn't you?
- A. I don't know.
- 7 Q. Isn't that a good practice?
- A. I don't know.
- 9 Q. Don't you think as president of the Houston
- 10 Racquet Club during that time frame that that
- 11 probably is a good idea?
- 12 A. It's an area that needs to be addressed.
- 13 Q. Well, has the Houston Racquet Club, to your
- 14 knowledge, established a pool committee since the
- 15 drowning of John Pluchinsky?
- 16 A. Not specifically.
- 17 Q. Well, how have they done so nonspecifically?
- 18 A. It falls underneath the fitness committee.
- 19 Q. It's the same as it was before?
- 20 A. Which is -- in that specific area, yes.
- 21 Q. Well, in what specific area does it not
- 22 exist the same way it did before Mr. --
- 23 A. The --
- 24 Q. -- John Pluchinsky's death?
- 25 A. As far as the structure of where pool issues

- 1 and discussions are held, they are held within the
- 2 fitness committee and has not changed --
- 3 Q. Okay.
- 4 A. -- since.
- 5 Q. So with respect to committees and pool
- 6 safety issues, those are addressed the same way today
- 7 as they did before John Pluchinsky's death, correct?
- 8 A. They are within the same structure of the
- 9 committees, yes.
- 10 Q. In what way have they changed?
- 11 A. As far as the structure of where it falls
- 12 within the committee, that has not changed.
- 13 Q. How has it changed, if at all?
- 14 A. To my knowledge, it has not changed but I'm
- 15 not the president currently.
- 16 Q. Okay. Certainly, as president of the
- 17 Houston Racquet Club, you had the authority to
- 18 establish any committees you felt were appropriate
- 19 for the Club, correct?
- 20 A. Correct.
- 21 Q. You certainly had the authority on the first
- 22 day you became president, if you wanted, to establish
- 23 a committee, whether you want to call it a pool
- 24 committee or a safety committee, to make sure that
- 25 your pools are safe for young children, correct? \Box 00028
 - 1 MR. REESE: Objection, form.
 - 2 Q. (BY MR. MARRS) If you had wanted to?
 - 3 A. I'm sorry. Could you -- I apologize. Could
 - 4 you repeat the --
 - 5 Q. No problem. I'll be happy to.
 - 6 You could have -- The first day you
 - 7 walked in as president of the Houston Racquet Club,
 - 8 you had the authority to establish a pool committee
 - 9 or safety committee to focus on safety of the pools
 - 10 for young children, if you had chosen?
 - 11 A. If I would have had the authority or chosen,
 - 12 yes.
 - 13 Q. Okay. And you had the authority to do that,
 - 14 didn't you?
 - 15 A. Yes.
 - 16 Q. Okay. Any other committees at the Houston
 - 17 Racquet Club that you were a member of other than the
 - 18 tennis, fitness, club affiliations and finance
 - 19 committees?
 - 20 A. I believe I may have been on the hospitality

- 21 committee, but I'm not certain if that was my last
- 22 year or the year before, but I was -- I may have been
- 23 on the hospitality committee.
- 24 Q. Any others?
- 25 A. Not that I can remember.

- 1 Q. And the fitness committee, when were you a
- 2 member of that specifically?
- 3 A. It was my second year, so that's '05, '06.
- 4 Q. Did you during the time that you were a
- 5 member of the fitness committee ever raise any safety
- 6 concerns regarding pool safety for children in either
- 7 of your two pools?
- 8 A. I can't remember.
- 9 Q. Not that you can remember?
- 10 A. No.
- 11 Q. Is that correct?
- 12 A. That's correct.
- 13 Q. And did you ever raise, during the time you
- 14 were a fitness committee member, concerns or issues
- 15 relating to lifeguards not doing their jobs in some
- 16 way?
- 17 A. Not that I can remember.
- 18 Q. Did you ever raise any such issues as
- 19 president of the Houston Racquet Club?
- 20 A. Not that I can remember.
- 21 Q. What did you spend most of your time doing
- 22 as president of the Houston Racquet Club?
- 23 A. I attended most of the committee meetings
- 24 throughout the month. I conducted the once-a-month
- 25 Board meeting. Make myself generally available to

- 1 the membership. There are other activities, such as
- 2 anything specific to -- like we -- working on
- 3 refinancing the Club, long-range planning generally
- 4 is what I spent my time doing.
- 5 Q. And of those things, what was, during the
- 6 time you were president, the thing that took the most
- 7 of your time, was the largest percentage of your
- 8 time?
- 9 A. Attending different committee's meetings
- 10 when I could. The Board meeting was two hours once a
- 11 month. But attending the six or seven different
- 12 committee's meetings throughout the month was
- 13 probably what I spent all of my time doing. I can't
- 14 remember -- I can't think of anything else

- 15 specifically.
- 16 Q. And let's explain to the jury -- I mean,
- 17 being President of the Houston Racquet Club is not a
- 18 full-time job, is it?
- 19 A. No, it's not.
- 20 Q. I mean, you have another full-time job,
- 21 right?
- 22 A. That's correct.
- 23 Q. And you run a business; is that right?
- 24 A. That's correct.
- 25 Q. Is that a software-related business?

- 1 A. The Secure Messaging System is an automated
- 2 telecommunications business. My main line of
- 3 business is the Medical Profiles.
- 4 Q. Safe to say that's a full-time business?
- 5 A. Yes.
- 6 Q. Full-time job for you?
- A. Yes.
- 8 Q. Okay. So how much -- how many hours during
- 9 the week would you typically devote to Houston
- 10 Racquet Club activities, issues?
- 11 A. I can estimate five hours a week. Sometimes
- 12 it's more; sometimes it's less.
- 13 Q. Who really ran the Houston Racquet Club on a
- 14 day-to-day basis during the time you were president?
- 15 A. Rely on the general manager and the staff to
- 16 run the day-to-day activities.
- 17 Q. Okay. And who really made most day-to-day
- 18 operational decisions at the Houston Racquet Club
- 19 during the time you were president?
- 20 A. The general managers in charge and charged
- 21 with running the day-to-day activities of the Club
- 22 and his staff.
- 23 Q. And who is that?
- 24 A. Steve Griffin is the general manager.
- 25 Q. Who is here today, correct?

- 1 A. Correct.
- 2 Q. And whether it was on a committee or
- 3 otherwise, did anyone complain to you when you were
- 4 president of the Houston Racquet Club prior to
- 5 John Pluchinsky's death that there were safety issues
- 6 relating to the pool at the Racquet Club?
- A. I have not had any specific complaints about
- 8 safety issues at the Racquet Club while I was

- 9 president.
- 10 Q. How about nonspecifically?
- 11 A. I can't remember any nonspecific complaints.
- 12 Q. Okay. Or specific or nonspecific complaints
- 13 that you became aware of? In other words, that
- 14 weren't made directly to you since you don't recall
- 15 any, but that were made known to you?
- 16 MR. REESE: Is that still prior to his
- 17 death?
- 18 MR. MARRS: Correct.
- 19 A. I'm sorry. About -- I hate to do this to
- 20 you. Could you repeat --
- 21 Q. (BY MR. MARRS) Well, I'm now asking you --
- 22 A. Okay.
- 23 Q. Other than -- You already testified you
- 24 don't recall any complaints made to you during the
- 25 time you were president of the Houston Racquet Club □00033
- 1 prior to John Pluchinsky's death, safety complaints
 - 2 or safety concerns. I'm asking you --
 - 3 A. Okay.
 - 4 Q. -- other than those made directly to you,
 - 5 were any safety concerns made known to you while you
- 6 were president of the Houston Racquet Club --
- 7 A. Okay.
- 8 Q. -- prior to John Pluchinsky's death?
- 9 A. Lunderstand. Lunderstand. I'm sorry.
- 10 Q. That's where I'm going.
- 11 A. Yes.
- 12 Q. Such as what?
- 13 A. There were concerns about elementary and
- 14 junior high kids going back to the woods to play.
- 15 There were concerns about skateboarders, bicycle
- 16 riders, roller-bladers at the Club.
- 17 Q. Any complaints made known to you or concerns
- 18 relating to pool safety or lifeguards not doing their
- 19 jobs prior to John Pluchinsky's death?
- 20 A. Repeat the question again. I'm sorry.
- 21 Q. Any complaints or concerns regarding pool
- 22 safety or lifeguards not doing their jobs made known
- 23 to you prior to John Pluchinsky's death?
- 24 A. No.
- 25 Q. So, who is the president of the Houston
- □00034
 - 1 Racquet Club ultimately responsible to?
 - 2 A. I would assume that's the members.

- 3 Q. And what about the Board? Do you answer to
- 4 the Board or not when you're president?
- A. I don't understand the answer, but yeah. I
- 6 work with the Board. We work together.
- 7 Q. Okay. Other than working with the Board or
- 8 working together, do you have to answer to the Board
- 9 of Directors of the Houston Racquet Club?
- 10 A. Yes. I communicate with the Board. I would
- 11 need to -- I would need to talk to them.
- 12 Q. To your knowledge, did they have the
- 13 authority to remove you as president?
- 14 A. I don't know.
- 15 Q. To your knowledge, did they have the
- 16 authority to direct you to do certain things?
- 17 A. They could vote to do -- a majority vote
- 18 could do, yes.
- 19 Q. Could do what?
- 20 A. Could do certain -- could do things.
- 21 Q. Okay. And who reported to you as
- 22 president? I'll tell you what, let's do this: Why
- 23 don't we explain to the jury what the management
- 24 structure of the Racquet Club during the time you
- 25 were president was, who reported to, what the chain $\square 00035$
 - 1 was from the top to the bottom, management wise.
 - 2 A. The management of the Board or the Club?
 - 3 The -- There's a president of the Board, there's a
 - 4 vice president of the Board. There's a secretary of
 - 5 the Board. There are committee members -- chairs and
 - 6 committee members. There's a general manager who
 - 7 reports to the Board and to the president. The
 - 8 general manager has heads of departments and then the
 - 9 heads of departments have employees.
 - 10 Q. Right. So let's take the first one. Let's
 - 11 take the Board and tell us who the various like
 - 12 president, vice president, secretary of the Board
 - 13 were during the time you were president of the
 - 14 Racquet Club.
 - 15 A. Okay. I was the president. HRCBM-H
 - 16 was the vice president. HRCBM-B was the
 - 17 secretary. The chairs, do you want -- did you want
 - 18 to know the chairs of the various committees?
 - 19 Q. Yes, sir.
 - 20 A. Okay. You have FC as your
 - 21 fitness, the head of the fitness. HRCBM-D was
 - 22 head of the food and beverage. HT was head

- 23 of tennis. HRCBM-B was in charge of the
- 24 facilities. Membership was HRCBM-U.
- 25 Q. Uh-huh.

- 1 A. Finance was HRCBM-H. I can't think of
- 2 any other ones.
- 3 Q. And were there any other say officers or
- 4 those that were -- had some degree of management
- 5 responsibility other than the positions that you just
- 6 mentioned?
- A. Well, I guess I don't understand the word
- 8 "management."
- 9 Q. Well, those that have -- that could make
- 10 decisions on behalf of the Club or make
- 11 recommendations.
- 12 A. That's all I can think of at this particular
- 13 time.
- 14 Q. I know you had an HRC Women's Association
- 15 Executive Board as well, correct?
- 16 A. Yes. The head of the women's association
- 17 attended Board meetings, but did not have a vote.
- 18 Q. Okav.
- 19 A. And that could have been HRCBM-L, the
- 20 head of -- the head of that.
- 21 Q. And what other clubs in the Houston area
- 22 have you been a member of?
- 23 A. I grew up at the Forest Club. I was a
- 24 member of West Side Tennis Club. I was a member at
- 25 the Metropolitan Racquet Club. I believe that's it.

- 1 Q. No others that come to mind?
- 2 A. No.
- 3 Q. And what -- are you currently a member of
- 4 any of those clubs?
- 5 A. No.
- 6 Q. What years were you a member of Forest?
- A. My parent -- my parents -- I'm sorry, my
- 8 parents were members; I was a child. So until I left 9 for college.
- 10 Q. Okay.
- 11 A. I went to college in 1979.
- 12 Q. And West Side?
- 13 A. Approximately 1989 or '90 to 1992,
- 14 approximately that time frame. I'm not sure.
- 15 Q. How about Metropolitan Racquet?
- 16 A. That would have maybe been in the late '90s,

- 17 mid to late '90s.
- 18 Q. Did you hold any positions at Metropolitan?
- 19 A. No.
- 20 Q. West Side?
- 21 A. No.
- 22 Q. Forest?
- 23 A. No.
- 24 Q. Have you ever been an employee of a club?
- 25 A. Yes.

- 1 Q. Which ones?
- A. West Side Tennis Club, prior to my
- 3 membership.
- 4 Q. As what?
- 5 A. Tennis professional. I have taught lessons
- 6 to a -- two or three hours a week up until about
- 7 three years ago at the Houston City Club, so I did
- 8 that for about eight years, so, do my math.
- 9 Q. Are you considered the tennis pro there?
- 10 A. Assistant tennis pro.
- 11 Q. Okay. Where else? Any other clubs you've
- 12 been an employee of?
- 13 A. No. I was considered an independent
- 14 contractor at those particular clubs.
- 15 Q. Okay. Independent contractor at any other
- 16 clubs, to your knowledge?
- 17 A. I believe I taught tennis lessons at the
- 18 Metropolitan Racquet Club for a few months sometime
- 19 in the early '90s.
- 20 Q. What entities other than those listed in
- 21 your resume have you worked for since college, if
- 22 any?
- 23 A. None.
- 24 Q. And as a -- You're still a member of the
- 25 Racquet Club, correct?

- 1 A. Yes.
- Q. Former -- Immediate former past president,
- 3 you still keep up with what's going on at the Racquet
- 4 Club?
- 5 A. I'm not as involved as I was, but I am. But
- 6 I do go to the meeting -- the Board meeting and I
- 7 still am involved.
- 8 Q. What was your -- And your term ended October
- 9 2007; is that correct?
- 10 A. Correct.

- 11 Q. Was that the last day of October?
- 12 A. I believe it was the -- officially it was
- 13 the 2nd Tuesday of October, whatever. I'm not sure
- 14 of the day.
- 15 Q. And HRCBM-H was elected president?
- 16 A. Correct.
- 17 Q. And that was on or about September 26, 2007;
- 18 is that about right?
- 19 A. The Board elects the next president on the
- 20 last Thursday of September.
- 21 Q. Okay.
- 22 A. And he takes official duties on the second
- 23 Tuesday of October.
- 24 Q. Have you ever held any position at any Club
- 25 other than the Houston Racquet Club?

- 1 A. No.
- 2 Q. How would you describe your relationship
- 3 with Mr. Griffin during the time you were president
- 4 of the Racquet Club?
- 5 A. Good.
- 6 Q. And were you social acquaintances as well or
- 7 was it strictly Racquet Club-related?
- A. Racquet Club-related and friendly.
- 9 Q. Well, did you socialize with Mr. Griffin
- 10 during that time?
- 11 A. No. No.
- 12 Q. Go to dinner with Mr. Griffin during that
- 13 time?
- 14 A. No.
- 15 Q. And Mr. Griffin during that time reported
- 16 directly to who, you?
- 17 A. To me and the Board. I guess specifically
- 18 if there's a specific it would be me.
- 19 Q. On a day-to-day basis, who does he report 20 to?
- 21 A. I guess I don't understand that question. I
- 22 guess he would report to me during my term. If
- 23 that's day-to-day, then yes.
- 24 Q. Well, as president of the Houston Racquet
- 25 Club, what was your understanding as to the avenues □00041
 - 1 of reporting that Mr. Griffin had during that time,
 - 2 who he had to report to, who he had to get answers
 - 3 from for certain issues?
 - 4 A. Depending on the issues, he would -- he

- 5 would take care of the day-to-day decisions. If it
- 6 was something larger or long-term, he would come to
- 7 the Board. He would probably either report to the
- 8 specific committee that a large issue would relate to
- 9 and they would make a recommendation to the Board.
- 10 Q. Were you always available to Mr. Griffin
- 11 during the time you were president to address or talk
- 12 to him about any issues that he wanted to speak to
- 13 you about?
- 14 A. I believe so, yes.
- 15 Q. I mean, were you just a phone call away if
- 16 he needed to speak with you?
- 17 A. Yes.
- 18 Q. And who were the department heads during the
- 19 time that you were president of the Racquet Club?
- 20 A. I apologize. I probably won't be able to
- 21 name them all, but I'll try. We had -- David Lamkin
- 22 was in charge of the fitness. TD was the
- 23 director of tennis. Granville Wood is the chef. I
- 24 can't remember the name of the lady that was in
- 25 charge of the banquet business. A gentleman by the $\square 00042$
 - 1 name of Mario was -- has a, I believe, a department
 - 2 head role.
 - 3 Q. What department?
 - 4 A. He would be under the food and beverage area
 - 5 that pertained to service. Guillermo Palmer was head
 - 6 of aquatics, but reported to David. Joyce Healy was
 - 7 with the comptroller.
 - 8 That's all I can remember at this
 - 9 particular time.
 - 10 Q. Is Joyce still at the Houston Racquet Club,
 - 11 to your knowledge?
 - 12 A. Yes.
 - 13 Q. Is Mario?
 - 14 A. Yes.
 - 15 Q. And what is Mario's last name?
 - 16 A. I don't know. I'm sorry.
 - 17 Q. Any other Mario's at the Houston Racquet
 - 18 Club, to your knowledge?
 - 19 A. I would have to imagine there's another
 - 20 employee with a Mario name, but I don't know. I'm 21 sorry.
 - 22 Q. Now, other than the Racquet Club, what other
 - 23 entities have you been on the Board?
 - 24 A. Association of Life and Health

25 Administrators. It's one of my industry

- 1 organizations. I'm currently on the Board of the
- 2 Houston Association of Insurance and Financial
- 3 Advisors. That's all I can think of at this moment.
- Q. Well, you specifically named two. Were
- 5 there others other than the two you mentioned that
- 6 you -- entities that you served as a Board member
- 7 other than the Racquet Club?
- 8 A. I was on a small -- at the University of
- 9 Texas in the Hall of Honor Committee. It's not
- 10 really a Board, it's more of a committee. It's
- 11 sports-related.
- 12 Q. Okay. Any other entity --
- 13 A. No.
- 14 Q. -- where you served as a Board member?
- 15 A. No.
- 16 Q. Have you ever served as an employee or a
- 17 Board member or an officer of any entity that held a
- 18 summer camp other than the Racquet Club?
- 19 A. No.
- 20 Q. Ever been involved in summer camps to any
- 21 degree other than the Houston Racquet Club?
- 22 A. I personally as a child went to one.
- 23 Q. Personally as a what?
- 24 A. As a child, I went to one.
- 25 Q. Which one did you go to?

- 1 A. It was Camp Anderson in Colorado.
- 2 Q. And you were how old?
- 3 A. I believe I was in the eighth grade.
- 4 Q. Okay.
- A. I've attended tennis camps during the
- 6 summertime as a child. And that's all I can think 7 of.
- 8 Q. Did you ever -- Did you ever act as a
- 9 counselor or lifeguard relating to any pool
- 10 activities for any entities at any time?
- 11 A. At West Side I was a tennis instructor at
- 12 our summer camp.
- 13 Q. Tennis instructor?
- 14 A. Yes.
- 15 Q. And did you have any responsibilities
- 16 relating to children and pools?
- 17 A. No.
- 18 Q. Have you ever served as a pool counselor or

- 19 a lifeguard at a pool at any time during your life?
- 20 A. No.
- 21 Q. Is there a -- yeah, a management or
- 22 structure chart like an organizational chart for the
- 23 Houston Racquet Club?
- 24 A. None that I've seen.
- 25 Q. Never?

- 1 A. I don't believe I've ever seen one, no.
- Q. And have you ever been an employee, Board
- 3 member, officer, counselor or lifeguard for any camp
- 4 involving children other than the tennis camp that
- 5 you referenced?
- 6 A. No.
- 7 Q. Whether it's a day camp, summer camp or
- 8 otherwise?
- 9 A. No.
- 10 Q. To your knowledge, is Guillermo Palmer still
- 11 employed by the Houston Racquet Club?
- 12 A. No.
- 13 Q. Why not?
- 14 A. He took an opportunity to go in, I believe,
- 15 sales in another business.
- 16 Q. What kind of business?
- 17 A. Paving.
- 18 Q. And when was his last day, to your
- 19 knowledge?
- 20 A. I don't know. It -- I don't know.
- 21 Q. Well, was it before or after you finished
- 22 your term as president of the Racquet Club?
- 23 A. After.
- 24 Q. How soon after?
- 25 A. Six to -- I'm not sure, several months.

- 1 Q. What's your understanding of why he left the
- 2 Houston Racquet Club to do paving instead of staying
- 3 at the Racquet Club?
- 4 A. I don't -- the only understanding, it was a
- 5 nice -- it was an opportunity provided to him that he
- 6 felt was going to benefit him in the long -- in the
- 7 future.
- 8 Q. By who, to your knowledge?
- 9 A. It was a member of the Racquet Club. I
- 10 don't know his name.
- 11 Q. Is he currently still in that same position
- 12 in sales with that paving company, to your knowledge?

- 13 A. That's my understanding.
- 14 Q. What was Mr. Palmer's compensation agreement
- 15 at the Racquet Club during the time he was there?
- 16 A. I've not seen it. I don't know.
- 17 Q. Do you know what his general salary was as
- 18 of the time he left?
- 19 A. I do not.
- 20 Q. Do you know what his title was during the
- 21 time you were president of the Racquet Club?
- 22 A. I believe it was director of aquatics.
- 23 Q. Do you know what his compensation was as
- 24 aguatics director of the Houston Racquet Club?
- 25 A. I do not.

- 1 Q. And who made that decision as to what his
- 2 salary would be?
- 3 A. Mr. Griffin.
- 4 Q. Was Mr. Palmer given a favorable
- 5 recommendation to his prospective new employer, the
- 6 paving company, to your knowledge?
- 7 A. I don't know if any recommendation was
- 8 asked.
- 9 Q. Have you seen any recommendation letter
- 10 regarding Mr. Palmer?
- 11 A. No.
- 12 Q. Has Mr. Griffin or anyone else told you
- 13 whether or not Mr. Palmer got a recommendation or was
- 14 recommended by the Houston Racquet Club?
- 15 A. No one has mentioned anything to me.
- 16 Q. Did you ask?
- 17 A. I did not.
- 18 Q. You knew prior to the end of your term as

- 22 Q. Did you at any time after John Pluchinsky's

 - A. I know nothing of any type of recommendation
 - 4 request and there was no discussion because there was
 - 5 no discussion of a request.
 - 6 Q. Did you at any time want to make sure as

- 7 president of the Racquet Club that your Club did not
- 8 give a favorable recommendation to the aquatics
- 9 director when a child died under his watch?
- 10 MR. REESE: Objection, form.
- 11 A. I don't understand that question. I'm
- 12 sorry.
- 13 Q. (BY MR. MARRS) Was it any concern of yours
- 14 after John Pluchinsky's death that the Racquet Club
- 15 review whether or not it should give a favorable
- 16 recommendation to the aquatics director, who held
- 17 that position during the time John Pluchinsky died?
- 18 A. I don't believe there was a recommendation 19 asked.
- 20 Q. Okay. Well, I'm not asking if one was or
- 21 not. What I'm asking you is: Did you consider after
- 22 John Pluchinsky's death the issue of whether or not
- 23 if a recommendation was asked for, the Racquet Club
- 24 should or should not make a favorable recommendation
- 25 to a prospective employee of Mr. Palmer one way or □00049
 - 1 the other? Did you look at that issue?
 - A. I didn't look at that issue.
 - Q. Did you as president think that it was
 - 4 important to look at that important issue after John
 - 5 Pluchinsky's death?
 - 6 MR. REESE: Objection, form.
 - 7 Q. (BY MR. MARRS) For Mr. Palmer or for
 - 8 Mr. Lamkin or for Mr. Griffin?
 - 9 MR. REESE: Same objection.
 - 10 A. I did not -- I did not -- I did not think
 - 11 about any recommendations one way or the other at any
 - 12 time -- at --
 - 13 Q. (BY MR. MARRS) Okay. And how about
 - 14 evaluating the performance of Mr. Palmer, what did
 - 15 the Racquet Club do to evaluate Mr. Palmer's
 - 16 performance after John Pluchinsky's death, if
 - 17 anything, to your knowledge?
 - 18 A. There was no evaluation taken from me. I
 - 19 don't know if there was an evaluation taken from the
 - 20 general manager or who Guillermo reported to. I
 - 21 don't know.
 - 22 Q. Okay. Well, as we sit here today then you
 - 23 just don't know what was done, if anything, to
 - 24 evaluate Guillermo Palmer's performance as aquatics
- 25 director after John Pluchinsky's death, correct?

- 1 A. Correct.
- 2 Q. And certainly, you did not ask anyone to
- 3 make any such evaluation, correct?
- A. Correct.
- Q. And would the same responses hold true from
- 6 you with respect to Mr. Griffin?
- A. The same responses, I don't know. I can't
- 8 speak for Mr. Griffin.
- 9 Q. Let me ask you then: With respect to
- 10 Mr. Griffin, did you undertake any kind of review of
- 11 Mr. Griffin's performance as general manager after
- 12 John Pluchinsky's death?
- 13 A. Yes.
- 14 Q. Okay. What did you do?
- 15 A. We met. We have an annual review and we met
- 16 concerning Mr. Griffin on his anniversary date,
- 17 some -- which is sometime in September, met with the
- 18 vice president HRCBM-H and I believe
- 19 HRCBM-U.
- 20 Q. And what did that evaluation consist of?
- 21 A. It consisted of performance throughout the
- 22 year, response to membership, general feeling on
- 23 membership experience throughout the year. Meeting
- 24 budgets were some of the areas that we consider.
- 25 Q. And this annual review, was this basically a $\square 00051$
 - 1 meeting?
 - 2 A. It was a meeting.
 - 3 Q. Among who?
 - 4 A. The small group and then --
 - 5 Q. Being who?
 - 6 A. HRCBM-H.
 - 7 Q. Okay.
 - 8 A. Myself and I believe it was HRCBM-U, but
 - 9 I'm not 100 percent certain.
 - 10 Q. Occurring where?
 - 11 A. At the Houston Racquet Club.
 - 12 Q. Okay. For how long?
 - 13 A. It's taken -- I don't know.
 - 14 Q. Approximately?
 - 15 A. I mean, it could be an hour; it could be two
 - 16 hours. I'm sorry. I don't know.
 - 17 Q. You think about one to two hours?
 - 18 A. It's taken to the Board for discussion.
 - 19 That's it.
 - 20 Q. When you say "taken to the Board," would

- 21 that be a general Board meeting, regular Board
- 22 meeting or special?
- 23 A. It was held during our regular Board meeting
- 24 time; however separately from Mr. Griffin and any
- 25 other employees were not a part of that particular □00052
 - 1 session.
 - Q. And was that the session where the new
 - 3 president was elected?
 - 4 A. Yeah -- I can't remember. I don't know if
 - 5 it was the August 1 or it was -- or the one that the
 - 6 new president was elected. I can't remember which 7 one.
 - 8 Q. Well, if Mr. Griffin's anniversary date, did
 - 9 you say it was in September?
 - A. Correct. Correct.
 - 11 Q. Does that jog your memory?
 - 12 A. Well, it could have. The year before it --
 - 13 we didn't make that decision until October, November.
 - 14 Q. Okay.
 - 15 A. So...
 - 16 Q. All right. So basically you had this, as
 - 17 you call it, a small meeting?
 - 18 A. Uh-huh.
 - 19 Q. With yourself, Mr. HRCBM-H and Mr. HRCBM-U,
 - 20 perhaps, for one to two hours. And then would it be
 - 21 the same day that it would be presented to the Board
 - 22 or not?
 - 23 A. No.
 - 24 Q. Okay. But you know that it was taken to the
- 25 Board then. And what decision was to be made by the $\square 00053$
 - 1 Board relating to your evaluation of the general
 - 2 manager?
 - 3 A. Well, they were all -- each member was to
 - 4 also evaluate by the same criteria that the small
 - 5 group used.
 - 6 Q. Each Board member?
 - 7 A. Yes.
 - 8 Q. Was to evaluate after having received what,
 - 9 recommendations --
 - 10 A. No.
 - 11 Q. -- by your group or --
 - 12 A. No. No. On their own.
 - 13 Q. Verbally as in a discussion setting during
 - 14 the Board or how?

- 15 A. It was a discussion setting.
- 16 Q. Okay. And then to decide what, as it
- 17 related to the general manager?
- 18 A. Performance and compensation for the
- 19 following year, performance of the previous year,
- 20 compensation for the future.
- 21 Q. And when you say performance, would that
- 22 relate to a bonus or not?
- 23 A. Yes, it could.
- 24 Q. Okay. Did Mr. Griffin receive a bonus in
- 25 September or October of 2007 for his performance $\square 00054$
 - 1 during the 2006/2007 term as general manager?
 - A. He received a bonus at that -- in that
 - 3 particular time frame for perform -- meeting
 - 4 performance issues and equaling what he made the 5 previous year.
 - 6 Q. Equaling the bonus he made or equaling the 7 salary he made?
 - 8 A. The total compensation he made the previous 9 year.
 - 10 Q. And what was the amount of his bonus?
 - 11 A. I don't know the exact amount. It may have
 - 12 been in the **Priv** number.
 - 13 Q. Okay. So after the performance evaluation
 - 14 that you and the Board conducted, Mr. Griffin
 - 15 received a bonus for the 2006/2007 term, correct?
 - 16 A. For the 2006/ Priv -- he received, he
 - 17 did. He received a salary, plus he received his
 - 18 bonus to equal, yes.
 - 19 Q. Okay. And am I wrong in describing it
 - 20 2006/2007?
 - 21 A. No. I get confused. I'm sorry.
 - 22 Q. Well, I do, too. That's fine.
 - 23 A. I'm simple-minded. I'm sorry.
 - 24 Q. Okay. But we know that in -- was it
 - 25 September or October, do you recall?

- 1 A. I really don't recall. I'm sorry.
- 2 Q. Okay. So we know that after you and the
- 3 Board reviewed Mr. Griffin's performance, that after
- 4 John Pluchinsky's death, but sometime around
- 5 September, October of 2007 he nonetheless received a
- 6 bonus of some -- something in the range of **Priv**
- 7 correct?
- 8 A. Correct.

- 9 Q. And how would you describe his performance
- 10 for that time frame, since I don't have the document,
- 11 poor, fair, good, very good or excellent?
- 12 A. Good.
- 13 Q. Did he receive a raise as well?
- 14 A. I don't remember. I know a CPI type of
- 15 raise was discussed, but I don't remember if it was
- 16 given. I'm sorry.
- 17 Q. You've got to understand, I'm just a
- 18 lawyer. And CPI, what's that mean?
- 19 A. I guess it's a standard by which it tries to
- 20 meet inflation. I don't know what the exact --
- 21 Consumer Price Index. It could mean that, it could
- 22 mean something else. I'm not 100 percent certain 23 either.
- 24 Q. Okay. And what was the -- what was the
- 25 amount of the raise he received?

- 1 A. I'm not certain he got it. It was
- 2 discussed.
- 3 Q. Excuse me?
- 4 A. I don't know if he actually got it. I can't
- 5 remember. I know it was discussed. He may have.
- Q. Did you recommend that he get a raise?
- 7 A. I recommended that -- I would have
- 8 recommended -- I did recommend that he would have
- 9 received a raise to meet that type of index formula.
- 10 Q. Did you recommend that he get a bonus?
- 11 A. I did.
- 12 Q. Did anyone, whether it be someone in your
- 13 small group or the Board, recommend that Mr. Griffin
- 14 not get a bonus, to your knowledge?
- 15 A. To my knowledge, no.
- 16 Q. Anyone recommend that he not get a raise, to
- 17 your knowledge?
- 18 A. There was discussion, but no.
- 19 MR. REESE: Are you at a good breaking
- 20 point?
- 21 MR. MARRS: In about five minutes.
- 22 Almost there.
- 23 Q. (BY MR. MARRS) And was that small meeting
- 24 between yourself, Mr. HRCBM-H and Mr. HRCBM-U, did
- 25 the discussion of John Pluchinsky's death come up?

- 1 A. Yes. I believe it did.
- 2 Q. How so?

- 3 A. It was a -- in a discussion did -- how we
- 4 felt -- how did we feel that he handled the
- 5 situation.
- 6 Q. And what was the substance of the discussion
- 7 about how he handled the situation?
- 8 A. We felt that he acted appropriately,
- 9 quickly, and the best that anybody could.
- 10 Q. Any criticisms whatsoever with respect to
- 11 Mr. Griffin's performance or actions as they related
- 12 to John Pluchinsky's death?
- 13 A. Not to my knowledge.
- 14 Q. Any discussion with respect to whether or
- 15 not Mr. Griffin adequately managed those underneath
- 16 him, such as Mr. Lamkin or how he addressed any
- 17 lifeguard issues relating to the pools during your
- 18 discussion with Mr. HRCBM-U and Mr. HRCBM-H?
- 19 A. Not specifically.
- 20 Q. How about nonspecifically?
- 21 A. He generally had the -- he generally met
- 22 with his staff regularly. He addressed things
- 23 quickly and that's essentially how it was.
- 24 Q. So, then I take it there were no criticisms
- 25 whatsoever with respect to Mr. Griffin and his □00058
- 1 performance as they relate to safety issues at the
- 2 pool or as they relate to John Pluchinsky's death,
- 3 correct?
- 4 A. I can't remember any such.
- 5 Q. And how about at the Board meeting when you
- 6 took recommendations and evaluation to the Board,
- 7 during that Board meeting, was there any discussion
- 8 of John Pluchinsky's death?
- 9 A. No.
- 10 Q. Any mention of whether or not Mr. Griffin
- 11 performed adequately with respect to issues relating
- 12 to John Pluchinsky's death?
- 13 A. I honestly can't remember the specifics to
- 14 the discussions. I'm sorry.
- 15 Q. Not that you can recall?
- 16 A. Not that I can recall.
- 17 MR. MARRS: Wade, this is fine.
- 18 MR. REESE: All right.
- 19 MR. MARRS: If you want to take a
- 20 break.
- 21 MR. REESE: Good enough.
- 22 VIDEOGRAPHER: We are going off the

- 23 record. The time is 11:32 a.m. 24 (Brief recess.) 25 VIDEOGRAPHER: Going on the record. □00059 1 The time is 11:53 a.m. Q. (BY MR. MARRS) With respect to the small 3 meeting that you had with Mr. HRCBM-H and Mr. HRCBM-U 4 with respect to the evaluation of Mr. Griffin, what 5 documents were there that related to that meeting or 6 that evaluation of Mr. Griffin? 7 I don't believe there were anv. 8 Q. Are you sure about that? A. Not 100 percent sure, but none that I can 10 remember. 11 Q. So as president of the Racquet Club, you 12 didn't ensure that there was some kind of 13 documentation in Mr. Griffin's employee file that 14 backed up or documented somehow the recommendations, 15 evaluation, raises or bonus that were to be given 16 Mr. Griffin? 17 A. I can't remember. I believe it was just a 18 verbal meeting. Q. Well, certainly there's some document that 20 was given to accounting to cut a check for 21 Mr. Griffin relating to his bonus, wasn't there? 22 A. I don't believe so, no. 23 Q. So everything was handled verbally? No 24 documentation whatsoever relating to the evaluation 25 of Mr. Griffin or your meeting with Mr. HRCBM-H and □00060 1 Mr. HRCBM-U regarding the evaluation of Mr. Griffin? A. I don't believe so, no. In the year before 3 there was a document that was given out to the Board 4 members to just go -- as a tool of understanding that 5 was created the year before, but I'm not -- I don't 6 believe we used that this time around. 7 Q. And that's what I was going to ask you. I 8 mean, what forms existed at the Racquet Club for 9 evaluation of individuals, like Mr. Griffin so it 10 could be in writing?
 - 11 A. There was nothing given in writing to the
 - 12 comptroller or anything to provide for that
 - 13 documentation that you're asking for, I believe.
 - 14 Q. Any standard evaluation forms that the
 - 15 Racquet Club uses to evaluate its employees to your
 - 16 knowledge at any time while you were president?

- 17 A. We -- I don't know if we used -- we -- I
- 18 don't think we used -- we may -- I'm not sure. We
- 19 don't -- we may have used the form that was created
- 20 the year before to give people an idea of categories
- 21 and thoughts to their -- to the recommendation or to
- 22 their decision, but there's no standard form.
- 23 Q. Did you or Mr. HRCBM-H or Mr. HRCBM-U use
- 24 any such document relating to the evaluation of
- 25 Mr. Griffin, to your knowledge?

- 1 A. I don't remember any such, but I would have
- 2 to ask Mr. HRCBM-H to see if we did.
- 3 MR. MARRS: We'll send you a written
- 4 request, Wade, for those docs to see if they exist.
- 5 MR. REESE: Okay.
- 6 Q. (BY MR. MARRS) Any e-mails or
- 7 correspondence or other communications between
- 8 yourself, Mr. HRCBM-H or Mr. HRCBM-U or anyone else
- 9 relating to the evaluation of Mr. Griffin?
- 10 A. None to my knowledge.
- 11 Q. And when you showed up or were at the
- 12 meeting with these two gentlemen regarding the
- 13 evaluation of Mr. Griffin, did anyone take notes, to
- 14 your knowledge?
- 15 A. Not to my knowledge.
- 16 Q. And with respect to the subsequent Board
- 17 meeting relating to the evaluation of Mr. Griffin,
- 18 were there any -- and the Board members' own
- 19 evaluation as you say of Mr. Griffin, were there any
- 20 documents relating to that, to your knowledge?
- 21 A. As it pertains -- specific like forms,
- 22 standardized forms that you're talking about?
- 23 Q. No, sir.
- 24 A. Okay. I'm sorry.
- 25 Q. I'm talking about any documents.

- 1 A. Okay. None to my knowledge. I'm not sure
- 2 if any were given from the previous years. I'd have
- 3 to -- I would have to look into that.
- 4 Q. Where would you look?
- A. I would look -- I would ask Mr. HRCBM-H . I
- 6 would look to see if I have any in my computer at
- 7 work. Those are the two places I would go first.
- 8 Q. Have you looked?
- 9 A. No.
- 10 Q. Will you look --

- 11 A. I will look.
- 12 Q. -- in all places where such documents may
- 13 reside and inform your counsel and provide such
- 14 documents, if any, to Norman Snyder so that he can
- 15 provide those to us?
- 16 A. Yes.
- 17 Q. Are there any guidelines at the Houston
- 18 Racquet Club with respect to how evaluations are to
- 19 be performed of employees or officers?
- 20 A. No.
- 21 Q. And who evaluates you as president of the
- 22 Racquet Club?
- 23 A. There is no evaluation, to my knowledge.
- 24 Q. Did you receive any compensation as
- 25 president or relating to your role as president of □00063
 - 1 the Houston Racquet Club?
 - 2 A. No.
 - 3 Q. Do you receive any perks as president of the
 - 4 Houston Racquet Club?
 - 5 A. No.
 - 6 Q. What was the advantage of being president of
 - 7 the Houston Racquet Club other than the status?
 - 8 A. Opportunity to give back.
 - 9 Q. Anything else?
 - 10 A. No.
 - 11 Q. Why was the evaluation of Mr. Griffin --
 - 12 strike that.
 - How long did the discussion occur in
 - 14 the subsequent Board meeting relating to the
 - 15 evaluation of Mr. Griffin, issues relating to raise,
 - 16 issues relating to bonus and performance of
 - 17 Mr. Griffin?
 - 18 A. I have no rememberance of that. It could be
 - 19 15 minutes. It could be 30 minutes. I have no
 - 20 knowledge. I don't remember.
 - 21 Q. Why is there no mention of that in that
 - 22 particular Board minute relating to that particular
 - 23 Board meeting of any evaluation of Mr. Griffin?
 - 24 A. Because that's done outside the proper Board
- 25 meeting. It's done within just the Board outside of $\square 00064$
 - 1 any employees or...
 - Q. Explain that.
 - A. In that particular circumstance, they can
 - 4 call what's -- it's called Executive Committee, which

- 5 is just the Board members only. All staff or anybody
- 6 with the staff have to -- they leave. And then a
- 7 discussion to -- pertaining to the general manager
- 8 would be discussed outside of him being there.
- 9 Q. And what kind of meeting would that be
- 10 called? Would it be called Executive Committee
- 11 Meeting?
- 12 A. Yes, yes.
- 13 Q. Would that be before, during or after a
- 14 regular Board meeting?
- 15 A. Anytime that the president chooses.
- 16 Q. And when did you choose to have this
- 17 Executive Committee Meeting relating to the
- 18 evaluation of Stephen Griffin?
- 19 A. I believe it was after one of the Board
- 20 meetings, either in August or September.
- 21 Q. Were there minutes of the executive
- 22 committee meeting relating to the evaluation of
- 23 Mr. Griffin?
- 24 A. No.
- 25 Q. Why not?

- 1 A. There are not minutes. There's no one there
- 2 to keep minutes.
- 3 Q. As a rule?
- 4 A. I don't know if that's a rule or not.
- 5 Q. Were minutes ever kept of Executive
- 6 Committee Meetings, to your knowledge, at the Racquet 7 Club?
- 8 A. I can't speak prior to me, but I don't
- 9 know. They may have. They may not. I'm not sure.
- 10 Q. And how does the Executive Committee Meeting
- 11 differ from a special Board meeting?
- 12 A. That nobody from the staff of the Club
- 13 attends.
- 14 Q. Was any Executive Committee Meeting called
- 15 by you as president of the Racquet Club relating to
- 16 the death of John Pluchinsky?
- 17 A. We had a meeting a week or so after the
- 18 accident.
- 19 Q. An Executive Committee Meeting?
- 20 A. Yes.
- 21 Q. And who attended?
- 22 A. I would -- I'm not sure. Most of the Board
- 23 did. I'm not sure. Made -- counsel, and that's all
- 24 I can remember.

25 Q. And this would have been in July of 2007? □00066 1 I believe that's correct. Q. Were minutes kept of that meeting? 2 3 A. No. Q. How long did it last? 4 A. I'm not sure, an hour. It could be an 6 hour-and-a half. Q. Were any decisions made at that meeting? 8 A. No. 9 Q. And what was it called about? 10 MR. REESE: That's enough there. You 11 had counsel present. You had the privilege. You 12 don't have to answer that question. MR. MARRS: You're asserting the 13 14 attorney/client privilege? 15 MR. REESE: That's exactly what we're 16 doing. Q. (BY MR. MARRS) You're refusing to answer on 18 the basis of the -- your lawyer's advice? 19 A. Yes. 20 Q. Are there any documents that depict or state 21 or describe any decisions made or discussions had 22 during that meeting? 23 A. None that I'm aware of. 24 Q. How -- Who called that meeting? 25 MR. REESE: You don't have to answer □00067 1 that. MR. MARRS: He doesn't have to answer 3 who called the meeting? MR. REESE: No. I've allowed you 5 pretty good leeway as far as the privilege and he's 6 not going to answer anything more about decisions. 7 MR. MARRS: Okay. 8 MR. REESE: Who called it. Those are 9 all going to be privileged. 10 MR. MARRS: On the basis of 11 attorney/client privilege? MR. REESE: Absolutely. 12 13 Q. (BY MR. MARRS) And you're refusing to 14 answer on the basis of your client's -- or your 15 counsel's advice; is that correct? 16 A. Yes. sir. 17 Q. Any other meetings, executive committee 18 meetings or special committee meetings relating to

- 19 the death of John Pluchinsky?
- 20 A. We had a small committee meeting the day
- 21 following to hire professionals to investigate and
- 22 in -- with any potential litigation.
- 23 Q. And who was present at that meeting?
- 24 A. HRCBM-B, HRCBM-H, HRCBM-X by
- 25 phone, HRCBM-Z, Steve Griffin, HRCBM-W, □00068
 - 1 HRCBM-G.
 - 2 Q. HRCBM-G who?
 - 3 A. HRCBM-G.
 - 4 Q. Is he with the Club?
 - 5 A. He is the insurance person for the Club.
 - Q. And you say "small committee meeting," what
 - 7 committee was that or was it a committee meeting?
 - A. Officers, essentially.
 - 9 Q. Was that an Executive Committee or a Special
 - 10 Committee Meeting or just a specially called meeting
 - 11 or what?
 - 12 A. I don't know. I don't have a name for it.
 - 13 Q. Okay. Who called that meeting?
 - 14 A. I may have. I -- that was Thursday
 - 15 evening. I may have called it.
 - 16 Q. Was a professional hired to investigate it?
 - 17 A. Yes.
 - 18 Q. Who?
 - 19 A. Mike Wall with Gardere Wynne.
 - 20 Q. Who else?
 - 21 A. That's it.
 - 22 Q. When did the investigation begin?
 - 23 MR. REESE: You don't have to answer
 - 24 that. That's privileged. Mike Wall was present at
 - 25 that meeting. Anything else about that would be
- □00069
 - 1 privileged as well.
 - Q. (BY MR. MARRS) Do you refuse to answer on
 - 3 the basis of your counsel's advice?
 - 4 A. Yes, sir.
 - Q. Any meetings regarding John Pluchinsky's
 - 6 death or issues surrounding it other than those
 - 7 you've described or those that you've had with
 - 8 counsel?
 - 9 A. No.
 - 10 Q. Did you call any meetings as president of
 - 11 the Houston Racquet Club to discuss how to help the
 - 12 Pluchinsky family during their time of need?

- 13 A. No specific meeting.
- 14 Q. Any nonspecific meeting where that was
- 15 discussed?
- 16 A. I've discussed it with individuals.
- 17 Q. How about in Board meetings?
- 18 A. I led the first Board meeting with a silent
- 19 prayer to help them spiritually. I don't believe any
- 20 other conversation at Board meetings or any topics
- 21 were raised on specific issues towards that. We did
- 22 make a decision at a Board meeting, I believe, to
- 23 donate to Bo's Place. We statused the Board on
- 24 things that we've done, and that's about all I can
- 25 remember.

- 1 Q. Things that you had done such as what?
 - MR. REESE: To the extent that it
- 3 includes anything done with counsel, that would be 4 privileged.
- 5 A. We talked about the Friends and Family book,
- 6 that we were going to have that out. We talked about
- 7 my attempts to make contact through permission of
- 8 others, through my one call to Mr. Pluchinsky,
- 9 through -- to let them know that the Club did deliver
- 10 flowers, a card, recommending they go to the funeral
- 11 if they chose to. That's all I can remember at this
- 12 particular moment.
- 13 Q. (BY MR. MARRS) And other than your one call
- 14 to Mr. Pluchinsky, have you subsequently attempted to
- 15 contact Mr. Pluchinsky or Mrs. Pluchinsky?
- 16 A. No. I have been advised not to.
- 17 Q. And other than the Friends and Family book,
- 18 donation -- How much was the donation to Bo's?
- 19 A. From the Club it was \$1,000. From
- 20 individuals, I don't know what they did.
- 21 Q. So other than the book and the donation and
- 22 the one phone call to Mr. Pluchinsky, what else did
- 23 you or the Club do to reach out to the Pluchinsky
- 24 family as a result of the death of their son in your
- 25 pool, if anything?

- 1 A. I called, a conversation with Mr. Maynard, I
- 2 asked for permission to make contact to a mutual
- 3 friend of Ms. Pluchinsky's, I asked for permission.
- 4 We flew the flag at half mast for a week. That's all
- 5 I can think of.
- 6 Q. And who was responsible for sending flowers

- 7 or cards to the Pluchinskys?
- 8 A. Steve Griffin and myself.
- 9 Q. Was that done?
- 10 A. Yes. It was sent to the church.
- 11 Q. Let me back up. Did you or are you
- 12 currently serving in any capacity other than member
- 13 of the Houston Racquet Club?
- 14 A. I am the past president. I believe I'm the
- 15 assistant secretary. I have no voting right, but I'm
- 16 on the Board.
- 17 Q. You're on the Board?
- 18 A. I'm on the Board as the past president and
- 19 assistant secretary and -- but I don't have voting
- 20 rights on Board issues.
- 21 Q. And why were you made assistant secretary?
- 22 Was it so that you could keep your privileges at the
- 23 Houston Racquet Club?
- 24 A. Yes.
- 25 Q. And what privileges are those?
- □00072
 - 1 A. None other than I was -- I am -- I was the
 - 2 president during the time of this accident and will
 - 3 remain involved until the conclusion of this process.
 - 4 Q. And because the Club wanted you to remain
 - 5 involved, they did what?
 - A. I don't understand what -- I'm sorry.
 - 7 Q. I'm trying to understand what you just
 - 8 said. That's why I asked.
 - 9 A. Right. To remain on a -- I guess in a
 - 10 privileged capacity to this process.
 - 11 Q. And when you say "privileged capacity," do
 - 12 you mean like the attorney/client privilege or do you
 - 13 mean some other type of privilege?
 - 14 A. Attorney/client privilege.
 - 15 Q. Okay. So it's your understanding that you
 - 16 remain or were made assistant secretary so that you,
 - 17 your discussions and communications with those within
 - 18 the Club or their lawyers would remain privileged?
 - 19 A. Yes.
 - 20 (Plaintiff's Exhibit Number 68 marked.)
 - 21 Q. (BY MR. MARRS) And if we look at Exhibit 68
 - 22 from September 2007 Board meeting minute where it
 - 23 says that, "It was agreed on by the Board that Ted
 - 24 Erck would be the Assistant Secretary so he can keep
- 25 his privileges," are those -- his privilege that is □00073

- 1 being referred to attorney/client privilege?
- 2 A. I assume so, yes.
- 3 Q. And does the Houston Racquet Club have a 4 wading pool?
- 5 A. I've never heard it called as such. We have 6 a beach area.
- 7 Q. Right. Do you have a wading pool? Does the
- 8 Racquet Club currently have a wading pool?
- 9 A. Again, I've never heard anything called as
- 10 such. We have a beach area.
- 11 Q. Okay. Did the Racquet Club have a wading
- 12 pool prior to the family pool being constructed?
- 13 A. There was a separate pool, a small round
- 14 pool to the southwest of the initial pool.
- 15 Q. And is that what you would consider a wading
- 16 pool, a separate pool for wading?
- 17 A. I guess it could be defined as anything, but
- 18 something like that.
- 19 Q. Okay.
- 20 A. It could be defined as that, I assume.
- 21 Q. Sure. And that's why when I asked you if
- 22 the Racquet Club currently has a wading pool, you
- 23 said, well, they have a beach entry because, you
- 24 know, the wading pool to you means a separate pool
- 25 for wading; is that right?

- 1 A. It can mean that. It can mean a shallower
- 2 part of a pool. It can mean, I think, either of 3 those.
- 4 Q. Okay. Well, based on your understanding, a
- 5 guy who's been a president of a club, does the
- 6 Houston Racquet Club currently have a wading pool?
- 7 A. You could consider the beach area a wading 8 area, but not a separate pool.
- 9 Q. Okay. You would not consider that a wading
- 10 pool; is that correct?
- 11 A. I would not consider it a wading pool if you
- 12 defined it as a separate entity that's shallow to
- 13 wade in.
- 14 Q. Okay. But you yourself would not define the
- 15 beach area of the family pool as a wading pool, would 16 vou?
- 17 A. Not based on those definitions, correct.
- 18 Q. Isn't that the definition you use?
- 19 A. Okay. If a pool -- if a wading pool is
- 20 separate and is shallow enough to walk in, then

- 21 that's -- if that's my definition, then yes, I agree.
- 22 Q. Is that your definition, as we just sit here
- 23 today and you hear the term wading pool?
- 24 A. I --
- 25 Q. Would you consider it a separate pool? □00075
 - 1 A. Okay. Yeah.
 - 2 Q. Would you?
 - 3 A. I might, yes.
 - 4 Q. Okay. And does the Racquet Club, are they
 - 5 going to have summer camp this year?
 - A. Not as it -- not as it existed last year.
 - 7 Q. And how will it exist this year for summer 8 2008?
 - 9 A. We have several two-hour programs that --
 - 10 and I'm not as familiar with all the different
 - 11 programs and I'm sorry. They can be anything from
 - 12 building a rocket ship to painting, to cheerleading,
 - 13 activities such as those.
 - 14 Q. And is the Racquet Club calling it summer
 - 15 camp or something else?
 - 16 A. I'm not sure how we've defined it. Someone
 - 17 might define it as camp. Someone might define it as
 - 18 activities. It can be -- I'm not sure how the Club
 - 19 has actually marketed it to promote it --
 - 20 Q. Okay.
 - 21 A. -- and define it.
 - 22 Q. Is it promoted to only members or
 - 23 non-members also?
 - 24 A. It's promoted -- it's my understanding that
- 25 mainly to members. I'm not sure if a non-member can $\square 00076$
 - 1 come in under the premise of a member. I would have
 - 2 to confirm that.
 - Q. As we sit here today, you don't know whether
 - 4 or not non-members can partake in the summer
 - 5 activities for summer 2008?
 - 6 A. We also have -- I don't know. I can't
 - 7 confirm that 100 percent.
 - Q. And who within the Racquet Club, to your
 - 9 knowledge, made the decision to move forward and at
 - 10 least have summer activities for summer 2008 at the
 - 11 Racquet Club?
 - 12 A. HRCBM-H would have approved it with
 - 13 Steve Griffin.
 - 14 Q. And the Board as well?

- 15 A. Uh-huh.
- 16 Q. And is swimming for children part of the
- 17 summer activities for summer 2008 at the Racquet
- 18 Club?
- 19 A. Not to my knowledge.
- 20 Q. Do you specifically know they aren't or you
- 21 don't know?
- 22 A. I'm pretty sure that they are not. I would
- 23 have to review the list, but I'm pretty -- I'm very
- 24 sure -- I'm pretty sure they are not.
- 25 Q. Based on what?

- 1 A. Based on the fact that we've changed the
- 2 camp to not include that. We've outsourced it.
- 3 Q. To who?
- 4 A. I believe her name is Kyle Robertson and --
- 5 Q. With who?
- 6 A. I believe she has her own company. I'm not
- 7 sure of the name. If there's a specific name to it,
- 8 I'm not certain.
- 9 Q. And what is she, to your knowledge? Is she 10 a --
- 11 A. She's a teacher, I believe in Austin, and
- 12 has done these types of little camps and activities
- 13 for people in Austin. And through some relationships
- 14 that she has with -- for children and for families at
- 15 the Racquet Club.
- 16 Q. And have you been present during any
- 17 discussions relating to whether or not swimming
- 18 should be a part of summer activities for 2008 at the
- 19 Racquet Club?
- 20 MR. REESE: And that excludes any
- 21 discussions that would include counsel.
- 22 A. All right. Yes.
- 23 Q. (BY MR. MARRS) What discussions?
- 24 A. We discussed whether we were going to do
- 25 camp or not.

- 1 Q. Who is "we"?
- A. I believe it was HRCBM-H,
- 3 HRCBM-a1, Steve Griffin and myself and --
- 4 Q. And tell us what the substance of those
- 5 communications were after you tell me whether there
- 6 was anyone else present.
- 7 A. I don't believe there was anybody else
- 8 present. The issue was brought up at a Board meeting

- 9 whether we -- and I don't know which month, but
- 10 whether he would have camp or not. We would discuss
- 11 it thoroughly or -- and see if it was something that
- 12 their members wanted.
- 13 Q. Well, did you ask members as to whether they
- 14 wanted that or not?
- 15 A. I did not lead that group. I was just part
- 16 of the discussion. I didn't do any work towards
- 17 that, so I don't know exactly how they came up with
- 18 the information that -- to move forward with doing
- 19 these activities.
- 20 Q. Was there a group that would canvass or ask
- 21 questions of members with respect to that?
- 22 A. Not specifically that I know of, no.
- 23 Q. And who is HRCBM-a1?
- 24 A. He's a current Board member.
- 25 Q. And were these discussions had in

- 1 conjunction with any insurance carrier for the
- 2 Racquet Club?
- A. No.
- 4 Q. Did any insurance company or representative
- 5 recommend that you not have water activities as part
- 6 of summer activity 2008?
- 7 A. No, none that I'm aware of.
- 8 Q. You're still having Mad Science, though, for
- 9 summer activities 2008?
- 10 A. I don't know.
- 11 Q. Is the offering of summer activities for
- 12 summer 2008 advertised by the Houston Racquet Club?
- 13 A. I believe it is on the web site.
- 14 Q. Available to the public or the members only
- 15 portion of the web site?
- 16 A. I don't know. I'm sorry.
- 17 Q. How else is it advertised?
- 18 A. I believe a general e-mail went out to the
- 19 membership. Outside of that, I believe that's it.
- 20 Q. Okay. How is enrollment thus far, to your
- 21 knowledge?
- 22 A. I have no knowledge.
- 23 Q. And with respect to Kyle Robertson, why is
- 24 the Racquet Club outsourcing its summer activities
- 25 for this summer?

- 1 A. Because of pending litigation is one reason
- 2 we chose not to do the camp as it existed last year.

- 3 And too, highly recommend by members, that her
- 4 activities would fit well with the membership.
- 5 Q. What members highly recommended outsourcing?
- 6 A. I don't know if it was -- the recommendation
- 7 of outsourcing was an issue. It was more of how can
- 8 we provide activities for our membership. We weren't
- 9 going to do summer camp, so what could we do to
- 10 provide summer activities for our members.
- 11 Q. And was there a Board meeting with respect
- 12 to that issue?
- 13 A. A decision was not made by the Board to move
- 14 forward with that, just by some Board members and the
- 15 president. But that's -- it was -- the president was
- 16 in that committee along with a Board member and
- 17 Steve Griffin and they moved -- we moved forward with
- 18 those activities.
- 19 Q. Were there minutes of those meetings?
- 20 A. No
- 21 Q. Are there generally minutes of the committee
- 22 meetings?
- 23 A. No.
- 24 Q. Do you have an understanding as to whether
- 25 or not Houston Racquet Club plans to have summer camp □00081
 - 1 2009?
 - 2 A. I have no idea.
 - 3 Q. Haven't -- They haven't made a decision one
 - 4 way or the other, to your knowledge?
 - A. I don't think it's even been discussed.
 - 6 Q. And when is the first time that you became
 - 7 aware that Guillermo Palmer was interested in leaving
 - 8 Houston Racquet Club and seeking employment
 - 9 elsewhere?
 - 10 A. I can't remember it exactly, but he had
 - 11 taken the job sometime, I believe, in 2008.
 - 12 Q. When did you become aware of the fact that
 - 13 he was going to be leaving the Racquet Club?
 - 14 A. At the -- sometime early to mid 2008.
 - 15 Q. How did you find out?
 - 16 A. He told me.
 - 17 Q. Under what circumstances did he tell you?
 - 18 A. I believe it was -- I believe I ran into him
 - 19 at the Club. I don't know if there was any
 - 20 particular circumstance that I can remember, but he
 - 21 told me at the Club.
 - 22 Q. What did he tell you?

- 23 A. That he was going to leave the Club. He was
- 24 going to take an opportunity -- he had an opportunity
- 25 to work in sales for a paving company and I

- 1 congratulated him and that was it.
- 2 Q. What fraternities do you belong to?
- 3 A. I was a member of the Silver Spurs at the
- 4 University of Texas.
 - MR. REESE: That's it, Matt.
- 6 MR. MARRS: Uh-huh.
- 7 A. That's it.
 - MR. REESE: We were Spurs together.
- 9 THE WITNESS: Oh. Oh, me? You?
- 10 MR. REESE: Matt asked whether or not
- 11 we had run into each other.
- 12 THE WITNESS: Oh, sorry.
- 13 MR. REESE: We all look the same under
- 14 the white hat.
- 15 THE WITNESS: Well, sorry I didn't
- 16 participate as much as I should have.
- 17 Q. (BY MR. MARRS) So what's your understanding
- 18 of what your responsibilities were as president of
- 19 the Houston Racquet Club?
- 20 A. To generally be in charge of the Club's
- 21 affairs.
- 22 Q. That's it?
- 23 A. Be accessible to the membership, run Board
- 24 meetings -- monthly Board meetings. Run the -- run
- 25 the annual membership meeting in October.

- 1 Q. Were you responsible for fund-raising?
- 2 A. No.
- 3 Q. Who was?
- 4 A. No one was in charge of fund-raising. We
- 5 don't have that vehicle.
- 6 Q. Meaning what? What do you mean you don't
- 7 have --
- 8 A. I'm not sure about fund-raising. The
- 9 Racquet Club doesn't have a fund-raising.
- 10 Q. But there's no prohibition in the bylaws or
- 11 elsewhere for the Houston Racquet Club to raise
- 12 funds, is there?
- 13 A. Not to my knowledge.
- 14 Q. Do you generally raise funds through dues?
- 15 A. We have operating budgets and the -- which
- 16 is -- which is the dues, surplus of that operating

- 17 budget.
- 18 Q. Did you receive any compensation or anything
- 19 of value for being president of the Racquet Club?
- 20 A. No.
- 21 Q. Did Mr. Lamkin receive a raise during his
- 22 annual review after the death of John Pluchinsky?
- 23 A. I don't know.
- 24 Q. Or bonus?
- 25 A. I don't know.

- 1 Q. What about Guillermo Palmer?
- 2 A. I don't know.
- 3 Q. How about 15 y/o LG #1?
- 4 A. I know -- I do know -- I know that she
- 5 received additional money per hour based on the
- 6 deposition that you took with Steve Griffin.
- 7 Q. Okay. So, you know that 15 y/o LG #1, after
- 8 John Pluchinsky's death, did receive an increase in
- 9 her hourly salary, correct, for her hourly rate?
- 10 A. That's information I gathered through the
- 11 other deposition, yes, sir.
- 12 Q. And that she also received an excellent
- 13 review, correct?
- 14 A. That I don't know.
- 15 Q. Do you not remember that part of the
- 16 deposition?
- 17 A. I don't remember that part, no.
- 18 Q. And since John Pluchinsky's death, has the
- 19 responsibilities of Mr. Griffin or Mr. Lamkin changed
- 20 at all, to your knowledge?
- 21 A. Mr. Griffin's, no. Mr. Lamkin does not have
- 22 the summer camp in his world. I don't know how
- 23 Mr. Lamkin's responsibilities are with the
- 24 third-party lifeguard group that's come -- I don't --
- 25 I don't have any knowledge of that, if there is any.

- 1 Q. Repeat that.
- 2 A. I don't have any knowledge if Mr. Lamkin's
- 3 responsibilities flow over to the pool area anymore.
- 4 They may. I don't know.
- 5 Q. You just don't know?
- 6 A. I just don't know.
- 7 MR. REESE: It's 12:30. Do you guys
- 8 want to take an hour for lunch?
- 9 MR. MARRS: Yeah. Although I'm okay
- 10 with doing something less than that. Sure.

- 11 30 minutes, 45 minutes, something like that?
- 12 MR. REESE: Is everybody fine with just
- 13 going downstairs?
- 14 MR. MARRS: Why don't we plan on around
- 15 45, yeah. Okay. Let's do that now.
- 16 VIDEOGRAPHER: It's 12:34. We're off
- 17 the record.
- 18 (Lunch recess was taken.)
- 19 VIDEOGRAPHER: The time is 1:27 p.m.
- 20 We are back on the record.
- 21 Q. (BY MR. MARRS) And, Mr. Erck, you mentioned
- 22 that a call was placed to Bill Maynard; is that
- 23 correct?
- 24 A. He actually called the Club, I believe.
- 25 Q. Okay. When?
- □00086
 - 1 A. I think it was Thursday afternoon.
 - 2 Q. To who?
 - 3 A. To Steve Griffin.
 - 4 Q. And what was discussed, to your knowledge?
 - 5 A. He asked what happened and we told him we
 - 6 did not know. I asked him for permission to go to
 - 7 the family and send our condolences. He said he was
 - 8 going to be -- he was going to go to their house that
 - 9 evening and he would call us and let us know.
 - 10 Q. And did he?
 - 11 A. He was -- I think he had to go pick up his
 - 12 child at camp somewhere on that Friday. He said he
 - 13 would call. I don't believe -- he didn't call while
 - 14 I was around.
 - 15 Q. Okay. And then what other subsequent
 - 16 conversations occurred with Mr. Maynard with anybody
 - 17 from the Club, to your knowledge?
 - 18 A. None, to my knowledge.
 - 19 Q. Okay. I thought you mentioned previously
 - 20 today that someone called Bill Maynard to get
 - 21 permission to contact a friend of the Pluchinskys?
 - 22 A. No. I made a call to a friend of
 - 23 Ms. Pluchinsky to get -- to also seek permission.
 - 24 Q. Okay. And who was that?
 - 25 A. Cherie Hoepfl.
- □00087
 - 1 Q. Hoepfl?
 - 2 A. Yes.
 - 3 Q. And when was that that you made that call?
 - 4 A. I believe it was Thursday evening, but it

- 5 could have been Friday.
- 6 Q. And why?
- 7 A. To seek permission to meet with the
- 8 Pluchinskys.
- 9 Q. And why -- How did you know that she was a
- 10 friend of the Pluchinsky's?
- 11 A. I believe she was a sponsor of the
- 12 Pluchinskys for membership at the Racquet Club.
- 13 Q. And the time when you called and talked to
- 14 Mr. Pluchinsky briefly, was that before the funeral
- 15 of John Pluchinsky?
- 16 A. I believe it was, yes.
- 17 Q. Did you ever reach out to try to contact the
- 18 Pluchinskys yourself after the funeral?
- 19 A. I did not.
- 20 Q. Did Mr. Griffin, to your knowledge?
- 21 A. Not to my knowledge.
- 22 Q. Did Mr. Lamkin, to your knowledge?
- 23 A. Not to my knowledge
- 24 (Plaintiff's Exhibit Number 1 referenced.)
- 25 Q. (BY MR. MARRS) Let me show you what's been □00088
 - 1 marked as Plaintiff's Exhibit Number 1, which I
 - 2 believe you've seen before, the July 20th, 2007
 - 3 message to members that is from yourself, correct,
 - 4 sir?
 - 5 A. It looks accurate, yes.
 - Q. Now, did you write this yourself or did
 - 7 someone write it for you?
 - 8 A. I wrote it and it was looked over by
 - 9 counsel, professional counsel.
 - 10 Q. You mean legal counsel?
 - 11 A. Legal counsel.
 - 12 Q. And did anyone assist you in drafting it or
 - 13 finishing it or revising it?
 - 14 A. I wrote it. It was edited by legal counsel,
 - 15 approved and sent.
 - 16 Q. And when you say "sent," was it posted on
 - 17 your web site?
 - 18 A. I don't know if it was posted on the web
 - 19 site or not. I believe we sent an e-mail out to -- a
 - 20 blast e-mail out to the membership.
 - 21 Q. Who's responsible for placing things on the
 - 22 Houston Racquet Club web site?
 - 23 A. It's my understanding that Jean Northey does
 - 24 much that as the assistant to Steve Griffin.

25 Q. Jean Northey? □00089 1 A. Yes. Q. And male or female? Male? 2 3 A. Female. Q. Female. And she's an assistant of 5 Mr. Griffin? 6 A. Yes. Q. Okay. Anybody else responsible for placing 8 things on the Houston Racquet Club web site, to your 9 knowledge? 10 A. I don't know exactly how that process works, 11 but to my knowledge, she does much of that. 12 Q. And before, let's say, fliers about summer 13 camp or a section of your web site about summer camp 14 is actually posted for the public or members to see, 15 is it run through a committee or the Board for 16 approval? 17 A. Not typically. 18 Q. Well, someone in management at the Racquet 19 Club would approve content that goes on your web site 20 before it goes on, wouldn't they? 21 A. I would believe so. 22 Q. Who do you believe that would be? 23 A. Ultimately, I would believe that would be 24 the general manager. 25 Q. Mr. Griffin? □00090 A. Yes. 1 Q. And do you know for a fact whether or not 3 Mr. Griffin approved subject matter regarding the 4 pools and summer camps before placed on the Racquet 5 Club web site? A. I don't know if that process actually took 7 place or not. Q. You would expect it to? 8 9 A. I would expect it to. 10 Q. Was that part of Mr. Griffin's job 11 responsibilities? 12 A. I think it falls underneath there somewhere. 13 Q. Okay. And on Exhibit 1 it says that, on the 14 third or fourth line, "We have initiated an internal 15 investigation to understand what may have led to this 16 tragedy," referring to John Pluchinsky's death,

17 correct, sir?

A. Yes.

- 19 Q. And it's been, I guess, almost a year since
- 20 that day on July 18, 2007. Based on your or the
- 21 Racquet Club's knowledge of the facts, what did lead
- 22 to this tragedy?
- 23 MR. REESE: To the extent that requires
- 24 you to comment on anything you may have learned from
- 25 counsel, I'm instructing you not to answer.

- 1 A. As I understand it -- I wasn't here the day
- 2 of the tragedy, but I understand that John was in
- 3 a -- in a group of four-year-old boys. They had gone
- 4 and had lunch or a snack prior to the swimming part
- 5 of the -- of the day, arrived at the pool at or
- 6 around 10:45. It's my understanding that John and
- 7 one of his little campers were friends and played,
- 8 the little boy, 4 y/o-C #7 boy and the mother was
- 9 there, played together. At around 11:00 o'clock I
- 10 understand that Ms. M #1 and her son went to the
- 11 lap pool and that the counselors took John to play.
- 12 And from that point till the time that 15 y/o LG #1
- 13 got out of her chair and went over to the -- and
- 14 yelled at the counselor, 4 y/o B-CC #3, to check on the
- 15 boy. That's how I understand what happened -- the
- 16 events that happened that day.
- 17 Q. (BY MR. MARRS) And when you say that around
- 18 o'clock Ms. M #1 left to go to the lap
- 19 pool and the counselors took John to play, what
- 20 counselors are you referring to?
- 21 A. I do not know.
- 22 Q. As the president of the Racquet Club at the
- 23 time this happened, you were very concerned about
- 24 what happened, correct?
- 25 A. Correct.

- 1 Q. And you certainly wanted to understand for
- 2 yourself as president exactly what happened, right,
- 3 sir?
- 4 A. To the best I could, yes.
- 5 Q. And the best you could do is to find out for
- 6 yourself what the facts were and who was involved and
- 7 what counselors and lifeguards were involved and what
- 8 happened, correct?
- 9 A. I'm not a -- I'm not a professional
- 10 investigator, so I asked a few of the people that
- 11 were around.
- 12 Q. Yes, sir.

- 13 A. And then left a lot of that up to the
- 14 professionals that were doing the investigation.
- 15 Q. Well, I'm not talking about professionals.
- 16 I'm talking about your employees. The counselors and
- 17 the lifeguards that were there that day on July 18th
- 18 with John Pluchinsky in the pool were your employees
- 19 at the Racquet Club, weren't they?

- 21 A. They were employees of the Racquet Club.
- 22 Q. (BY MR. MARRS) Sure. And so, if you as the
- 23 president wanted to know specifically what happened,
- 24 nothing kept you from specifically asking, well, what
- 25 counselors took John Pluchinsky to play, correct?

 - 1 A. I could -- I could have gone to speak with
 - 2 each of them, I guess -- I guess I could.
 - 3 Q. And you did not?
 - 4 A. I did not.
 - 5 Q. Well, did you ever ask -- to this day have
 - 6 you ever asked what counselors took John Pluchinsky
 - 7 to play after Ms. M #1 left to go to the lap
 - 8 pool?
 - 9 A. I have not personally done that.
 - 10 Q. Do you know who they were, the counselors?
 - 11 A. I do not.
 - 12 Q. And you have not asked, correct?
 - 13 A. I have not asked those counselors.
 - 14 Q. You have not asked anyone who those

- 14 Q. And who was that?
- 15 A. I don't know.
- 16 Q. You don't know?
- 17 A. No.
- 18 Q. And was it for the purpose of defending what
- 19 might be a lawsuit or was it for the purpose of
- 20 making the pools safe or do you know?
- 21 MR. REESE: Objection, form.
- 22 A. I don't know. I don't know.
- 23 Q. (BY MR. MARRS) Well, when you refer to, "We
- 24 have initiated an internal investigation," what
- 25 investigation are you referring to specifically?

 - 1 A. We hired the firm of Gardere Wynne to
 - 2 investigate the process of what happened.
 - Q. Okay. Separate and apart from lawyers that
 - 4 you've hired, what specific company, aquatics experts
 - 5 have you hired to come in to make sure your pools are
 - 6 safe for young children?
 - 7 A. The Club has hired a company called NASCO, I 8 believe.
 - 9 Q. Uh-huh.
 - 10 A. I believe they oversee -- they do mock
 - 11 trainings and they do oversee, I believe, pools,
 - 12 policies and procedures.
 - 13 Q. Uh-huh.
 - 14 A. That's who we hired.
 - 15 Q. And did your insurance company recommend
 - 16 that you hire them?
 - 17 A. They did recommend that we do.
 - 18 Q. And aside from hiring lawyers and hiring a
 - 19 company that your insurance company required you to
 - 20 hire, did you hire any other safety consultants or
 - 21 experts to come in and make sure your pools were safe

- 8 Q. (BY MR. MARRS) No?

- 10 Q. Then why is that before John Pluchinsky died
- 11 in your pool, you did not hire NASCO nor did you hire

- 13 safety company to come in and make sure your pools
- 14 were safe?

- 16 A. After John drowned, Steve Griffin went to

 - 22 not one to your knowledge, correct?

 - 24 Q. Now, Guillermo Palmer, it was kind of his

 - 1 sure that the pools were safe. That was one of his
 - 2 responsibilities, right?

I don't know. Q. Had you been aware prior to June 11th, 2007 7 of complaints about Guillermo Palmer --8 A. No. 9 Q. -- and whether he was doing his job? 10 A. No. 11 Q. You didn't become aware of any such 12 complaints about Guillermo Palmer prior to 13 John Pluchinsky's death? 14 A. No. 15 Q. Mr. Griffin did not pass on any of those 16 complaints to you before John Pluchinsky's death? 17 A. I believe this was the only one that I was 18 aware of. 19 Q. Was this e-mail transmitted to the 21 Board? 22 A. I don't know. I don't believe so, but I 23 don't know. Q. Okay. And she cc's a Board member, 25 HRCBM-D, as you said? □00159 A. That's correct. 1 Q. - 24 Did I read that correctly?
- 25 A. It looks like you did, yes, sir.

- 1 Q. So she's saying she made these complaints to
- 2 Guillermo Palmer and David Lambert [sic] --
- 3 A. Lamkin.
- 4 Q. -- Lamkin some five weeks before this
- 5 e-mail, which would have been approximately five
- 6 weeks before John's death, correct?
- A. Some five weeks ago, yes.
- 8 Q. So that's correct?
- 9 A. This is --
- 10 Q. Because this e-mail was sent on the very day
- 11 that John Pluchinsky drowned, July 18th, 2007?
- 12 A. Yes.
- 13 Q. So that's correct, right, sir?
- 14 A. Yes.
- 15 Q. Okay. Now, we know for a fact that although
- 16 something did happen, that a child, John Pluchinsky,
- 17 lost his life on July 18th, 2007, that Guillermo
- 18 Palmer did not lose his job and Mr. Lamkin did not
- 19 lose his job and the two lifeguards, 15 y/o LG #2
- 20 and 15 y/o LG #1 did not lose their jobs as a result,
- 21 correct?
- 22 A. I believe that's correct.
- 23 Q. And we know because I think you already
- 24 stated that with respect to Guillermo Palmer that on
- 25 the day in question, July 18, 2007, there were
- □00163
 - 1 lifeguards that didn't have current certifications,
 - 2 four lifeguards took lunch together during one of the
 - 3 busiest times of the day when a group -- a couple of
 - 4 groups of four-year old children were in the pool,
 - 5 that there was not an emergency action plan, that
 - 6 you've seen complaints prior to that time about

- 7 Guillermo Palmer, and yet he still had his job on 8 July 18, 2007, correct? A. That was a lot there. I'm sorry. 10 Q. Well, despite all of those things Guillermo 11 Palmer still had his job at the end of the day on 12 July 18th, 2007, correct? 13 A. Guillermo Palmer did, yes. 14 Q. Well, what does it take for your aquatics 15 director to be fired at the Houston Racquet Club? 16 What level of performance does it take for the 17 aguatics director to be relieved of his duties? A. I'm not sure I agree with the premise of all 19 these statements that have been said in these e-mails 20 from my understanding. I don't know what level. I 21 don't know what level it takes. 22 Q. Well, if your aquatics director allows 23 lifeguards to be on duty without current CPR 24 certifications, allows half of the lifeguards that 25 are on duty to go to lunch together while two groups □00164 1 of four-year olds are in the pool being watched by 2 two 15-year-old lifeguards, isn't that unacceptable 3 performance of the aquatics director who is 4 responsible for the lifeguards? 5 MR. REESE: Objection, form. A. Again, there's a lot there. The four 7 lifeguards going to lunch, they have shifts, as I 8 understand it and breaks, so I wouldn't consider them 9 on duty. I'm trying to recall some of the other 10 things you said there and I apologize for not 11 remembering them all, but... 12 Q. (BY MR. MARRS) Is that acceptable to you as 13 the president of the Houston Racquet Club at the time 14 for the aquatics director to allow those things to 15 happen? 16 MR. REESE: Objection, form. 17 A. I don't understand the premise from which 18 you're referring to as far as -- there are -- there 19 are shifts as I understand it that lifeguards go 20 through when they are on and off duty.

 - 21 Q. (BY MR. MARRS) And who's responsible for
 - 22 making sure that those shifts are appropriate and 23 safe?
 - 24 A. It would be Guillermo Palmer.
- 25 Q. Yes, sir. And if he allows half of the □00165

- 1 lifeguards on duty during summer camp to go to lunch
- 2 together leaving only two 15-year-old lifeguards
- 3 manning the entire pool full of children, including
- 4 two groups of four-year olds, is that acceptable to
- 5 you as president of your Club?
- 6 MR. REESE: Objection, form.
- 7 A. I'm not a lifeguard. I haven't taken any
- 8 Red Cross and I don't understand the Red Cross. I
- 9 would want a safe pool. I don't know -- I'm not -- I
- 10 don't understand the number of lifeguards needed;
- 11 however, it sounds like from what I understand we had
- 12 the appropriate number of lifeguards per bather load.
- 13 Q. (BY MR. MARRS) Really? Well, were you here
- 14 during the deposition of Guillermo Palmer?
- 15 A. I was not.
- 16 Q. Were you here during the deposition of
- 17 Mr. Lamkin?
- 18 A. I was not.
- 19 Q. Were you here during the deposition of
- 20 LG Supv?
- 21 A. I was not.
- 22 Q. And what's the bather load?
- 23 A. The definition of it?
- 24 Q. No. What's the appropriate ratio according
- $25\,$ to the bather load at the Houston Racquet Club that $\square 00166\,$
 - 1 was in place as of July 18, 2007?
 - A. I don't remember the exact ratios.
 - 3 Q. But you remember they were complied with?
 - 4 A. I don't know if they were -- I don't know.
 - 5 I would leave that up to the people that were in
 - 6 charge of that to confirm or deny that.
 - 7 Q. Which was who?
 - 8 A. It would have been LG Supv or
 - 9 Guillermo Palmer.
 - 10 Q. And if they did not ensure that the
 - 11 appropriate ratio of supervisors or lifeguards were
 - 12 in the pool on the day in question, then that would
 - 13 have been a lapse on their part, wouldn't it?
 - 14 MR. REESE: Objection, form.
 - 15 A. I would like to have been on top of that to
 - 16 staff the appropriate number of lifeguards per bather
 - 17 load, yes.
 - 18 Q. (BY MR. MARRS) Okay. Since there was a lot
 - 19 in my questions, as you stated, I wrote them out for
 - 20 you so I can ask you the questions and we'll all be

- 21 on the same page. So let me show you Exhibit

 - 21 Q. (BY MR. MARRS) Correct, sir?
 - MR. REESE: Objection, form.
 - 23 A. I can't -- if you could go back up. I'm
 - 24 sorry. I don't know how many of the girls there
- 25 were. There were 12 four-year-old boys and then I $\ \square \ 00168$
 - 1 don't know how many four-year-old girls there were.
 - Q. (BY MR. MARRS) Okay. Well, let's just say
 - 3 there were, plus two groups of four-year olds, okay,
 - 4 so we can be accurate.
 - 5 A. Okay.
 - 6 Q. Okay? Now, you've learned that those facts
 - 7 existed from being involved in this case, correct, 8 sir?
 - 9 MR. REESE: Objection, form.

 - 3 A. Prior complaints about Guillermo Palmer.

 - 5 Q. (BY MR. MARRS) Why don't we put --
 - 6 A. -- the two that you talked about.
 - 7 Q. Why don't we put HRCBM-B, Griffin and
 - 8 Ms. CM #1 said that she complained previously?

 - 1 last week, once about putting the flag at half-mast
 - 2 (done), and once to call for a membership meeting as
 - 3 an open forum to discuss the drowning. I did not
 - 4 call him back about this suggestion; did not want to
 - 5 get dragged into a pointless discussion.

Not to my knowledge. 3 (Plaintiff's Exhibit Number 26 4 referenced.) Q. (BY MR. MARRS) And Exhibit Number 26 is an 6 e-mail from CM #2. Do you know who she is? 7 A. I don't know her. Q. Okay. This is an e-mail from CM #2 9 to Mr. Erck sent to the memberfeedback web link on 10 July 25th. She addresses it to you, Mr. Erck. Did 11 you receive this e-mail on or about July 25th? 12 A. I assume I did, yes. 13 Q. When have you last reviewed this e-mail? A. Oh, I think it's probably back in the fall 14 15 sometime. 16 Q. Which would have been what month

And had you ever, prior to July 18, 2007, 24 seen anything with respect to safety or lifeguards at 25 the family pool that concerned you? □00185 1 A. No. Q. Had you ever mentioned to any of the 3 managers or lifeguards or aquatics director prior to 4 July 18th that you had concerns with respect to 5 lifeguards or safety at the family pool or lap pool? 6 A. No. 7 Q. How many times had you been out to the 8 family pool prior to July 18, 2007? A. I can't recall. Maybe we'll come out a few 10 times a week, I would assume. 11 Q. I mean, a handful of times or more? 12 Approximately? 13 A. A couple dozen times. 14 Q. Okay. Did you say that one of your children 15 had been in summer camp at the Racquet Club? A. Tennis camp. 17 Q. Tennis camp? How about summer camp? 18 A. No. 19 (Plaintiff's Exhibit Number 27 20 referenced.) 21 Q. (BY MR. MARRS) Let me show you Exhibit 22 Number 27. This is an e-mail sent from M #5 23 to Mr. Griffin and yourself where she is saying that 24 as a member she's "beyond disappointment" and she's 25 complaining and saying that, "It is reprehensible □00186 1 that members endure the constant blast e-mails 2 promoting the revenue generating events at the Club

 - 3 yet have to find out about the tragic death of a
 - 4 child on our premises on the 10:00" -- o'clock --
 - 5 "news."
 - Did you receive that on or about the

- 7 time in July 2007, the 20th? A. I believe I did. 9 Q. Did you communicate with Ms. M #5 about 10 this? 11 A. I did not. I believe that was the same day 12 we sent out a -- the notice to the membership. Q. And in that notice did you tell the 14 membership that the Racquet Club was operating an 15 illegal day camp as the CPS had found? 16 MR. REESE: Objection, form. 17 A. They had not found us -- they were still --18 they were doing their investigation. Q. (BY MR. MARRS) Have you at any time 20 informed the membership of a Club that the CPS had 21 found you were operating an illegal day camp? 22 A. No. 23 Q. Or that the CPS had cited the Club for 24 causing John Pluchinsky's death? 25 A. No. □00187 1 Q. Why not? A. It was already in the news and in the paper. Q. And because of that you saw no reason to 4 send a blast e-mail to the membership to let them 5 know? A. No. But the investigation on that issue is 7 still pending. Q. But you still have members that are putting 9 their young children in your pools on a weekly basis, 10 correct? 11 A. We do. 12 Q. MARRS) And on Exhibit 28 when 19 Mr. -- tell the jury who HRCBM-E-- am I saying it right, 20 HRCBM-E, is? 21 A. HRCBM-E. 22 Q. HRCBM-E. Who is he? 23 A. I'm sorry. You want me to tell you? He was 24 a --
- 25 Q. Sure. □00188

- 1 A. -- a -- he's a member. He was a Board
- 2 member several years ago.
- 3 Q. Okay. Until when approximately?
- A. Three years ago.
- 5 Q. And has he ever held any positions at the
- 6 Racquet Club?
- 7 A. He was, I believe, secretary three years
- 8 ago.
- 9 Q. Okay. He's a man who still stays involved
- 10 in the goings on at the Racquet Club. Is that safe
- 11 to say?
- 12 A. He plays tennis at the Club. He was writing
- 13 a article that would talk about a specific employee.

- 15 A. It could be anybody.
- 16 Q. Well, was it CD that he's

 - 1 back to normal. And she had nothing to do with the
 - 2 tragedy. But it's your call. Sage advise, please.
 - 3 HRCBM-E."
 - In your view, have things died down and
 - 5 gotten back to normal at the Houston Racquet Club?
 - 6 A. No.
 - 7 Q. Do you think things are back to normal with
 - 8 the Pluchinskys?
 - 9 A. No.
 - 10 Q. Has this piece on CD been done?
 - 11 A. No.
 - 12 Q. Or on any other employee been done as
 - 13 drafted by Mr. HRCBM-E?
 - 14 A. Not to my knowledge.
 - 15 Q. Do you think things ever will be back to
 - 16 normal for the Pluchinsky family?
 - 17 A. I don't know.
 - 18 Q. And --
 - 19 MR. REESE: Let's take a break if we're
 - 20 going on to another exhibit.

- 8 Q. Well, you could voice your opinion as a

- 14 short, no quick solution to this."
- Now, to your knowledge, what "quick

- 18 a fully guarded pool --
- 19 Q. Uh-huh.
- 20 A. -- during hours of operation.
- 21 Q. Yes, sir.
- 22 A. That we have had in the past was, I believe,
- 23 our goal with --

- Q. Did you at any time ask for a special
- 3 assessment of the membership or for funds to be
- 4 raised or allocated towards the hiring of more
- 5 lifeguards for your pools?
- 6 MR. REESE: Objection, form.
- 7 A. During my remaining days as the president, I
- 8 did not ask the membership for an assessment.
- 9 Q. (BY MR. MARRS) Or to allocate funds for the
- 10 hiring of lifeguards?
- 11 A. Well, that can be done within the operating
- 12 budget.
- 13 Q. Did you ever specifically request that funds
- 14 be used to hire more lifeguards than existed on
- 15 July 18th, 2007?
- 16 A. We were working on that decision, whether we
- 17 were going to go 365 days a year with a fully-guarded
- 18 pool or not.
- 19 Q. Okay.
- 20 A. I did not demand funds to do that
- 21 immediately.
- 22 Q. Did you at any time demand that more guards
- 23 be hired than you had on July 18, 2007 for your
- 24 pools?

25 A. Did I demand back -- I'm sorry. Did I $\Box 00204$ 1 demand to hire more lifeguards? Q. Yes, sir. 3 A. I personally did not. 4 Q. Did you as president? A. I did not as president. Q. Okay. As president you had the authority to 7 do that, correct? A. I assume I would have with consultation with 9 the rest -- with some of the other Board members. I 10 would assume I would have. Q. Well, you don't have to assume it. You can 12 look at your bylaws, which say that the president has 13 the authority for all affairs of the Club as well as 14 to enter into obligations and contracts for the 15 Racquet Club, doesn't it? A. It says that the -- I don't know exactly 16 17 what it says, but to generally be in charge of the 18 affairs of the Club. 19 Q. Sure. So you could do that if you so chose, 20 correct? 21 A. But, I'm between a 10 rock and a hard place; the requirements of our 11 insurance company and the expectations of the 12 membership." 13 He goes on later to say, (Reading) The 14 other problem is the need to guard it to the level 15 expected by Jeff Ellis & Associates, the risk 16 management company identified and requested by our 17 insurance carrier. 18 Now, is it your understanding that

- 19 Ellis refused to be your lifeguarding company because
- 20 the Racquet Club refused to put in place the measures
- 21 that Jeff Ellis required in order for it to sign a
- 22 contract with you?
- 23 MR. REESE: Objection, form.
- 24 Q. (BY MR. MARRS) Or do you not know?
- 25 A. I don't know, but that does not sound

- 1 accurate.
- Q. Okay. Were you in talks with Jeff Ellis or
- 3 did someone else handle that?
- A. Steve Griffin handled that.
- Q. And it says here, "Their inspectors show up
- 6 unannounced several times per year (per our contract
- 7 with them) and videotape the guards without their
- 8 knowledge. This can either" be "a very favorable,
- 9 permanent record of performance (handy in a lawsuit),

 - 8 videotapes -- "could have the opposite effect." He's

- 21 A. Yes.
- 22 Q. Well, then why did Mr. Griffin express some
- 23 concerns about having videotapes and -- of his
- 24 lifeguards performing their duties unannounced --
- 25 MR. REESE: Objection, form.

- 1 Q. (BY MR. MARRS) -- if he wasn't concerned
- 2 about it and it was just fine with the Racquet Club?
- 3 MR. REESE: Same objection.
- 4 Q. (BY MR. MARRS) Do you know?
- 5 A. I don't see any concern in there. I see
- 6 looking at two sides.
- 7 Q. This could be very favorable or have the
- 8 opposite effect? It could be favorable or
- 9 unfavorable; isn't that how you read that or not?
- 10 A. No. That's not how I read it.
- 11 Q. Okay. So I think you testified that the
- 12 HRCBM-B e-mail, to your knowledge, was not
- 13 transmitted to the Board, right?
- 14 A. Correct.
- 15 Q. Nor the Steven Griffin e-mail, correct?
- 16 A. Correct.
- 17 Q. Nor the CM #1 e-mail, correct?
- 18 A. Not to the entire Board, no, correct.
- 19 (Plaintiff's Exhibit Number 22b
- 20 referenced.)
- 21 Q. (BY MR. MARRS) So on Exhibit 22b where we
- 22 had these warnings listed out, I'll put-- where it
- 23 says, "Transmitted to Board? No. No. No." Okay?
- 24 MR. REESE: Objection, form.
- 25 Q. (BY MR. MARRS) Now, are there any other □00209
 - 1 complaints about lifeguards not doing their jobs or
 - 2 Mr. Palmer not doing his job that are listed on
 - 3 Exhibit 22b, to your knowledge, that we haven't
 - 4 already talked about today?
 - 5 A. None that I'm aware of. I think you've said
 - 6 a couple of other e-mails earlier today.

- 7 Q. Other than what we discussed today, anything 8 else?
- 9 A. Not that I can remember.
- 10 Q. And correct me if I'm wrong. I think you
- 11 said that a special Board meeting was not called with
- 12 respect to John Pluchinsky's death; is that correct?
- 13 A. We had a -- We had a meeting with any member
- 14 of the Board that could come to meet with counsel to
- 15 understand the process of what was going on and get a 16 status.
- 17 Q. And when was that?
- 18 A. Sometime late July, early August.
- 19 Q. Okay. And was that with Mr. Wall?
- 20 A. That was with the firm Brown Sims and
- 21 Gardere Wynne.
- 22 Q. And various families of the Racquet Club,
- 23 family members?
- A. No. There -- it was Board members who could come.

- 1 Q. Okay.
- 2 A. It was not an official Board meeting of any 3 type.
- 4 Q. Okay. So other than that, my question is:
- 5 Was a special Board meeting called with respect to
- 6 the death of John Pluchinsky?
- A. Not outside of what I've discussed.
- 8 Q. And -- Now, a special Board meeting was
- 9 called in 2006 with respect to, among other things, a
- 10 \$30 due increase, wasn't it? Do you recall that?
- 11 That would be Exhibit 58, minutes for the Special
- 12 Board Meeting of May 9th, 2006. You were present at
- 13 that meeting, correct?
- 14 A. May 9, 2006.
- 15 Q. It says --
- 16 A. I was present, yes. Let's see...
- 17 Q. Okay. And one of the things that was
- 18 discussed and discussed first in the minutes is a
- 19 proposal to increase the dues by \$30, correct?
- 20 A. It stated "the purpose of this meeting was
- 21 to revisit the \$30 dues increase passed by the
- 22 Board." Okay.
- 23 Q. Is that correct?
- A. That's what she says, what's stated there, 25 yes.
- □00211

- 1 Q. Okay. And --
- 2 MR. REESE: Just a second. That would
- 3 have been when Mr. Erck was vice president. You 4 incorrectly --
- 5 MR. MARRS: Okay. That's fine.
- 6 MR. REESE: I just -- well --
- 7 Q. (BY MR. MARRS) And you were vice president
- 8 at that time; is that right?
- A. That's correct.
- 10 Q. Okay. Now as president, I just want to
- 11 close the loop on this, although the Board thought it
- 12 was important to discuss a \$30 dues increase in the
- 13 year before, when you're president and a child dies
- 14 in your pool, that did not incite you to call as
- 15 president a Special Board Meeting to discuss
- 16 John Pluchinsky's death, correct?
- 17 A. We did not have a -- We did not have a
- 18 Special Board Meeting. We had -- We did have an
- 19 opportunity for the Board to gather to speak about
- 20 this accident.
- 21 Q. It took -- It takes how many days' notice
- 22 for you to call a special committee meeting, Special
- 23 Board Meeting?
- 24 A. I assume there's certain rules under -- in
- 25 the bylaws that require that, but I don't -- I don't $\hfill\Box 00212$
 - 1 know.
 - 2 Q. Would it surprise you that it takes only two
 - 3 days' notice?
 - 4 A. It wouldn't surprise me.
 - 5 Q. And you did not call an Executive Committee
 - 6 Meeting with respect to John Pluchinsky's death
 - 7 either, correct?
 - 8 A. It would be -- you could consider it an
 - 9 executive meeting, I guess, with -- that we had.
 - 10 Q. In August?
 - 11 A. It could have been in late July. I don't
 - 12 remember the exact day
 - 13 (Plaintiff's Exhibit Number 45a marked.)
 - 14 Q. (BY MR. MARRS) Now, let me show you
 - 15 Exhibit 45a, Board minutes for April 29th, 2004. And
 - 16 on Page 2 it mentions that she,
 - 17 Jean-Calloway-Stinson -- oh, excuse me, second line
 - 18 there. "Sondra Maxfield, has been retained for the
 - 19 start up of the childcare. She will aid with the
 - 20 hiring of the staff, to include background checks and

- 21 CPR training, and all aspects of implementing the
 22 childcare facility."
 23 Do you see that?
 24 A. I see that.
- 25 Q. Why did the Houston Racquet Club not perform □00213
 - 1 background checks on those that were responsible for2 supervising the children in your summer camp for3 2007?
 - 4 MR. REESE: Objection, form.
 - 5 A. I do not know.
 - 6 Q. (BY MR. MARRS) Do you now know that that is
 - 7 a requirement or not?
 - 8 A. I do not know.
 - 9 Q. Have you asked that question, why that was
 - 10 not performed?
 - 11 A. I have not.
 - 12 (Plaintiff's Exhibit Number 45b marked.)
 - 13 Q. (BY MR. MARRS) And in Exhibit 45b the
 - 14 minutes for October 11, 2005, it mentions
 - 15 "construction of the Ballroom, Grill and Pool
 - 16 Complex." And "with the increase of membership these
 - 17 accomplishments were made possible."
 - 18 Now, when was the family pool
 - 19 construction complete?
 - 20 A. I can't remember. I think it was August,
 - 21 September -- maybe two and a half years ago. I don't 22 know.
 - 23 Q. Okay. And it says, "The newly elected Board
 - 24 members are: HRCBM-A," right?
 - 25 A. HRCBM-A.
- □00214
 - 1 Q. "HT, HRCBM-U, HRCBM-H,
 - 2 HRCBM-B and FC." And who is HRCBM-A?
 - 3 Is that 4 y/o B-CC #3 's mother?
 - 4 A. Yes, it is.
 - 5 (Plaintiff's Exhibit Number 45c marked.)
 - 6 Q. (BY MR. MARRS) And on Exhibit 45c, minutes
 - 7 for the December 15, 2005 Board meeting, you were
 - 8 present during that Board meeting, weren't you?
 - 9 A. I was --
 - 10 Q. "Ted Erck-Vice President"?
 - 11 A. I was there. It looks like it, yes.
 - 12 Q. And on Page 4, it says, "Grounds Committee.
 - 13 HRCBM-S " -- now, he's a lawyer, right?
 - 14 A. I believe so.

- 15 Q. "... announced that the Club was in full16 compliance with the pool enclosures according to the
- 17 Texas Administrative Codes. David Lamkin has a copy
- 18 of the pool safety provisions," right, sir?
- 19 A. That's what it says.
- 20 Q. So we know that David Lamkin had a copy of
- 21 the pool safety provisions of that Texas Code at
- 22 least as of December, 2005, correct, sir?
- 23 MR. REESE: Objection, form.
- 24 A. I'm not sure what David had, but -- I'm not
- 25 sure what HRCBM-S gave him, but it had to do something $\square 00215$
 - 1 with the Texas Administrative Code.
 - 2 Q. (BY MR. MARRS) And isn't that what this
 - 3 exhibit shows? Isn't that what it states?
 - 4 David Lamkin has a copy of the pool safety
 - 5 provisions?
 - 6 MR. REESE: Objection, form.
 - 7 A. Yes.
 - 8 Q. (BY MR. MARRS) And was HRCBM-S acting
 - 9 as counsel for -- legal counsel for the Club at that
 - 10 time?
 - 11 A. He was not.
 - 12 Q. But as discussed in the Board meeting, the
 - 13 Board as of December 2005 knew that the Texas
 - 14 Administrative Code, some of its provisions apply to
 - 15 the pools at the Racquet Club, didn't it?
 - 16 A. I reviewed the construction of the pool area
 - 17 and felt like -- felt that -- it looks like it
 - 18 felt -- that he felt that it met the Texas
 - 19 Administrative Code provisions.
 - 20 Q. And that was discussed in the Board meeting
 - 21 as reflected in the minutes, right?
 - 22 A. To some degree. I'm not sure to what
 - 23 degree. I don't know if he just announced that or if
 - 24 he discussed any specifics. I have no recollection.
 - 25 Q. Well, we know for a fact that at least to

 - 1 the degree of saying that "the Club was in full
 - 2 compliance," mentioning the Texas Administrative Code
 - 3 and the pool safety provisions, doesn't that indicate
 - 4 to you that the Board knew at least as of this time
 - 5 that there were pool safety provisions in the Texas
 - 6 Administrative Code?
 - 7 MR. REESE: Objection, form.
 - 8 A. He states that the "full compliance with the

- 9 pool enclosures..." 10 Q. (BY MR. MARRS) Sure. 11 ... according to the Texas Administrative 12 Codes." He announced that. Q. Okay. Okay. So was it your understanding 13 14 at this time that there were, as the minutes reflect, 15 pool safety provisions in the Texas Administrative 16 Code that apply to the Houston Racquet Club pool? 17 MR. REESE: Objection, form. 18 A. Was it my understanding at that particular 19 time? I can't -- I can't -- I have no --Q. (BY MR. MARRS) Okay. Well, you don't 21 have --A. -- understanding. 22 23 Q. I'm sorry. Are you finished? 24 A. I'm all right. 25 Q. You don't have any reason to believe that □00217 1 what is reflected in the minutes occurred? A. I have no reason to believe that it did not 3 occur. 4 Q. Okay. And it says here that -- under "Youth 5 Services. HRCBM-J reported" to "the Youth 6 Services Committee went to the Houstonian and got 7 some good insights on their Teen Room." Did any employee of the Houston Racquet 9 Club, to your knowledge, during the time you were 10 president go to any other clubs to get some good 11 insights about how the lifeguards were trained or how 12 they ran their summer camps? A. I don't know. I don't know -- I do not know 13 14 if any employee went to another club to talk about 15 their lifeguards. 16 Q. You certainly never asked anyone to do that, 17 right? 18 A. No, I did not. 19 (Plaintiff's Exhibit Number 45d marked.) 20 Q. (BY MR. MARRS) And we know that on 21 Exhibit 45d, another minutes -- and I'll tell you 22 this came from August 2006 -- it mentions that 23 "wristbands are being utilized for all guests at the 24 pool area."
- Did you witness that also, that that □00218
- 1 occurred, wristbands being used?
 - 2 A. Yes. I've seen the wristbands.

- 3 Q. Do they still use them at the Racquet Club?
- 4 A. I don't believe they do right now.
- 5 Q. Well, at this time they were using it to
- 6 differentiate guests from members; is that right?
- 7 A. That's correct.
- 8 Q. And would they be a certain color?
- 9 A. I don't know. I don't think there's
- 10 anything special about them.
- 11 Q. Well, they were all the same color, though,
- 12 weren't they?
- 13 A. Yes, I believe so.
- 14 Q. And why didn't the Racquet Club use
- 15 wristbands to differentiate children with different
- 16 swimming abilities in the pool for summer camp 2007,
- 17 to your knowledge?
- 18 A. I don't know.
- 19 Q. Well, we know that the Racquet Club knew
- 20 where to get wristbands, at least as of August 2006,
- 21 right?
- 22 A. Correct.
- 23 Q. Have you asked why color coding or
- 24 wristbands were not used to differentiate kids with
- 25 different swimming abilities during the summer camp □00219
 - 1 2007?
 - A. I have not. I haven't heard that being
 - 3 done. It may be done some places, but I have not
 - 4 seen or -- that or heard of that, but I did not ask
 - 5 the question.
 - 6 Q. Would you expect your aquatics director to
 - 7 be aware of that practice if indeed it existed?
 - 8 A. Possibly.
 - 9 (Plaintiff's Exhibit Number 45e
 - 10 marked.)
 - 11 Q. (BY MR. MARRS) And then subsequent to this,
 - 12 August 31st, 2006, this is another minutes for that
 - 13 Board meeting and it also says, "Ted Erck Vice
 - 14 President." You were present, correct?
 - 15 A. Yes. It looks like it.
 - 16 Q. And on Page 2 we see where -- can you see
 - 17 that okay? Where under "Fitness HRCBM-Q" it
 - 18 states that, "The Fitness Committee met, and there
 - 19 are two things that need to be brought to the Board's
 - 20 attention. With the amount of water area that we
 - 21 have at" the "Club, there is concern about not having
 - 22 adequate coverage with Lifeguards." Do you see that?

- 23 A. I see that.
- 24 Q. Now, "not having adequate coverage with
- 25 Lifeguards" at your pools could be a safety risk, □00220

1 correct?

- 2 A. It could be.
- 3 Q. And this was an expressed concern voiced
- 4 during this Board meeting, right?
- 5 A. May I see the date of this meeting, please?
- 6 Q. Of course.
- 7 A. I'm sorry.
- 8 Q. That's okay. It was August 31st, 2006.
- 9 A. Okay.
- 10 Q. All right.
- 11 MR. REESE: And if you need to look at
- 12 the entire paragraph, not just what's highlighted.
- 13 THE WITNESS: Okay.
- 14 MR. REESE: Your --
- MR. MARRS: Do you want to go off the
- 16 record and --
- 17 MR. REESE: No. We can stay on the
- 18 record if you're going to ask him questions about it,
- 19 but he should have the opportunity to read the entire
- 20 text of what was going on.
- 21 THE WITNESS: I -- okay. I'm sorry.
- 22 That helps me.
- 23 MR. MARRS: That's okay.
- 24 THE WITNESS: Thank you.
- 25 MR. MARRS: Sure. Happy to do it.

- 1 A. It's my understanding historically though,
- 2 as the time approaches Labor Day it becomes more
- 3 difficult to staff lifeguards adequately.
- 4 Q. (BY MR. MARRS) Okay.
- A. Certain things -- certain things, it's my
- 6 understanding that they do what they can to try to
- 7 make sure that we have adequate coverage. Also, it
- 8 says we're "very careful about our signage when it is
- 9 left unguarded."
- 10 Q. Sure. But what was done about this specific
- 11 complaint, about a possible lack of coverage,
- 12 lifeguard coverage at the pools, if anything, to your
- 13 knowledge?
- 14 A. I don't know if it was a complaint. I think
- 15 it was an observation that as the time gets closer to
- 16 this time period when people go to school, high

- 17 school or colleges, that it becomes more difficult
- 18 for coverage.
- 19 Q. And what was done about it?
- 20 A. I don't -- I can't -- I can't remember.
- 21 Q. Were additional monies put into the budget
- 22 in order to hire more lifeguards at this time, to
- 23 your knowledge?
- 24 A. I believe that lifeguards do get raises to
- 25 try to stay on to keep them on longer throughout □00222
 - 1 September.
 - Q. That's not my question. Was additional.
 - 3 budgeting put in place to hire more lifeguards as a
 - 4 result of this observation by the fitness committee,
 - 5 to your knowledge?
 - A. I cannot recall what happened at this
 - 7 particular day and time.
 - 8 (Plaintiff's Exhibit Number 45f
 - 9 marked.)
 - 10 Q. (BY MR. MARRS) Well, let's look at the
 - 11 next -- or the Board meeting the following month,
 - 12 September 28, 2006, Exhibit 45f. And it also
 - 13 indicates that you were present at that meeting,
 - 14 correct?
 - 15 A. Yes.
 - 16 Q. And HRCBM-E indicates here, "HRCBM-E
 - 17 observation should we be selling our memberships
 - 18 for more money? He feels that we have been very
 - 19 conservative and we should be thinking in larger
 - 20 terms."
 - 21 Do you see that?
 - 22 A. Yes.
 - Q. Did you agree or disagree or were
 - 24 indifferent about that opinion by HRCBM-E that we
- 25 need to be thinking in larger terms and sell our
- $\Box 00223$
 - 1 memberships for more money?
 - 2 A. I don't remember what I thought at that
 - 3 particular time.
 - 4 Q. Do you know why, although a month before an
 - 5 observation was made that there might not be enough
 - 6 lifeguard coverage, do you know why in the very next
 - 7 meeting of the Board there was no mention whatsoever
 - 8 made about that observation?
 - 9 A. I didn't -- I need to read the --
 - 10 HRCBM-Q 's position there to see, to talk about

- 11 whether there's any other mention or not.
- 12 Q. Well, assume with me there's not since
- 13 there's not. Do you know why there was no mention
- 14 during the Board meeting of that previous month's --
- 15 A. I don't know why.
- 16 Q. Do you know whether or not within one
- 17 month's time that concern was remedied?
- 18 A. I don't know.
- 19 MR. REESE: Objection, form.
- 20 Q. (BY MR. MARRS) You can't say one way or the
- 21 other?
- 22 A. I can't say one way or the other
- 23 (Plaintiff's Exhibit Number 45g
- 24 marked.)
- 25 Q. (BY MR. MARRS) But what we can say is that □00224
 - 1 May 2007, as shown in the minutes for 45g, minutes of
 - 2 that Board meeting, that you were present, correct?
 - 3 A. Yes.
 - 4 Q. Only this time you were the president,
 - 5 right?
 - 6 A. Yes.
 - 7 Q. And under -- on Page 2, "Fitness -
 - 8 FC," there's a statement in here that -- they are
 - 9 talking about, "One advantage of moving the Kids'
 - 10 Club is that Kids' Club employees can help watch the
 - 11 kids in the Youth Room. We are not licensed as a day
 - 12 care facility."
 - 13 Do you see that?
 - 14 A. I see that.
 - 15 Q. Do you know which Board members were aware
 - 16 prior to this Board meeting that there were Texas
 - 17 licensing requirements to run a child care facility?
 - 18 A. I do not believe that the way we structure
 - 19 our Kids' Club we are required to have a license.
 - 20 Q. Is that your belief as we sit here today?
 - 21 A. Yes.
 - 22 Q. And regardless of your belief, it was known
 - 23 by the Board as of May 30, 2007 that the Racquet Club
 - 24 was not licensed as a day care facility, correct?
 - 25 A. The Kids' Club portion, yes.

- 1 Q. Okay.
- 2 A. The Kids' Club.
- 3 Q. Well, the Board was aware that no part of
- 4 the Racquet Club was licensed as a day care facility,

- 5 didn't it, as of the date of this document?
- 6 A. No. This pertains directly to the Kids'7 Club.
- Q. Okay. Well, tell me what part of the
- 9 Racquet Club was licensed as a day care facility as
- 10 of the time of this Board meeting on May 30th, 2007.
- 11 A. It was my understanding that none of the
- 12 Club was licensed.
- 13 Q. Okay. And if there was mention in the Board
- 14 meeting that they're not licensed as a day care
- 15 facility, then certainly the Board knew that in order
- 16 to run a day care facility you had to be licensed,
- 17 right?
- 18 A. There are certain requirements for certain
- 19 types of day care facilities that need licenses, yes.
- 20 Q. And the Board knew that as of May 30, 2007,
- 21 didn't it?
- 22 A. They are in reference to this. Again, this
- 23 is dealing with the Kids' Club at our Club. That's
- 24 the perspective with which the Board was
- 25 understanding this statement.

- 1 Q. And we also know that HRCBM-S was at
- 2 that Board meeting, too, correct?
- 3 A. Yes. It looks as though he was.
- 4 Q. Any other lawyers that you can spot on
- 5 Page 1 of Exhibit 45g that were at that Board 6 meeting?
- 7 A. HRCBM-X is one.
- 8 Q. Okay.
- 9 A. I believe HRCBM-P is.
- 10 Q. Okay.
- 11 A. And that's it.
- 12 Q. Did any of those lawyers or anybody on
- 13 behalf of the Racquet Club before July 18, 2007 look
- 14 into whether or not the summer camp 2007 constituted
- 15 a day care facility, to your knowledge?
- 16 A. Not to my knowledge.
- 17 Q. Or that looked into whether or not the
- 18 summer camp 2007 had to be licensed, to your
- 19 knowledge?
- 20 A. Not to my knowledge.
- 21 Q. And on Page 3 we see a reference to the fact
- 22 that the Harris County Appraisal District sent our
- 23 valuation and it increased from \$6 million to
- 24 \$26 million. Do you remember that issue?

25 A. I do.

- 1 Q. And was it your understanding that Harris
- 2 County Appraisal District had appraised the Racquet
- 3 Club property at \$26 million?
- 4 A. That was their initial appraisal.
- 5 Q. Did the Racquet Club hire counsel in order
- 6 to get that appraisal down?
- A. We hired assistance. I don't know if it was
- 8 counsel, but we hired assistance to fight HCAD.
- 9 Q. Okay. And it says here, "We are contacting
- 10 Vinson & Elkins to develop a strategy to file the
- 11 necessary exemptions or get the recreational status
- 12 or restriction that is needed," correct?
- 13 A. We did.
- 14 Q. Did they assist you in doing that?
- 15 A. I don't believe -- I'm not -- I don't know
- 16 if the person came from V&E or where he -- where he
- 17 came from. I don't remember.
- 18 Q. Okay. But you were successful in getting
- 19 the valuation reduced, correct?
- 20 A. Yes, we were successful in correcting the
- 21 valuation.
- 22 (Plaintiff's Exhibit Number 45h marked.)
- 23 Q. (BY MR. MARRS) And Exhibit 45h, this is
- 24 June 28, 2007 minutes, and it reflects that you were
- 25 present, correct?
- □00228
 - 1 A. Yes.
 - Q. And it says here at the bottom under
 - 3 "General Manager Steve Griffin," that "Attendance
 - 4 at both the Summer Camp and Tennis Camp has been
 - 5 strong this year. Members have complained about the
 - 6 parking shortage and long lines to drop off and pick
 - 7 up as well as delivery trucks blocking the road.
 - 8 Steve is meeting with TD and David" -- who is
 - 9 TD?
 - 10 A. TD is the director of tennis.
 - 11 Q. And would that be David Lamkin?
 - 12 A. Yes.
 - 13 Q. "... to determine if we have allowed
 - 14 enrollment to get too high and to try and come up
 - 15 with a better traffic flow plan," correct?
 - 16 A. That's what it says.
 - 17 Q. This was -- let me look at the date again
 - 18 for this exhibit. This was a month before John's

- 19 death, right?
- 20 A. That's correct.
- 21 Q. Did the Racquet Club, as a result of a
- 22 concern that maybe enrollment at summer camp 2007 had
- 23 gotten too high, ensure that more than two lifeguards
- 24 were watching the family pool during summer camp
- 25 2007?

- 1 MR. REESE: Objection, form.
- 2 A. I don't understand the question. That had
- 3 nothing to do with the issue that you've underlined
- 4 and highlighted.
- 5 Q. (BY MR. MARRS) Well, increased enrollment
- 6 of summer camp has a number of effects, but we know
- 7 two of them is, Number 1, it means you're going to
- 8 have more parents dropping off more kids, right?
- 9 A. Possibly, yes.
- 10 Q. And it means that more kids are going to be
- 11 in summer camp, right? Right, sir?
- 12 A. Yes. Yes. Sorry.
- 13 Q. And if more kids are in summer camp, it
- 14 probably is going to mean that more kids are going to
- 15 be in the family pool, right?
- 16 MR. REESE: Objection, form.
- 17 Q. (BY MR. MARRS) It could?

 - 7 highlighted here.
 - 8 Q. (BY MR. MARRS) Okay. Well, let's forget

 - 9 A. The issue was not raised -- was not raised

- 2 Q. So this is June 28th and then we know that
- 3 the incident occurred July 18th, correct?
- A. Correct.
- 5 Q. And then here June 26, 2007 [sic], as
- 6 depicted on Exhibit 45i, was that the very next Board
- 7 meeting after John Pluchinsky's death, to your
- 8 knowledge?
- 9 A. It was the -- it was the next scheduled
