      Q. Mr. Griffin, my name is Scott Marrs and
18 together with Matt Pletcher and the law firm of
19 Beirne, Maynard and Parsons we are honored to
20 represent the Pluchinsky family in this case against
21 the Racquet Club and various individuals. You are
22 the general manager of the Houston Racquet Club; is
23 that correct?
24
      A. That's correct.
25
      Q. And you've been the general manager since
0005

- 1 approximately July of 2005?
- 2 A. September 2005.
- 3 Q. And you were the general manager of the
- 4 Houston Racquet Club on July 18th, 2007 when John
- 5 Pluchinsky lost his life at your club?
- 6 A. Yes, sir.
- 7 Q. Who do you report directly to?
- 8 A. The president of the club and the board of
- 9 directors.
- 10 Q. As of the date of John Pluchinsky's death
- 11 the president of the Racquet Club was Ted Erck; is
- 12 that correct?
- 13 A. That's correct.
- 14 Q. And he's in the room with us today, isn't
- 15 he?
- 16 A. Yes, he is.
- 17 Q. Currently Bob Landauer is the President of
- 18 the Racquet Club; is that right?
- 19 A. That's correct.
- 20 Q. You understand that all the testimony you're
- 21 giving here today will be both as corporate
- 22 representative and individually, correct?
- 23 A. Yes, sir.
- 24 Q. Let me show you what's been marked as
- 25 Exhibit Number 1. Do you recognize this 0006
- 1 July 20th, 2007 Houston Racquet Club document?
- 2 A. Yes, I do.
- 3 Q. Tell the jury what that is.
- 4 A. I believe that's a letter that was -- that
- 5 was written by Ted Erck to the members of the Racquet6 Club.
- 7 Q. And that was with respect to the death of

- 5 Q. So they are here today, they want to know,
- 6 they are willing to listen, so tell the jury and the

- 8 MR. SNYDER: And I'll remind you and
- 9 instruct you, Mr. Griffin, not to divulge any
- 10 information that has been learned or acquired through
- 11 the Gardere Wynne investigation. If you have
- 12 knowledge that you and/or the club acquired
- 13 independent of that, that's not privileged, you can
- 14 certainly disclose that and respond to the question.
- 15 Q. (BY MR. MARRS) Go ahead.
- 16 A. Would you repeat the question, please?
- 17 Q. Sure. The family is here today. They want
- 18 to know what led to this tragedy at your club. You
- 19 investigated this tragedy. You -- and talked to your
- 20 employees about this tragedy. We have some of those
- 21 statements from those employees that the Racquet Club
- 22 has produced to this family, but they want to know
- 23 what happened. So go ahead and tell the jury and the
- 24 Pluchinskys what happened to their little boy on
- 25 July 18, 2007 at your club.

- MR. SNYDER: And I'll give you --
- 2 Q. (BY MR. MARRS) What's your understanding of 3 what happened?
  - MR. SNYDER: And I'll give you the same
- 5 instruction, Mr. Griffin: Not to divulge any
- 6 information learned as a result of the Gardere Wynne 7 investigation.
- 8 A. We don't know. We don't know. There was
- 9 evidence that has been uncovered, but it's of a
- 10 privileged nature by the attorneys that we retained.
- 11 Q. (BY MR. MARRS) Do you have anything further
- 12 you want to add to that?
- 13 A. No, sir.
  - Q. Okay. So the family is here seven months

- 15 after their little boy died in your pool and all you
- 16 have to say about what happened to their boy to give
- 17 them answers that they need is I can't tell you
- 18 because the lawyers did it? Is that essentially your
- 19 answer?
- 20 MR. SNYDER: Objection, form.
- 21 A. I can only say that I don't know.
- 22 Q. (BY MR. MARRS) What did you do as the
- 23 general manager of the Houston Racquet Club to learn
- 24 for yourself what happened to this little boy?
- A. Of course, I immediately spoke with 0009
- 1 Guillermo and David. In fact, I was present -- I was
- 2 present at the time that John was -- that John was
- 3 pool side.
- 4 Q. Yes, sir.
- 5 A. We talked about it extensively and guite
- 6 honestly could come up with no conclusion as to what 7 happened.
- 8 Q. And that was before the Gardere Wynne firm
- 9 was hired, correct? You said immediately?
- 10 A. Yes.
- 11 Q. So after you talked to Guillermo Palmer and
- 12 David Lamkin and others that day before you hired
- 13 Gardere Wynne, what was your understanding of what
- 14 happened to this little boy in your pool?
- 15 A. Only that he drowned.
- 16 Q. Did you investigate as general manager of
- 17 this club exactly where this little boy was when he
- 18 was found in the pool?
- 19 A. No, I did not.
- 20 Q. Was that not important for you as general
- 21 manager to know?
  - MR. SNYDER: Objection, form.
- 23 A. It's important to know and I would have
- 24 liked to have known, but the facts weren't available
- 25 to me at that time.

- 1 Q. (BY MR. MARRS) What was John -- and when I
- 2 say "John," I'm referring to John Pluchinsky, the
- 3 four-year-old son of the Pluchinskys. What was he
- 4 doing prior to getting into the pool on July 18th?
- 5 A. I don't know specifically.
- 6 Q. Was he jumping prior to getting in the pool,
- 7 to your knowledge?
  - A. I have no knowledge.

- 9 Q. Was he eating before he got into the pool?
- 10 A. It was reported to me later that John had
- 11 had lunch, yes. I didn't personally observe it.
- 12 Q. Was he tired prior to getting into the pool?
- 13 A. I don't know.
- 14 Q. Did he fall into the pool?
- 15 A. I don't know.
- 16 Q. Did he get a cramp before he got into the
- 17 pool?
- 18 A. I don't know.
- 19 Q. Did he step off the ledge on the northwest
- 20 side of the pool?
- 21 A. I don't know.
- 22 Q. Did he walk down the steps on the west side
- 23 of the pool to get in the water at any time on that
- 24 day?
- 25 A. I don't know.

- 1 Q. Did he walk down the steps on the southside
- 2 of the pool to get into the pool that day?
- 3 A. I don't know.
- 4 Q. Did he walk down through the beach area, the
- 5 zero depth area right there to get in the family
- 6 pool?
- 7 A. I don't know.
- 8 Q. Did he play dead man's float game while he
- 9 was in the pool that morning?
- 10 A. I don't know.
- 11 Q. Do you know what that game is?
- 12 A. Yes, I do.
- 13 Q. Tell the jury what that is.
- 14 A. The way I understand it, it's a game where
- 15 children float facedown in the water and just stare
- 16 at the bottom or listen to the sounds of the water.
- 17 what have you. I have observed children doing that
- 18 in the pool.
- 19 Q. How many times?
- 20 A. I don't know.
- 21 Q. A number of times?
- 22 A. Any number of times, yes.
- Q. Okay. And do they do it often in the family 24 pool?
- 25 A. I can't say what often is.

- 1 Q. Well, how many times have you seen that
- 2 occur, numerous occasions, more than five, more than

- 3 20, more than 30? Give me just a guesstimate.
- 4 A. I can't estimate.
- 5 Q. Okay. Numerous times?
- 6 A. I suppose.
- 7 Q. Okay. And when you would see that
- 8 happening, what would you do?

- 5 a non-camper close to John when he was found?
- A. Non-camper being a counselor, yes. Otherthan that, I don't know.
- 8 Q. Okay. And I mean a non-camper child, an
- 9 older child. Was there one close to John when he was
- 10 found, to your knowledge, that was not a counselor or
- 11 a lifeguard?
- 12 A. Not to my knowledge.
- 13 Q. But you don't know either way, do you?
- 14 A. No, I do not.
- 15 Q. How long was John unattended before he was
- 16 found unconscious floating facedown in the water?
- 17 MR. SNYDER: Objection, form.
- 18 A. I have no way to determine that.
- 19 Q. (BY MR. MARRS) Have you tried to determine 20 that?
- 21 A. I've thought about it a great deal, but I
- 22 have no way to determine it.
- 23 Q. And in thinking of that a great deal, did
- 24 you conclude that it was at least "X" number of
- 25 minutes?

- A. Define "X".
- Q. Well, that's what I'm asking you to define.
- 3 Did you make a conclusion that he was at least
- 4 unattended for a certain amount of time?
- 5 MR. SNYDER: Objection, form.
- 6 Q. (BY MR. MARRS) Whether it was five minutes,
- 7 15 minutes, 20 minutes?
- 8 MR. SNYDER: Objection, form.
- 9 A. That would be speculation and guessing on my
- 10 part. I can't do that.
- 11 Q. (BY MR. MARRS) Well, how did John even get
- 12 to where he was found?
- 13 A. Be more specific, please.
- 14 Q. Sure. At some point John Pluchinsky was
- 15 placed down in the pool by a counselor; is that your
- 16 understanding?

- 17 A. My understanding, he was part of the
- 18 four-year-old group who was in the pool at that
- 19 time. I have no knowledge as to how he actually
- 20 entered the pool or who he was in contact with.
- 21 Q. And from the last time and last place that
- 22 he was seen by a counselor or a lifeguard alive in
- 23 the pool, it is your understanding that he was not in
- 24 that same place when he was found floating; isn't
- 25 that true?

- 1 A. I have no idea.
- 2 Q. You haven't investigated that to learn for
- 3 yourself as a concerned general manager of the
- 4 Racquet Club exactly how long he was unattended,
- 5 exactly where he was found, exactly where he was last
- 6 seen before he was found, any of those things you
- 7 just don't know?
  - MR. SNYDER: Objection, form.
- 9 A. I didn't personally conduct interviews with
- 10 any of the counselors.
- 11 Q. (BY MR. MARRS) You immediately spoke to
- 12 Guillermo Palmer, David Lamkin. Didn't you ask some
- 13 of those questions when you did that?
- 14 A. Yes.
- 15 Q. What did you learn?
- 16 A. I didn't learn anything from them.
- 17 Q. They didn't know either, did they?
- 18 A. I'll let them answer for themselves.
- 19 Q. When you talked to them on that day
- 20 immediately, did they tell you any of those things?
- 21 A. No.
- 22 Q. Did you ask them any of those things?
- 23 A. We were simply talking and speculating, but
- 24 we had no -- we had no firm knowledge of anything.
- 25 Q. Did you ask Mr. Palmer how did this happen? 0017
- 1 A. In so many words, yes.
- 2 Q. And what was his response?
- 3 A. He didn't know.
- 4 Q. Did you ask Mr. Lamkin how did this happen
- 5 in so many words as well?
- 6 A. Yes.
- 7 Q. What was his response?
- 8 A. He didn't know either.
- 9 Q. Did you ask anybody else on that day
- 10 immediately after the incident, "What happened?"

- 11 A. No.
- 12 Q. Why not?
- 13 MR. SNYDER: Objection, form.
- 14 A. I don't know. I just didn't.
- 15 Q. (BY MR. MARRS) Well, who -- certainly you
- asked who was responsible for watching John at thetime he drowned, didn't you?
- 18 A. We discussed the -- some of the people that
- were part of the group and part of the lifeguardgroup.
- 21 Q. Okay. Well, tell me, who is the one
- 22 specific person that John was assigned to that was
- 23 supposed to be watching him at the time he drowned.
- 24 Give me their name.
- 25 MR. SNYDER: Objection, form.

- A. My understanding was that John was part of a counselor group and that the counselors as a group were responsible for watching the children.
- 4 Q. (BY MR. MARRS) So are you saying that there
- 5 was no specific person that was given the specific
- 6 responsibility to watch this one four-year-old child;

- 8 A. That's my understanding.
  - Q. So, the entire group of counselors,
- 10 four-year-old boy counselors were supposed to watch
- 11 the entire group of four-year-old boys; is that

- 18 Q. So if I ask you, which counselors allowed

- 19 him to venture into water unsupervised where he could
- 20 not stand and breathe, you would know exactly which
- 21 counselors those were, wouldn't you?
- 22 MR. SNYDER: Objection, form.
- 23 A. I could name the people in the pool.
- 24 Q. (BY MR. MARRS) Okay. Tell me which ones
- 25 they were. Which counselors?

- 1 A. Okay. 4 y/o B-CC #2.
- 2 Q. Yes, sir.
- 3 A. 4 y/o B-CC #6, 4 y/o B-CC #5, Supv CC #2,
- 4 4 y/o B-CC #3, 4 y/o B-CC #4.
- 5 Q. Yes, sir.
- 6 A. Those are the only names I can recall at the
- 7 moment.
- 8 Q. Supv CC #1?
- 9 A. Supv CC #1, yes.
- 10 Q. 4 y/o B-CC #1?
- 11 A. Yes.
- 12 Q. Another one?
- 13 A. 4 y/o B-CC #1, yes.
- 14 Q. Now, I count eight that you have named so
- 15 far. Is that all of them?
- 16 A. Yes, that's correct.
- 17 Q. Okay. So all of the counselors you just
- 18 mentioned were responsible to closely -- closely
- 19 supervise John Pluchinsky the morning he died,
- 20 correct?
- 21 A. Supv CC #2 and 4 y/o B-CC #3 were super -- were
- 22 counselor supervisors in charge of all the counselors
- 23 in the pool and in the area that day. The other six
- 24 were counselors directly assigned to the
- 25 four-year-old boys.

- 1 Q. Supv CC #2 and who else?
  - A. 4 y/o B-CC #3.

- 9 that back. I would need to -- I would need to review
- 10 the file.
- 11 Q. And so, I guess what you're saying is that
- 12 on July 18, 2007 you think that Guillermo Palmer did

- 13 an exemplary job in his role at the Houston Racquet
- 14 Club; is that correct?
- 15 A. I think he was performing his job
- 16 satisfactorily.
- 17 Q. And you would say the same about David
- 18 Lamkin?
- 19 A. Yes, I would.
- 20 Q. And you would say the same about
- 21 4 y/o B-CC #2?
- A. I have no knowledge of 4 y/o B-CC #2 's
- 23 performance.
- 24 Q. You have no criticisms of Guillermo Palmer
- 25 in his job performance before or leading up to or 0048
- 1 through July 18th, 2007, correct?
- A. There are incidents where each of my
- 3 department heads don't perform according to my
- 4 expectations or the expectations of members. That's
- 5 not true just of Guillermo. That's true of everyone.
- 6 Q. But relating to safety and John Pluchinsky's
- 7 death, it's your opinion that David Lamkin and
- 8 Guillermo Palmer performed their job satisfactory up
- 9 to and including July 18th, 2007, correct?
- 10 A. Yes, that's correct.
- 11 Q. Same for 15 y/o LG #1?
- 12 A. I have no knowledge of 15 y/o LG #1 's
- 13 performance.
- 14 Q. Did you ask?
- 15 A. No.
- 16 Q. How about 15 y/o LG #2?
- 17 A. I don't know anything about 15 y/o LG #2's
- 18 performance.
- 19 Q. Did you ask?
- 20 A. Guillermo stated that both of those
- 21 lifeguards were very good and very capable in their
- 22 positions. I have no firsthand knowledge, though.
- 23 Q. Let's look at Exhibit Number 2. And the
- 24 name 4 y/o B-CC #2 is a little bit cut off at the
- 25 top.
- 0049
- 1 A. Okay.
- 2 Q. But have you seen this document before?
- 3 A. I read it once a couple months ago.
- 4 MR. MARRS: Can you go down to the
- 5 lower part of the document? Thank you.
- 6 Q. (BY MR. MARRS) Now, 4 y/o B-CC #2 was one

- 7 of the counselors that was responsible for watching
- 8 John Pluchinsky, correct?
- 9 A. Yes.
- 10 Q. And she states in her statement that, "I had
- 11 been playing with John earlier and he was perfectly
- 12 okay. Then, about" I think she says "10 to
- 13 15 minutes later was when we saw him." And my
- 14 question is: Who saw John during that 10 or
- 15 15 minutes after 4 y/o B-CC #2 finished playing with
- 16 John?
- 17 A. I don't know.
- 18 Q. Was 4 y/o B-CC #2 the last person to see
- 19 John alive?
- 20 A. I have no knowledge of that.
- 21 Q. Did 4 y/o B-CC #2 place John down somewhere
- 22 in the pool after she finished playing with him?
- 23 A. I have no knowledge of that.
- 24 Q. Well, who does? Who knows that?
- A. Perhaps the counselors that were in the 0050
- 1 water with the children.
- 2 Q. 4 y/o B-CC #2 would know that, wouldn't
- 3 she?
- 4 MR. SNYDER: Objection, form.
- 5 A. I can't conclude that.
- 6 Q. (BY MR. MARRS) 4 y/o B-CC #2 would know
- 7 whether or not she placed John down in the pool after
- B playing with him, right?
- 9 A. Yes, she would.
- 10 Q. Did she turn her back on John and walk away
- 11 and not look back at John for some 10 or 15 minutes?
- 12 A. I have no way of knowing that.
- 13 Q. You do have a way because you could ask
- 14 4 y/o B-CC #2 if you cared to, correct, sir?
- 15 A. She was interviewed.
- 16 Q. Yes. Were you there?
- 17 A. No, I was not.
- 18 Q. If you cared to ask her yourself, you could,
- 19 couldn't you, sir?
- 20 A. Yes, I could have.
- 21 Q. But you didn't, did you?
- 22 A. No. I left it to others.
- 23 Q. To who?
- 24 A. Gardere Wynne interviewed 4 y/o B-CC #2.
- 25 Q. Who with --

- 1 A. The Family Protective Services interviewed
- 2 4 v/o B-CC #2.
- 3 Q. Who with Gardere Wynne?
- A. Mike Wall, Audrey Momanee.
- 5 Q. When?
- 6 A. I don't know for sure which day. Within the
- 7 days following the drowning.
- 8 Q. Were you at the club when these kids were
- 9 interviewed?
- 10 A. I was at -- in the club, yes.
- 11 Q. Okay. And did all the interviews of the
- 12 kids, the counselors and lifeguards, occur at the
- 13 club?
- 14 A. To the best of my knowledge, yes.
- 15 Q. Where at the club?
- 16 A. In a private room.
- 17 Q. Which private room?
- 18 A. I believe those were conducted in the garden
- 19 room, but I can't say for sure.
- 20 Q. Where is that?
- 21 A. The lower floors of the club.
- 22 Q. In what building?
- 23 A. The main clubhouse.
- 24 Q. And were they -- was more than one counselor
- 25 or lifeguard interviewed at the same time or were 0052
- 1 they interviewed separately?
- 2 A. I believe they were interviewed separately.
- Q. How long did these interviews last
- 4 typically?
- 5 A. I don't know that.
- Q. Were you present during any of the
- 7 interviews of the counselors or lifeguards?
- 8 A. No, I was not.
- 9 Q. Who else was, other than the two Gardere
- 10 Wynne lawyers?
- 11 A. Perhaps a claims adjuster, if I'm not
- 12 mistaken.
- 13 Q. From?
- 14 A. York, York Claims Services.
- 15 Q. And who else, to your knowledge?
- 16 A. As far as I know, no one else was present.
- 17 Q. Was 4 y/o B-CC #2 piggybacking John
- 18 Pluchinsky before she placed him down in the pool?
- 19 A. May I read her statement again, please?
- 20 Q. Of course.

- 21 MR. MARRS: Why don't you show him the 22 top half so he can read it.
- 23 MR. PLETCHER: Sure. What do we need?
- 24 MR. MARRS: He just wants to read the
- 25 whole statement. Keep going up so he can read the 0053
- 1 rest.

- THE WITNESS: Move it up, please. Is
- 3 there anything on the back? That's it?
  - MR. MARRS: That's it.
  - THE WITNESS: Okay.
- 6 A. Your question again, please.
  - Q. (BY MR. MARRS) Have you seen any document
- 8 where 4 y/o B-CC #2 indicates that she piggybacked
- 9 John Pluchinsky before she set him down in the pool?
- 10 A. No, I have not.
- 11 Q. And the interviews you just testified about
- 12 that you believe occurred at the Racquet Club of the

- 14 where the statements were taken by the counselors and

- 16 A. Which statements are those, please?
- 17 Q. Statements such as the one you're looking
- 18 at, Exhibit 2, statements of the counselors and
- 19 lifeguards that are handwritten.
- 20 A. No. David would have to speak to where
- 21 those were actually taken.
- 22 Q. Okay. So what are you referring to that
- 23 occurred in the garden room?
- 24 A. That's the interviews by the attorneys.
- Q. Okay. Did those lawyers at Gardere Wynne 0054
- 1 take any statements of the counselors or lifeguards
- 2 during those meetings in the garden room, to your
- 3 knowledge?

- A. I have no knowledge.
- 5 Q. Are you aware of where the kids, counselors
- 6 and lifeguards, were when they gave their handwritten
- 7 statements, such as Exhibit 2?
- 8 A. David Lamkin can respond to that.

- 11 Q. Have you seen any statement of any counselor

- 24 A. No.
- 25 Q. Let's go to Exhibit 3. Now, this is a 0055
- 1 Supervisor's Investigation of Accident signed off on
- 2 by 15 y/o LG #1 on the bottom. Have you seen this
- 3 document before?
- 4 A. No, I don't believe I have.
- 5 Q. Let's go to the second page, which is a
- 6 handwritten statement by 15 y/o LG #1.
- 7 A. What is the source of this handwritten
- 8 statement, please?
- 9 Q. It's from the Racquet Club as being
- 10 15 y/o LG #1 handwritten statement attached to her
- 11 investigation report.
- 12 A. Okay.
- 13 Q. 15 y/o LG #1 states, "I got on the stand at
- 14 11:00 o'clock and was efficiently scanning the pool.
- 15 All of the kids were playing happily. At around
- 16 11:15 I noticed the victim facedown in the pool. At
- 17 first glance, he seemed to be playing, but when I
- 18 looked back a few seconds later, he still hadn't
- 19 moved."
- 20 Now, is it your understanding that
- 21 15 y/o LG #1 saw John Pluchinsky facedown in the
- 22 water, turned away to continue scanning the pool and
- 23 then at some point turned back to him and noticed
- 24 that he was still motionless; is that your
- 25 understanding?

- 1 A. It seems to me that that's what she's
- 2 saying, yes.
- 3 Q. Okay. So she saw him not once, but twice
- 4 floating facedown in the pool, at least according to
- 5 her statement, correct?
- 6 A. My understanding is that when she saw him
- 7 the second time, she reacted immediately.
  - Q. And that's my question. She saw him not

- 9 once, but twice floating facedown in the pool. The
- 10 second time is when you say she did something, right?
- 11 A. According to her statement, that's how I 12 interpret it, yes.
- 13 Q. And how many seconds did it take for 15 y/o LG #1
- 14 to see him floating facedown the first time and for
- 15 15 y/o LG #1 to then scan the pool again and then for her to
- 16 look back to see John floating again?
- 17 A. I have no --

- 19 A. -- knowledge of that.

- 8 think that's an appropriate course of conduct for a
- 9 lifeguard?
- 10 MR. SNYDER: Objection, form.
- 11 A. I can't comment.
- 12 Q. (BY MR. MARRS) Well, do you just out of
- 13 common sense believe that if you see a child,
- 14 especially a small child, facedown in the water not
- 15 moving, you should take immediate action to get him
- 16 out of the water?
  - MR. SNYDER: Objection, form.
- 18 Q. (BY MR. MARRS) Do you agree with that
- 19 statement?
- A. I would hope that the lifeguard would use -- 21 would use appropriate judgment in that case.
- 22 Q. (BY MR. MARRS) In that case do you believe
- 23 that the lifeguard should immediately -- immediately
- 24 get that child out of the water instead of continuing
- 25 to scan the pool?
- 0058

- 1 MR. SNYDER: Objection, form.
- 2 A. Not necessarily.

- 3 Q. (BY MR. MARRS) Why?
- 4 A. Children play in that way as we have
- 5 discussed earlier.

- 17 have seen of counselors and lifeguards that 4 y/o B-CC #3
- 18 was not the only person, not the only counselor who
- 19 when seeing John floating facedown in the water
- 20 motionless did not believe that that meant he was
- 21 doing anything other than playing, correct, sir?
- A. I would need to see those statements again, sir.
- Q. I mean, you know for a fact the reason why because he was floating facedown in the water is because he 0064
- 1 was dying, don't you?
- 2 MR. SNYDER: Objection, form.
  - Q. (BY MR. MARRS) Isn't that the conclusion
- 4 that you've reached? Isn't that common sense?
- 5 A. We know after the fact that he was in
- 6 distress.
  7 Q. But 4 v/o B-CC #3 didn't recognize the
- Q. But 4 y/o B-CC #3 didn't recognize that, did he?
   A. Not until that moment, no.
- 9 Q. Not until he turned him over, right, sir? I
- 10 mean, he says it himself in his statement, right,
- 11 sir?

- 13 Q. Do you believe that a counselor seeing a kid
- 14 floating facedown in the water motionless and
- 15 reacting that, nah, he's probably just playing is an
- 16 appropriate response?

- 18 Q. (BY MR. MARRS) For someone that is tasked
- 19 with protecting the lives of children in the pool?
  - MR. SNYDER: Objection, form.
- 21 Q. (BY MR. MARRS) Is that appropriate, do you 22 think?
- 23 MR. SNYDER: Objection, form.
- A. I can't comment on the state of mind of the counselor.

- 1 Q. (BY MR. MARRS) I'm talking about your state
- 2 of mind. Do you think that's appropriate?
- 3 MR. SNYDER: Objection, form.
- 4 A. I don't know. It depends on the

5 circumstances.

Q. (BY MR. MARRS) Well, if you turn him over
and he turns out to be alive and playing, then in
that circumstance I guess it's okay. If he turns out

- 18 A. Perhaps more. I don't remember exactly what
- 19 her certification date was.
- 20 Q. And who was responsible for scanning east of
- 21 the ropes or the rope that divided the shallow and
- 22 deep, as you say? 23
  - A. 15 y/o LG #2.
- 24 Q. And his responsibility was to solely focus
- 25 on the area east of the buoy rope that was in the 0070
- 1 immediate vicinity of the slide; is that correct?
  - MR. SNYDER: Objection, form.
  - That was his primary area of responsibility.
- 4 Q. (BY MR. MARRS) And to watch the kids as
- they go up the slide or -- as they step up on the
- ladder up to the slide? 6
- 7 A. His most important responsibility was to
- watch the kids as they came out of the flume.
- 9 Q. Okay. But wasn't it his responsibility to
- 10 make sure that no more than one went down at the same
- 11 time?

12 A. Yes.

- Q. And he wouldn't know that unless he had to 13 14 also watch up there at the top of the stair to make 15 sure that he told them to wait so that more than one 16 wouldn't go down at the same time, right? 17 A. Yes, that was another responsibility. Q. Sure. Okay. And his responsibility was to 18 19 watch them climb -- the kids climb up the stairs to 20 go up to the slide, right, to make sure they did it 21 safely? 22 A. He would observe that as well, yes. 23 Q. Okay. And that's exactly what he was 24 focused on on July 18th at the specific time that he 25 looked over and saw John Pluchinsky; is that correct? 0071 1 MR. SNYDER: Objection, form. 2 A. I have no way of knowing that. 3 Q. (BY MR. MARRS) Well he said that, in 4 looking at Exhibit 3B, that, "I stopped the kid on 5 the slide for a moment." So he was watching the kids 6 on the slide and actually stopped one at the time 7 that 15 y/o LG #1 discovered John Pluchinsky in the 8 pool floating facedown, correct? Is that your 9 understanding from his statement? A. From his statement, yes. 10 11 Q. Now, let's look at Exhibit 4, a handwritten 12 statement by 4 y/o B-CC #1. 13 MR. SNYDER: Can you see that? THE WITNESS: No, not --14 15 MR. PLETCHER: I'm going to scan it. 16 THE WITNESS: Okay. 17 MR. PLETCHER: Do you see her name 18 there, sir? 19 THE WITNESS: Yes, I do. 20 MR. PLETCHER: Okay. I'm going to 21 scoot it up. 22 Q. (BY MR. MARRS) And on the top she says, "I 23 was in the shallow end of the pool around the 24 toys..." What do you understand that to mean? The water features. 25 0072
- 1 Q. In the beach area?
- 2 A. Yes, sir.
- 3 Q. "...with three little boys, one on my back."
- 4 What's your understanding of who the three boys were
- 5 that she was with?
- 6 A. I have no knowledge of that.

- 7 Q. Well, you've read this statement before,
- 8 haven't you?
- 9 A. Yes, but it's been sometime.
- 10 Q. Well, even if it's been sometime, did you
- 11 ask at that time who the three boys were that she was
- 12 with?
- 13 A. I didn't interview 4 y/o B-CC #1.
- 14 Q. Have you asked anybody who the three boys
- 15 were that she's referring to in Exhibit 4?
- 16 A. No, I did not.
- 17 Q. Okay. Is it your understanding that one of
- 18 the boys that she was with was John Pluchinsky?
- 19 A. No. I don't have that understanding.
- 20 Q. What is your understanding, that John
- 21 Pluchinsky was not one of the three boys she's
- 22 referring to?
- 23 A. I have no knowledge one way or the other.
- 24 Q. Okay. Well, she says that, "I heard the
- 25 lifeguard running and asking if that boy was okay. 0073
- 1 My back was to him." Right?
- 2 A. Okav.
- 3 Q. So 4 y/o B-CC #1 is saying that her back was
- 4 turned away from John Pluchinsky, correct?
- 5 A. Okay.
- 6 Q. Right?
- 7 A. I under -- that's how I understand her
- 8 statement, yes.
- 9 Q. And we saw 4 y/o B-CC #2 's statement
- 10 earlier where she said she turned and walked back to
- 11 where she was. Did you see that?
- 12 A. I don't recall from 4 y/o B-CC #2 's statement where
- 13 she said she turned and walked back to where she
- 14 was.
- 15 Q. Is it your --
- 16 A. Perhaps we need to review the statement
- 17 again.
- 18 Q. Is it your understanding that 4 y/o B-CC #2
- 19 was not looking at John Pluchinsky during the 10 or
- 20 15 minutes that she refers to in her statement? Is
- 21 that your understanding?
- 22 A. I would -- I would -- yeah, I would
- 23 interpret that as that.
- 24 Q. Okay. So neither 4 y/o B-CC #2 nor 4 y/o B-CC #1
- were watching John Pluchinsky at the time he 0074

- 1 was discovered floating. Is that your conclusion
- 2 from those two statements?
- 3 A. Yes.

4 Q. Let's go to the second page, if we could.

MR. PLETCHER: Sure.

- 6 Q. (BY MR. MARRS) At the end of her statement, 7 she says, "I am so sorry for letting this happen and 8 not being more responsible", right, sir?
- 9 A. That's what I'm reading, yes.
- 10 Q. Was she one of the counselors that at that
- 11 particular moment in time was responsible for
- 12 protecting John Pluchinsky?
- 13 A. Yes, she was.
- 14 Q. And as we sit here today, you can't think of
- 15 anything that she could have done better on that day;
- 16 is that correct?
- 17 MR. SNYDER: Objection, form.
- 18 A. No
- 19 Q. (BY MR. MARRS) Is that correct?
- 20 A. That's correct, yes.
- 21 Q. Let's go to Exhibit 5. Exhibit 5 is a
- 22 Supervisor's Investigation of Accident, signed off on
- 23 by Sr LG #1. And you know who she is, don't
- 24 you?
- 25 A. Yes.

- 1 Q. Tell the jury who she is.
  - A. She's one of the head lifeguards.
- 3 Q. One of the head lifeguards. Now, as a head
- 4 lifeguard, what does that mean?
- 5 A. A lifeguard that's in charge of a particular
- 6 area on a particular shift.
- 7 Q. And do they then have to have a certain
- 8 amount of maturity in order to have that position?
- 9 MR. SNYDER: Objection, form.
- 10 A. I would let David or let Guillermo Palmer
- 11 respond to how he appoints people to head lifeguard
- 12 position.
- 13 Q. (BY MR. MARRS) Okay. Well, as general
- 14 manager of the Houston Racquet Club, what's your
- 15 understanding of why someone becomes a head lifeguard
- 16 versus just a regular lifeguard?
- 17 A. If I were appointed with that position I
- 18 would look for somebody with experience and maturity.
- 19 Q. With good judgment?
- 20 A. Yes.

- 21 Q. Okay. And here where she says, "Camp
- 22 counselors" -- and she's responding to an inquiry on
- 23 this form. The inquiry says, "What action has been
- 24 or should be taken to prevent a similar accident?"
- 25 And what does she write, this girl with good 0076
- 1 judgment? What does she write?
- 2 A. "Camp counselors need to pay more attention
- 3 to the campers as well as the guards."
- Q. Okay. So do you disagree with head
- 5 lifeguard Sr LG #1, who was there on that day
- 6 when she makes that statement?
  - MR. SNYDER: Objection, form.
- 8 A. I can't speak to Sr LG #1 's proximity to any
- 9 of the incidents that day. I don't know whether
- 10 she's capable of making a judgment or not.
- 11 Q. (BY MR. MARRS) Well, you know for a fact
- 12 that Sr LG #1 was working there on that day,
- 13 don't you?

- 14 A. I believe she was, yes.
- 15 Q. Uh-huh. And is it your understanding that
- 16 after the whistle blew, that Sr LG #1 went
- 17 right to the pool where John Pluchinsky was?
- 18 A. I don't recall.
- 19 Q. Okay. From everything you've learned about
- 20 what happened on July 18, 2007, do you have any
- 21 reason to agree or disagree that -- Sr LG #1
- 22 when she says that camp counselors need to pay more

- 24 A. I don't know why she would make that
- 25 statement.

- 1 Q. My question is: Based on everything that
- 2 you know seven months, nine days after this horrible
- 3 event, do you have any reason to agree or disagree
- 4 with what she says when she says, "Camp counselors
- 5 need to pay more attention to their campers"?
- 6 A. I can neither agree nor disagree with that.
- 7 Q. Okay.
- 8 A. I don't know her point of perspective.
- 9 Q. Okay. And did the eight counselors that you
- 10 identified earlier who were responsible for watching
- 11 John pay attention, constant attention to John
- 12 Pluchinsky while he was in the pool?
- 13 A. I don't know that.
- 14 Q. You don't know one way or the other,

24 on facts that she was aware of about how your summer
25 camp was being run, do you? You don't know one or

      Q. But plenty of other people did, didn't they?

      A. Not with regard to the counselors, sir.

7 has LG Supv name on it. Let's go to the8 bottom of that first page so we can see that

- 9 Exhibit 5B.
- 10 MR. MARRS: Can you flip to the second
- 11 page?
- MR. PLETCHER: (Complies.)
- 13 Q. (BY MR. MARRS) Now, who is LG Supv?
- 14 A. He's a lifeguard supervisor.
- 15 Q. And was he acting as a lifeguard supervisor
- 16 on the day of John Pluchinsky's death?
- 17 A. Yes, he was.
- 18 Q. Was he "the" lifeguard supervisor on that
- 19 day or were there more than one for the family pool?
- 20 A. I believe LG Supv was the sole lifeguard 21 supervisor.
- 22 Q. Okay. And as a matter of fact, he states,
- 23 "I was supervisor for the shift. I was eating lunch
- 24 at the pavilion when some people ran up asking
- 25 frantically for help."

- Do you know why the people were running around frantically asking for help at your club when this drowning occurred?
- 4 A. No. I can't speak to that.
- Q. Do you know whether or not your counselorsand lifeguards had regular drills for emergenciessuch as this?
- 0 4 N 1 1 1 1 1
- 8 A. No. I don't know that for a fact.
- 9 Q. Well, do you know for a fact that they did
- 10 not or you just don't know one way or the other?
- 11 A. I don't know one way or the other.
- 12 Q. Is that something that is very important as
- 13 a general manager of a club that accepts hundreds of
- 14 children into its waters during even one summer?
- 15 MR. SNYDER: Objection, form.
- 16 Q. (BY MR. MARRS) Is that important for you to
- 17 know?
- 18 A. I would -- I would want to be confident that
- 19 my supervisory staff was addressing that, my
- 20 department heads.
- 21 Q. And was preparing its lifeguards and
- 22 counselors for emergencies, correct?
- 23 A. Yes.
- 24 Q. And having emergency drills so that they
- would not be frantic, but instead would know how to 0081
- 1 handle emergencies, right, sir?
- 2 MR. SNYDER: Objection, form.

- 3 A. I guess that's correct, yes.
- 4 Q. (BY MR. MARRS) And at the bottom here of
- 5 Exhibit 5B, he writes some times here and he says
- 6 that, "11:00 to 11:05, went with three guards to get
- 7 lunch." Do you see that?
- 8 A. Yes, I do.
- 9 Q. Now, so this indicates that the lifeguard
- 10 supervisor that was supposed to be supervising the
- 11 lifeguards at this time was off to lunch with three
- 12 other lifeguards. Is that what that indicates to
- 13 you?
- 14 MR. SNYDER: Objection, form.
- 15 A. The way I read it, they went from 11:00 to
- 16 11:05 and it appears that they were back before the
- 17 time of the accident.
- 18 Q. (BY MR. MARRS) Back where?
- 19 A. To the pavilion, which is the area adjacent
- 20 to the resort pool.
- 21 Q. Were they back watching children in the
- 22 family pool?
- 23 A. No. They were on -- they were on break.
- 24 Q. Okay. So still, even as of the time of John
- 25 Pluchinsky's death, Number 1, there were at least 0082
- 1 four lifeguards, including a supervising lifeguard,
- 2 LG Supv, on break, correct?
- 3 A. That's correct and three on duty.
- 4 Q. Well, you don't mean to suggest there were
- 5 three on duty at the family pool, do you?
- 6 A. No. I suggest that there were three on duty 7 at the --
- 8 Q. Okay.

- 9 A. -- altogether two at the resort pool.
- 10 Q. Two at the resort pool. But not a
- 11 supervising lifeguard, correct?
- 12 A. That's correct.
- 13 Q. And not any adult lifeguard, correct?
- 14 A. Not in the immediate proximity of the resort 15 pool, no.
- 16 Q. Well, if someone is dying in your resort
- 17 pool, you want to make sure they are in the immediate
- 18 proximity of the pool, don't you?
  - MR. SNYDER: Objection, form.
- 20 A. I don't choose to answer that.
- 21 Q. (BY MR. MARRS) It's important for your club
- 22 to have sufficient number of lifeguards to adequately

- 23 scan the pool, protect the number of children that
- 24 are in it and of course, to be in very close
- 25 proximity to the children that are in the pool. You 0083
- 1 agree with that, don't you?
- 2 A. I do.
- 3 Q. But of course, on this instance there were
- 4 two 15-year-old lifeguards watching the entire family
- 5 pool of campers, counselors and others that were in
- 6 that family pool at approximately 11:10, 11:15, July
- 7 18th when this incident occurred, correct?
- A. That's correct.
- 9 Q. Do you think that's enough?
- 10 A. Yes, I do.
- 11 Q. Why?
- 12 A. Two lifeguards are adequate to scan -- to
- 13 fully scan the pool and the bather load was not that
- 14 great. It was less than one per 25, which is a --
- 15 which is a perfectly reasonable level for each
- 16 lifeguard.
- 17 Q. If the lifeguard is doing their job properly
- 18 and adequately, correct?
- 19 A. Yes.
- 20 Q. And you say two lifeguards is enough to
- 21 adequately scan the family pool, but you know that
- 22 two lifeguards were not scanning the entire family
- 23 pool, correct, at the time of this incident?
- 24 MR. SNYDER: Objection, form.
- A. No, I don't agree with that.
- 1 Q. (BY MR. MARRS) Okay. So now your testimony
- 2 is that 15 y/o LG #2 was scanning the entire family
- 3 pool at the time that John Pluchinsky drowned?
- 4 A. Between the two of them, they were scanning
- 5 the entire family pool, which is the way the zones
- 6 are set up.
- 7 Q. Okay. So back to my question. You're not
- 8 testifying that two lifeguards were scanning the
- 9 entire pool, that both of them were scanning the
- 10 entire pool, are you?
- 11 A. No, I'm not saying that.
- 12 Q. Okay. That's what I was asking.
- 13 A. Okay. I apologize.
- 14 Q. So really, you had one 15-year-old girl,
- 15 15 y/o LG #1, that was responsible for scanning the
- 16 pool from the rope floated line that was over by

- 17 the -- adjacent to the slide, all the way from that
- 18 to the left to the west, all the way passed the beach
- 19 area where all the toys, the sprinklers, the portion
- 20 even across from that pool that had the fountains,
- 21 all the way to the west side, she was responsible for
- 22 scanning all of that, correct?
- 23 A. Yes, that's correct.
- Q. And only 15 y/o LG #1 was responsible for
- 25 scanning that entire area, correct, sir? 0085
- 1 A. That was her primary area of responsibility, 2 ves.
- 3 Q. How many other clubs had 15 y/o LG #1 been a 4 certified lifeguard at?
- 5 A. I have no knowledge, but I believe she was 6 just recently certified.
- 7 Q. Was she the best lifeguard you had at that 8 time?
- 9 A. I couldn't say that one way or the other.
- 10 Q. But what you can say is that when John
- 11 Pluchinsky died, at least according to what the
- 12 supervising lifeguard says, four guards were off, two
- 13 on break away from the family pool not scanning the
- 14 family pool, correct?
- 15 A. That's correct.
- 16 Q. And where was Guillermo Palmer at this point
- 17 in time?
- 18 A. I'm not sure exactly where Guillermo was. I
- 19 think you should ask him.
- 20 Q. Well you know for a fact, though, without me
- 21 asking him, that he was not at the pool, don't you?
- 22 A. No, that's correct.
- 23 Q. You weren't at the family pool, were you?
- 24 A. No, sir, I was not.
- 25 Q. David Erck wasn't at the family pool, was 0086
- 1 he?
- 2 A. I don't know that for a fact.
- Q. David Lamkin wasn't at the family pool, was
- 4 he?
- 5 A. No, I don't believe he was.
- Q. No one but two 15-year olds and counselors?
- 7 MR. SNYDER: Objection, form.
- 8 Q. (BY MR. MARRS) Two 15-year-old lifeguards 9 and counselors, correct --
- 10 MR. SNYDER: Objection, form.

- 11 Q. (BY MR. MARRS) -- that worked for the
- 12 club? Those were the only people at the family pool
- 13 at the time John drowned, correct?
- 14 MR. SNYDER: Objection, form.
- 15 A. I can't confirm that those were the only 16 people.
- 17 Q. Well, let's look at Exhibit 6. And I think
- 18 you said before that the -- you believe that John's
- 19 four-year-old boy group arrived at the family pool at
- 20 approximately 10:45.
- 21 A. That's what was reported to me, yes.
- 22 Q. Okay. And as we look at Exhibit 6, this is
- 23 a Houston Racquet Club Kids Camp News four-year-old
- 24 Boy Week Number 5 Schedule, right, sir?
- 25 A. Yes, that's correct.

9

- 1 Q. And the -- You had previous weeks that were
- 2 really focused more on swimming, right?
- A. The way David Lamkin explained it to me, the
- 4 first two weeks they gave the kids swim tests on the
- 5 first two days, primarily to teach the counselors how
- 6 to properly observe the swimming proficiency of the
- 7 children. That was the --
- 8 Q. Okay.
  - A. That was the primary reason for doing
- 10 those -- doing those swim tests the first two weeks.
- 11 Q. And it's your understanding that they gave a 12 swim test to John Pluchinsky or do you know?
- 13 A. I don't know, but I don't think so.
- 14 Q. Okay. Do you know why?
  - A. They didn't routinely give swim tests to
- 16 the -- to the children.
- 17 Q. Do you know why they didn't routinely give
- 18 swim tests to young children that were as young as
- 19 four-years old that they were going to let in their
- 20 family pool that had areas that were easily
- 21 accessible to four-year olds, even 3.6 feet,
- 22 4 feet deep?
- 23 A. No. I just don't think it was our practice
- 24 to do so. We looked to the parents to provide
- 25 information and floaties if necessary, life jackets, 0088
- 1 that type of thing.
- Q. Okay. Well, who talked to the Pluchinskys
- 3 to find out what John Pluchinsky's swimming ability
- 4 was?

- 5 A. I don't know.
- 6 Q. What form -- because I haven't seen it --
- 7 exists that asked the Pluchinsky's what his swimming 8 ability was?
- 9 A. I don't believe we asked that on our form.
- 10 Q. Isn't it true that if you're going to accept
- 11 responsibility for the safety of four-year-old kids
- 12 that regardless of what guardians or parents say, if
- 13 you're going to let them in your waters you should
- 14 test their swimming ability?
  - MR. SNYDER: Objection, form.
- 16 A. I don't necessarily think so.
- 17 Q. (BY MR. MARRS) Well, would you -- would it
- 18 be a surprise to you if the American Red Cross
- 19 disagrees with you?
- 20 A. I would be interested to read that.
- 21 Q. Would it surprise you if every swimming
- 22 expert that's worth his weight in salt disagrees with 23 you?
- 20 you:
- 24 MR. SNYDER: Objection, form.
- 25 A. I don't necessarily --

- 1 Q. (BY MR. MARRS) Would that surprise you?
- 2 A. -- accept the premise of that.
- 3 Q. Well, we'll see about that.
- 4 Do you have grandchildren?
- 5 A. Yes, I do.
- 6 Q. How old are they?
- 7 A. I have an 18-month -- I'm sorry, a
- 8 nine-month, two five-year olds and an eight-year old.
- 9 Q. Have your two five-year-old grandchildren
- 10 swam in the family pool?
- 11 A. No. They don't live around here.
- 12 Q. How many different groups of campers were at
- 13 your family pool at the time John Pluchinsky drowned?
  - 4 A. The way I understand it, is that the two
- 15 13-year-old groups were there, the boys and the
- 16 girls, and that the seven-year olds had left as
- 17 the -- as the four-year olds came in.
- 18 Q. When you said the seven-year olds had left,
- 19 were they in the process of leaving or had they
- 20 already left the pool area?
- 21 A. I can't confirm that.
- 22 Q. Who else? Who else was in the pool at the
- 23 time of John's death?
- 24 A. I don't know. It was some members. I don't

25 know who else.

- 1 Q. Okay. Member children?
- 2 A. Perhaps.
- 3 Q. Do you know how many?
- 4 A. No.
- 5 Q. Do you know a minimum of how many?
- 6 A. No.
- Q. Were there seven-year-old boys that were
- 8 still there drying off right there at the family pool
- 9 at the time?
- 10 A. I don't know. I wasn't present.
- 11 Q. Yeah. But you've read the statements of all
- 12 the counselors, haven't you?
- 13 A. I don't recall the details. If you would
- 14 like to produce them, I'll review them right now.
- 15 Q. M #1, was she one of the
- 16 parents with a child in the pool immediately before
- 17 or at the time of John's death?
- 18 A. If I remember correctly, M #1 took
- 19 her -- took her four-year-old over to play with
- 20 another -- with her other child at the lap pool, if I
- 21 recall that mom.
- 22 Q. Immediately before?
- 23 A. At sometime prior to John's death.
- Q. And how many seven-year-old girls were in 25 the pool?

- 1 A. I don't know.
- 2 Q. How many counselors?
- 3 A. At least six with the boys group and the two
- 4 supervisors. I don't know how many girls -- girl
- 5 counselors were in pool.
- 6 Q. So you think there might have been around
- 7 eight counselors?
- 8 A. Total?
- 9 Q. Six to eight?
- 10 A. There were -- there were six to eight --
- 11 there were eight including the two supervisors, so
- 12 there were probably at least another four with the
- 13 girls.
- 14 Q. Okay. So if we have -- according to what
- 15 you do know, if we had two groups of 13, that's at
- 16 least 26 four-year-old children, we know
- 17 Ms. M #1 was there with one young camper, I
- 18 believe, probably a four-year-old, 4 y/o-C #7,

- 19 but he's already counted probably within the camper
- 20 number, but also with her daughter who was in the
- 21 pool with her, so we know that that's an additional
- 22 two. So that's 26 plus two, that's 28. And then we
- 23 know there were -- let's say if there were eight
- 24 counselors, that would be 36. And you say you think
- 25 there were also perhaps another member or two in the 0092
- 1 pool?
- 2 A. I don't know.
- 3 Q. Do you know how many guests were in the 4 pool?
- 5 A. No, I don't know.
- 6 Q. Does anybody at the Racquet Club know?
- 7 A. I don't think they do. I don't think -- I
- 8 doubt if anybody took a count prior to the incident.
- 9 Q. How about after the incident?
- 10 A. No. The pool was emptied after the 11 incident.
- 12 Q. So just based on the numbers that I've come
- 13 up with just now, based on what you do know, we know
- 14 that there was somewhere around 36 people in the
- 15 pool -- not counting the two lifeguards because they
- 16 weren't in the pool -- at least 36 people and there
- 17 may have been more, depending on whether there were
- 18 seven-year olds in the pool, whether there were
- 19 seven-year-old girls in the pool, whether or not
- 20 there were other members or guests that we're not
- 21 aware of, but at least about 36 we know of, correct?
- A. Possibly. I'm not quite sure how many girls were in the -- in the four-year-old group.
- 24 Q. Okay.
- 25 A. There were up to 13. That's our maximum 0093
- 1 allowable.
- 2 Q. So obviously, if you've got these groups
- 3 either in the pool or immediately leaving the pool,
- 4 that's a pretty busy time of the day for the camp,
- 5 around 11:00, 11:15 obviously, isn't it?
- 6 A. Moderately busy, yes.
- 7 Q. Moderately busy for the family pool?
- 8 A. Yes.
- 9 Q. Well, how many children, four-year olds
- 10 would need to be in the family pool for you to say it
- 11 was really busy?
- 12 MR. SNYDER: Objection, form.

- 13 A. I don't know.
- 14 Q. (BY MR. MARRS) In your opinion,
- 15 a 15-year-old first time certified lifeguard is more
- 16 than enough to scan by herself all of the 13-year
- 17 olds -- excuse me, all of the four-year olds, some
- 18 26 four-year olds in that swimming pool; is that your
- 19 opinion?

- MR. SNYDER: Objection, form.
- 21 A. With the addition of the -- all the
- 22 counselors that were also in the water with them,
- 23 yes, I feel that that was adequate.
- 24 Q. (BY MR. MARRS) None of whom saw John
- 25 Pluchinsky struggle or drown, correct? 0094
- 1 A. I don't know that. There's no evidence that
- 2 there was a struggle. It's not been reported.
- 3 Q. Well, there's evidence that there was a 4 drowning, correct?
- 5 A. Absolutely.
- 6 Q. There's evidence that he was found in
- 7 3.6 feet of water because you testified to that?
- 8 A. Around that area, yes.
- 9 Q. Sure. So we know that despite what you say
- 10 about the number of counselors we had in the pool,
- 11 the two life -- 15-year-old lifeguards, we know that
- 12 something went wrong and that he was not seen going
- 13 into 3.6 feet deep water, correct, sir?
- 14 A. I don't know that. I can't conclude that.
- 15 Q. You don't know one way or the other and the
- 16 Racquet Club doesn't know one way or the other,
- 17 correct, sir?
- 18 A. I'm just speaking for myself.
- 19 Q. Well, I want you to speak for the Racquet
- 20 Club.
- 21 A. The Racquet Club has the same position.
- Q. And what's the position that you're talking
- 23 about that the Racquet Club has?
- A. We don't know precisely what happened to 25 John.

- 1 Q. And you don't know how John got where he was
- 2 found floating, correct?
- A. That's correct.
- 4 Q. Where he was found floating that -- I mean,
- 5 you're familiar enough with the family pool in your
- 6 own club to know that where he was floating in

- 7 3.6 feet deep water is at least over 20 feet from
- 8 where that beach area ends. You know that, don't
- 9 you?

- 10 A. I don't know that for a fact. I would -- I
- 11 would want to see a scale drawing to determine that.
- Q. If John Pluchinsky was in that beach area 12
- 13 where he was supposed to be and started swimming or
- 14 walking towards and within that 3.6 foot deep area,
- 15 would you expect a counselor or lifeguard to prevent
- 16 him from doing that?
  - MR. SNYDER: Objection, form.
- 18 A. I would have expected that somebody would
- 19 have been -- would have seen him, yes.
- 20 Q. (BY MR. MARRS) Would have seen him and 21 protected him if he was going that way, correct, sir?
- 22 A. Yes.
- 23 Q. And you know of no one in this entire case
- 24 or that was employed by the Racquet Club that has
- 25 said that they saw him venturing into and going that 0096
- 1 distance, whether it was 20 or 25 feet, whatever it
- 2 is, no one has said that to your knowledge, right,
- 3 sir?

- 4 A. That's correct.
- 5 Q. So then, you know of course, as a matter of
- 6 fact, that your counselors and lifeguards did not
- 7 watch him as he ventured out there --8
  - MR. SNYDER: Objection --
- 9 Q. (BY MR. MARRS) -- to that 3.6 feet deep
- 10 water, correct, sir?
  - MR. SNYDER: Objection, form.
- 12 A. I can't -- I can't conclude that.
- 13 Q. (BY MR. MARRS) You don't conclude that?
- 14 A. No.
- 15 Q. Well, which one did see him venture into
- 16 that deep water and didn't do anything about it?
- 17 MR. SNYDER: Objection, form.
- 18 A. I don't know.
- 19 Q. (BY MR. MARRS) So, let's go to the -- so we
- 20 know from looking at Exhibit 6 that around 10:45
- 21 John's group, they were to head to the family pool, 22 correct?
- 23 A. Yes, that's correct.
- 24 Q. And then on the next page, we see the
- 25 four-year-old girls' schedule and 11:00 o'clock they 0097

- 1 were to be at the family pool, correct?
- 2 A. Yes.
- 3 Q. And then at the next page, we can see that
- 4 the five-year-old girl group, they at 11:25 were to
- 5 head to the family pool, right?
- 6 A. According to the schedule, yes.
- 7 Q. Then we know on the next page that a
- 8 seven-year-old boy group at 10:25 were in the pool
- 9 and were to get out sometime before 11:25, right,
- 10 sir?
- 11 A. Yes.
- 12 Q. And so who's responsible for drafting these
- 13 schedules that are shown on Exhibit 6?
- 14 A. I would defer to David Lamkin for those
- 15 specifics.
- 16 Q. Do you know the answer?
- 17 A. No, I do not.
- 18 Q. Those that were involved in operating your
- 19 summer camp at your club were who?
- 20 A. David Lamkin as fitness director was
- 21 primarily responsible. The camp supervisor for the
- 22 summer was CD and she had-- she had a
- 23 number of assistants.
- 24 Q. And how about Mr. Guillermo Palmer?
- 25 A. Guillermo had no -- no association with the 0098
- 1 camp.
- Q. Now, so we know that at least CD
- 3 and David Lamkin were fully aware prior to July 18,
- 4 2007 of the approximate number of four-year-old boys,
- 5 four-year-old girls and other children that were
- 6 scheduled to be in that family pool at the exact same
- 7 time. They were fully aware of it because that's
- 8 what the schedules show, correct, sir?
- 9 A. Yes.
- 10 Q. Who approved of some four lifeguards to take
- 11 a break at the same time around the 11:00 o'clock
- 12 hour when all these kids were going to be in the
- 13 family pool?
- 14 A. I think Mr. Palmer.
- 15 Q. Guillermo Palmer?
- 16 A. Yes.
- 17 Q. How about Mr. Lamkin?
- 18 A. I'm not sure if Mr. Lamkin was involved in
- 19 that decision or not.
- 20 Q. And you know that John Pluchinsky died

- 21 approximately 15 minutes after these lifeguards were
- 22 allowed to take a break and leave the pool, don't
- 23 you?
- 24 A. Approximately, yes.
- 25 Q. Can most four-year-old kids swim? 0099
- 1 MR. SNYDER: Objection, form.
- 2 A. I don't know.
- 3 Q. (BY MR. MARRS) Could your kids swim at 4 four-years old?
- 5 A. You know, I don't recall.
- 6 Q. Could your grandchildren who you should
- 7 recall because it wasn't that far along that they
- 8 were four-years old, it was a year ago, your two
- 9 five-year-old grandchildren, could they swim a year 10 ago?
- 11 A. They live in North Carolina. I'm not privy
- 12 to their day-to-day activities.
- 13 Q. You don't know?
- 14 A. No, I do not.
- 15 Q. Can most four-year-old children tread water
- 16 for any meaningful amount of time, to your knowledge?
- 17 MR. SNYDER: Objection, form.
- 18 A. I have no information.
- 19 Q. (BY MR. MARRS) But you certainly would
- 20 expect Guillermo Palmer and David Lamkin to know
- 21 those facts, wouldn't you?
- 22 MR. SNYDER: Objection, form.
- 23 A. I would expect them to provide a safe and
- 24 responsible number of guards and counselors at the
- 25 pool to watch for the children.
- 0100
- 1 Q. (BY MR. MARRS) And what else in terms of
- 2 protecting the lives of children that they allow in
- 3 your family pool, what else would you expect them to 4 do?
- 5 A. I think their steps were sufficient to
- 6 have -- David's requirement was that the counselors
- 7 remain in the pool with the counselors -- with the
- 8 children at all times at a ratio of 6 to 13, almost
- 9 two to one, which is much much higher than the
- 10 required ratio.
- 11 Q. Yes. But you can have 20 lifeguards and you
- 12 can have 20 counselors, but if they allow children to
- 13 drown in your pool, they're not really doing their
- 14 job, are they?

6 July 18th when John Pluchinsky drowned?
7
            MR. SNYDER: Objection, form.

A. I wasn't there. I don't know that for sure.

- 9 Q. (BY MR. MARRS) Based on what you now know
- 10 about all the number of people that were in that
- 11 pool, those getting in and out, drying off in the
- 12 pool, counselors, is it your opinion that it was
- 13 chaotic?
- 14 MR. SNYDER: Objection, form.
- 15 A. I would -- I would not anticipate that it
- 16 would have been chaotic, but as I said, I wasn't
- 17 there.
- 18 Q. (BY MR. MARRS) Have you ever tried to

- 7 exactly was he doing when John was drowning in the
- 8 family pool? Was he supervising the lifeguards?
- 9 A. No, he was not.
- 10 Q. Who's responsible for supervising the
- 11 lifequards?

- 12 A. Responsible lifeguards were left on staff at
- 13 the family pool.
- 14 Q. And who was responsible for supervising all
- 15 of the lifeguards at your club?
- 16 A. Guillermo Palmer. I don't interpret

- 17 supervisory as meaning that they have to be watched
- 18 moment to moment.
- 19 Q. No. They just have to adequately train
- 20 their lifeguards so that they know how to spot
- 21 children in distress and know how to handle emergency
- 22 situations and know how to adequately scan the pool
- 23 so that children don't lose their lives in the pool,
- 24 right, sir?
- 25 MR. SNYDER: Objection, form.

- 1 Q. (BY MR. MARRS) Would you agree with that?
- 2 A. I would agree that the training is
- 3 important.
- 4 Q. Would you agree with everything I just said?
- 5 A. Would you repeat it, please?
- 6 Q. I'd be happy to.
- 7 A. It was a statement.
- 8 Q. They are responsible for training their
- 9 lifeguards, training them so that they know how to
- 10 deal with emergencies and training them to adequately
- 11 scan the pool so that children don't drown in the
- 12 pool, aren't they?
- 13 A. Primary responsibility is the safety of the
- 14 people in the pool.
- 15 Q. Right. And of course, his job is to make
- 16 sure that there are an adequate number of competent
- 17 lifeguards at the family pool to protect the number
- 18 of children in that pool, right, sir?
- 19 A. Correct.
- 20 Q. Now, let's go to Exhibit Number 23. This is
- 21 a -- this is an E-mail from a M #2,
- 22 M #2. Do you know who that is?
- 23 A. No, I don't know her personally.
- 24 Q. And I think she made it to member feedback.
- 25 That's a -- that's basically an E-mail that arrives 0109
- 1 at the Houston Racquet Club for members to give feed
- 2 feedback, correct?
- 3 A. Correct.
- 4 Q. Do you usually look at the feedback that the
- 5 members give on the web site?
- 6 A. I monitor that daily.
- 7 Q. Okay. So you would have seen on July 21st,
- 8 that Saturday, or at least sometime after that,
- 9 M #2's E-mail that's Exhibit Number 23,
- 10 correct, sir?

- 11 A. Yes.
- 12 Q. And she states, "How did John accidentally
- 13 drown and die?" And later on she says, "Why do we
- 14 allow 4 year olds?" And near the bottom of the first
- 15 page she says, "I can not understand why a counselor
- 16 was not watching this poor child. That was our job.
- 17 I do not blame the counselor. I blame the Managers."
- Now, who are the managers of the
- 19 Houston Racquet Club? Yourself as general manager,
- 20 you've got David Lamkin, who is the -- what's his
- 21 title?
- 22 A. Fitness director.
- 23 Q. Does he have another title?
- 24 A. No. He has a lot of responsibilities,
- 25 though, other than fitness director.

- 1 Q. Is he aquatics?
- A. No. David Lamkin is -- Guillermo Palmer is
   aquatics.
- 4 Q. Okay. I'm sorry. Is he -- is David Lamkin
- 5 camp director?
- 6 A. No. The camps -- the camps are under
- 7 David's supervision.
- 8 Q. Okay. As fitness director?
- 9 A. David wears a lot of hats.
- 10 Q. Has he ever been called the camp director?
- 11 A. I can't speak to whether David actually had
- 12 that title in the past. He hasn't had it since I've
- 13 been here.
- 14 Q. Who has, anyone?
- 15 A. CD in 2007 and DS
- 16 in 2006. Prior to that, I can't say.
- 17 Q. And who is DS?
- 18 A. David's wife.
- 19 Q. And is she currently camp director?
- 20 A. No, she's not.
- 21 Q. Okay. But she was at some point and now
- 22 CD is; is that right?
- 23 A. There's no camp director right now. CD
- 24 was -- CD was in the most previous camp season.
- 25 Q. Okay.

- 1 A. The most recent camp season. Sorry.
- 2 Q. And how about the gentleman sitting across
- 3 from, Mr. Ted Erck, who is -- who was the president
- 4 of this club, he -- you reported directly to him?

- 5 A. Yes, I did.
- 6 Q. Okay. And did he have any management
- 7 responsibilities for the ongoing operations of the
- 8 Racquet Club?
- 9 A. None at all.
- 10 Q. Well, what were his responsibilities as you
- 11 understand them as of July 18, 2007?
- 12 A. The president of the board, as I -- I report
- 13 to the president of the board. The board of
- 14 directors set policy, discuss the club's needs,
- 15 determine the best path forward, consider a number of
- 16 issues. I'm charged with implementation of the
- 17 policies that they create.
- 18 Q. So -- and of course another manager would be
- 19 Guillermo Palmer?

I just know that 15 minutes 3 is not possible. 4 Q. Why? 5 A. There were too many people around him. He would have -- he would have had to have been seen. 7 Q. That amount of time seems ridiculous, 8 doesn't it? 9 A. Yes, it does. 10 Q. That's a long time, 15 minutes, even ten 11 minutes for a four-year-old child if they were not 12 supervised in your family pool if that were the 13 case. 14 A. May I ask that we once -- that we review 15 4 y/o B-CC #2 's statement, please?

Q. I'll let your lawyer ask you guestions about

So certainly as general manager, you

17 4 y/o B-CC #2 's statement, if he chooses to.

- 19 had authority personally to hire or make sure that
- 20 more lifeguards were hired for the family pool for
- 21 summer camp, don't you?
- 22 A. I left the hiring for the -- for the
- 23 lifeguards up to Guillermo Palmer.
- 24 Q. Of course. You delegated that
- 25 responsibility to --

- 1 A. I did.
- 2 Q. -- Mr. Palmer, correct?
- 3 A. Yes.
- 4 Q. But if you so chose, you could have said,

14 counselor to go into 3.6 or 4 feet deep water without

- 16 Q. And how much are those, do you know?
- 17 A. No, I don't know.
- 18 Q. How many does the Houston Racquet Club own?
- 19 A. We don't own any.
- 20 Q. Even to this day?
- 21 A. No. sir.
- 22 Q. Correct?
- 23 A. No, sir, that's correct.
- 24 Q. You know that Mrs. Pluchinsky when she
- 25 dropped John Pluchinsky off the morning of July 18, 0124
- 1 2007 trusted your club to keep him safe, don't you?
- 2 A. Yes.

- 3 MR. SNYDER: Objection, form.
- 4 Q. (BY MR. MARRS) Why was Mrs. Pluchinsky told
- 5 that her older son, Alec Pluchinsky, had drowned in
- 6 the Houston Racquet Club pool?
  - MR. SNYDER: Objection, form.
- 8 A. That was a miscommunication. I'm not sure
- 9 how that happened. There was no confusion at pool
- 10 side who that boy was.
- 11 Q. (BY MR. MARRS) Really?
- 12 A. No, sir, there was not. The message was not
- 13 conveyed by the Racquet Club. It came through
- 14 another party.
- 15 Q. Okay. So backing up to your statement that
- 16 there was no pool side confusion or miscommunication
- 17 about who this young boy was. What was the whole
- 18 purpose of lining up the four-year-old boys and
- 19 taking roll call immediately after this happened?
- 20 A. To be certain who the boy was that was
- 21 missing from roll call.
- 22 Q. And who was the boy missing from roll call?
- 23 A. It was reported to me that it was determined
- 24 to be John Pluchinsky.
- 25 Q. And if pool side they already knew it was 0125
- 1 John Pluchinsky, why in the world would they do roll
- 2 call to see where John Pluchinsky was?
- 3 MR. SNYDER: Objection, form.
  - A. The roll call was taken at the time John was
- 5 being resuscitated.

- 6 Q. (BY MR. MARRS) At the time John was being
- 7 resuscitated, your counselors and your lifeguards did
- 8 not know his name, correct?

- 9 MR. SNYDER: Objection, form.
- 10 A. I don't know at what point we determined
- 11 that it -- that it was John.
- 12 Q. At the time he was floating in the pool,
- 13 they did not know his name, did they?
- 14 MR. SNYDER: Objection, form.
- 15 A. I don't know that for a fact.
- 16 Q. (BY MR. MARRS) But you do know that after
- 17 this happened while he's being resuscitated or at
- 18 least attempting to resuscitate him, that someone
- 19 lined up the four-year-old boys and took a roll call
- 20 to find out who this four-year-old boy trying to be
- 21 resuscitated was.
- 22 MR. SNYDER: Objection, form.
- 23 Q. (BY MR. MARRS) Correct?
- 24 A. That's what was reported to me, yes.
- Q. And how is it that the hospital or EMT was 0126
- 1 told that the victim was Alec Pluchinsky? Do you 2 know?
- 3 MR. SNYDER: Objection, form.
- 4 A. We're not certain how that happened. The
- 5 only thing I do know is that Alec's -- Alec's contact
- 6 form was found first. It was brought back just for
- 7 reference for the Pluchinsky's phone numbers and
- 8 contact numbers. And I think that's where the
- 9 miscommunication occurred.
- 10 Q. (BY MR. MARRS) Okay. Who, you said Alex?
- 11 A. Alec, the brother.
- 12 Q. And who communicated the name Alec
- 13 Pluchinsky to the hospital or EMT?
- 14 A. I'm not sure.
- 15 Q. Well, who do you think it was?
- 16 MR. SNYDER: Objection, form.
- 17 A. Possibly the Village police who
- 18 investigated, but I don't know for sure.
- 19 Q. (BY MR. MARRS) And if it was the Memorial
- 20 Village Police Department that communicated that, do
- 21 you know who communicated Alec Pluchinsky as the name
- 22 of the victim to the Police Department? Do you know
- 23 who at the club gave that information to the Police
- 24 Department?
- A. No. If I -- if I understand the sequence of 0127
- 1 events correctly, I think that Alec's card was the
- 2 first one that we had with the Pluchinsky's contact

- 3 information on it. John's card was then subsequently 4 found.
- 5 Q. Okay. And so, what was done with Alec
- 6 Pluchinsky's card?
- 7 A. As of when?
- 8 Q. I'm trying --
- 9 A. I'm sorry.
- 10 Q. I'm trying to find out who communicated the
- 11 name Alec Pluchinsky to the police department as the
- 12 victim?
- 13 MR. SNYDER: Objection, form.
- 14 A. I'm not sure.
- 15 Q. (BY MR. MARRS) Okay. Well, you know that
- 16 someone at the Houston Racquet Club communicated to
- 17 either the police department or the hospital that
- 18 Alec Pluchinsky was the victim, don't you?
- 19 A. Yes, I know that.
- 20 Q. Okay. How do you know that?
- 21 A. I heard it after the fact.
- 22 Q. And did you hear who it was that
- 23 communicated that name?
- 24 A. No. I don't -- I don't know who ultimately
- 25 reached Mrs. Pluchinsky. We made several attempts. 0128
- 1 Q. And do you know who communicated that name
- 2 to the EMT that was on the scene?
- 3 A. No, sir, I do not.
- 4 Q. And was the Racquet Club's communication to
- 5 an emergency professional on the scene that it was
- 6 Alec Pluchinsky that was the victim, was that just a 7 mistake?
- 8 A. I have to conclude so.
- 9 Q. At what point in time did the Racquet Club
- 10 realize that the wrong name was communicated to the
- 11 emergency professional?
- 12 A. I don't believe that we knew that there was
- 13 a miscommunication until after the fact when -- after
- 14 John had been taken to the hospital and had died. I
- 15 don't recall the exact moment that I -- that I had
- 16 heard that there was a miscommunication.
- 17 Q. And did the Racquet Club do anything to
- 18 clear up that miscommunication immediately after it
- 19 learned of it?
- 20 A. Clear up with whom?
- 21 Q. Well, I guess a good place to start would be
- 22 with the parents.

- 23 A. By that time the parents already knew.
- Q. Okay. How about with the Police Department or the EMT?

- 1 A. I didn't make any communication with them, 2 no.
- 3 Q. Okay. Does it concern you as general
- 4 manager of the Houston Racquet Club that a parent was
- 5 told that their older son had died when in reality
- 6 their younger son had died?
- 7 A. I think it's an extremely unfortunate
- 8 miscommunication, completely accidental.
- 9 Q. And was the clipboard with the names of the
- 10 children in the pool readily available at the pool,
- 11 to your knowledge?
- 12 A. I believe it was. David Lamkin can provide
- 13 more information on that subject.
- 14 Q. And why do you believe it was?
- 15 A. It was reported to me afterwards that it
- 16 was, but I didn't actually see it.
- 17 Q. Well, why is it that none of the counselors
- 18 could find it if it was readily available at the
- 19 pool?

- 20 A. I don't know that to be the case.
  - Q. And does it concern you that Mrs. Pluchinsky
- 22 was at the hospital and saw a body lying on the
- 23 gurney under a sheet and thinking for just a minute
- 24 that, Oh, my God they have the wrong child. This is
- 25 not my child because this child is shorter than Alec 0130
- 1 and pulling the sheet back and realizing that it --
- 2 not only was it not her older son, but it was her
- 3 younger son?
  - A. It breaks my heart.
- 5 Q. Does that concern you?
- 6 A. Yes, it does.
  - Q. Do you think that there is any way that she
- 8 will ever erase that memory out of her mind?
- 9 MR. SNYDER: Objection, form.
- A. I don't know.
- 11 Q. (BY MR. MARRS) Are you aware of the fact
- 12 that not one, but more than one counselor was running
- 13 around your club sifting through Mr. Palmer's office
- 14 looking for something that would tell them who this
- 15 child was?
- 6 A. I'm not aware that that happened.

- 17 Q. Well, have you read the statements of the counselors where they indicate that?
- 19 A. I would have to read them again.
- 20 Q. Are you aware of the fact that it was not
- 21 any of your employees that decided to take this roll
- 22 call, that it was a concerned mother at the scene who
- 23 was frantically trying herself to make sure that the
- 24 parents knew, that said, "Let's take a roll call and
- 25 find out who this kid is?" Are you aware of that? 0131
- 1 A. I'm not aware of that.
- 2 Q. Let's look at Exhibit 10.
  - MR. SNYDER: You said 10, but I don't
- 4 know if that's still your plan.

- 5 MR. PLETCHER: 6 we just did.
- 6 MR. MARRS: Yeah. I just want to make 7 sure I'm not doubling up.
- 8 Q. (BY MR. MARRS) Let's look at Exhibit 7B.
- 9 This is a handwritten statement by a 7 y/o B-CC #3
- 10 seven-year-old boys counselor. And he
- 11 says that, "My kids and our counselors had just
- 12 gotten out of the pool and were drying off when we
- 13 heard a woman scream," et cetera. Does that lead you
- 14 to believe that there were a group of seven-year-old
- 15 boys that were pool side drying off at the time that
- 16 John drowned?
- 17 A. That's what 7 y/o B-CC #3 is reporting.
  - Q. So aside from the -- I think we arrived at
- 19 about 36 people in the pool including eight
- 20 counselors. If indeed, we put a group of
- 21 seven-year-old boys pool side at the same time, then
- 22 we know that there were -- do you know how large the
- 23 seven-year-old boys group was?
- 24 A. No, sir, I do not.
- 25 Q. Does eight -- about eight sound about right 0132
- 1 to you?
- 2 A. That's probably typical.
- 3 Q. So that would be -- 36 plus eight -- 44
- 4 counselors and campers in the pool that we know of so
- 5 far if indeed 7 y/o B-CC #3 is correct, right, sir?
- 6 MR. SNYDER: Objection, form.
- 7 A. Yes.
- 8 Q. (BY MR. MARRS) And we know that in
- 9 Exhibit 7C from Supv CC #2, one of the counselors
- 10 you mentioned earlier as being one of the counselors

- 11 responsible for watching John, correct?
- 12 A. He was a supervisor, yes.
- 13 Q. Okay. He was a counselor supervisor, right?
- 14 A. Yes, sir.
- 15 Q. And how many seven-year-old -- if there was
- 16 a group of seven-year olds in the pool, say eight, or
- 17 pool side, then how many counselors would have been
- 18 watching those seven campers?
- 19 A. I don't know that.
- 20 Q. At least one, right?
- 21 A. Certainly.
- 22 Q. Okay. And here we have Supv CC #2, who is
- 23 stating that he was swimming in the pool when he saw
- 24 the lifeguard walking over and heard her ask a
- 25 counselor what's wrong with the kid. And going back 0133
- 1 down a little further, he says, "I ran out of the
- 2 pool with another counselor to go find David" -- he's
- 3 talking about David Lamkin, right?
- 4 A. Yes.
- 5 Q. "...or Guillermo," that would be Guillermo
- 6 Palmer, right?
- 7 A. Correct.
- 8 Q. "Couldn't find them, so went back to go help
- 9 with the child." So here you have a counselor who
- 10 is -- who does not know where Guillermo Palmer was
- 11 or David Lamkin was at the time of this emergency and
- 12 running around trying to find them, correct?
- 13 A. Yes. They wouldn't necessarily know David
- 14 and Guillermo's location at every moment.
- 15 Q. Are they supposed to know who their
- 16 supervisor is at any given moment?
- 17 A. Yes. Their supervisor is David or CD, if
- 18 she's present.
- 19 Q. And you're fully aware of the fact that
- 20 you've had problems at your family pool with
- 21 counselors or lifeguards not even knowing who their
- 22 supervisor was, correct?
- 23 A. Correct.
- 24 MR. SNYDER: Objection, form.
- A. I think there was a statement to that 0134
- 1 effect, but I don't -- I don't accept that as a
- 2 general statement, no.
- 3 Q. (BY MR. MARRS) Well, there was a statement
- 4 to that effect by you at one time, wasn't there?

- 5 A. I don't recall making that statement.
- 6 Refresh my memory.
- 7 Q. I will.
- 8 A. Okay. I got you. My E-mail to Guillermo.
- 9 Q. Yes, sir.
- 10 A. Okay. I've got you.
- 11 Q. You yourself have complained, as a matter of
- 12 fact, it -- probably like a month before John
- 13 drowned, about lifeguards or counselors not even
- 14 knowing who their supervisor was when you asked them,
- 15 right, sir?
- 16 A. In that particular instance they didn't
- 17 know, yes.
- 18 Q. And aren't you aware of the fact that even
- 19 later after this incident, when these kids were asked
- 20 who their supervisor was, many of them still couldn't
- 21 even tell authorities who their supervisor was at the
- 22 Racquet Club. Were you aware of that?
- 23 A. No, I was not.
- 24 Q. Does that concern you?
- 25 A. Yes, it does.

- 1 Q. Does it lead you to believe that perhaps
- 2 Guillermo Palmer wasn't doing his job and making sure
- 3 that the lifeguards under his direction knew who
- 4 their supervisors were that they could turn to in a
- 5 moment of crisis for help? Does that concern you?
  - MR. SNYDER: Objection, form.
- 7 A. I believe the supervisors that day knew that
- 8 LG Supv was their supervisor or the
- 9 lifeguards. I can't speak for the counselors.
- 10 Q. (BY MR. MARRS) If the lifeguards did not
- 11 know who their supervisor was, would that concern
- 12 you?
- 13 MR. SNYDER: Objection, form.
- 14 A. Perhaps.
- 15 Q. (BY MR. MARRS) I mean, that's pretty
- 16 important to know, isn't it?
- 17 A. Well, it is, but they are lifeguards in
- 18 their own right and they have their responsibilities
- 19 at every given moment -- at any given moment. They
- 20 don't direct supervision at all times.
- 21 Q. Would it concern you if even after your
- 22 E-mail complaining that lifeguards or counselors
- 23 didn't know who their supervisors were, that in July
- 24 of 2007 after your E-mail during the investigation of

25 this drowning that some of those lifeguards and 0136

- 1 counselors still could not name who their supervisors
- 2 were? Would that concern you?
- A. It would surprise me.
- 4 Q. But there again, there was not a supervising
- 5 lifeguard at the family pool at the time John
- 6 drowned, correct?
- 7 A. There was a supervising lifeguard in 8 proximity at the pavilion.
- 9 Q. Eating lunch?
- 10 A. Yes. They eat lunch in the pavilion so that
- 11 they can stay in the general area of the pool while
- 12 they are eating lunch.
- 13 Q. And he had no clue, LG Supv, that
- 14 anything was going on back at the family pool until
- 15 the alarm bells went off and 15 y/o LG #1 was blowing
- 16 her whistle, right?
- 17 A. I think that was the first moment that
- 18 anybody knew that anything was going on.
- 19 Q. So back to my question. There was no
- 20 supervising lifeguard at the family pool when John
- 21 drowned, correct?
- 22 A. That's correct.
- 23 Q. And there was also the manager of the
- 24 lifeguards, Guillermo Palmer, wasn't there either,
- 25 correct?

- A. At that moment he was not.
- 2 Q. Did one of the counselors or lifeguards go
- 3 into the room where Alec Pluchinsky was and ask
- 4 whether there was an Alec Pluchinsky in that room?

- 5 club, correct?
- 6 A. No. My responsibilities were limited to the 7 clubhouse.
- 8 Q. Okay. Did you draft this resume?
- 9 A. It was actually prepared by a search firm.
- 10 Q. Based on information you provided to them?
- 11 A. Yes.
- 12 Q. Okay. When it says on Page 2 under duties
- 13 at the Westmoreland Country Club that you worked
- 14 closely with swim professional staff, would that be
- 15 inaccurate?
- 16 A. No. That's accurate, but I wasn't involved
- 17 in their day-to-day operation, scheduling or anything
- 18 like that. It was -- it was to the extent that
- 19 clubhouse activities coordinated with the swimming
- 20 activities. I had very little to do with the
- 21 operation of that pool.
- 22 Q. Well, I didn't ask you if you worked
- 23 day-to-day with them. My question was: Did you work
- 24 closely with the swim professional staff and you
- 25 said, "No."

- 1 So my question is, did you or didn't
- 2 you work closely with the swim professional staff?
- 3 A. I did and I just described the context of
- 4 that relationship to you.
- 5 Q. Did the Westmoreland Country Club have a
- 6 summer camp program?
- 7 A. No.
- 8 Q. Did they have a child swim program?
- 9 A. I believe they did.
- 10 Q. How many pools did they have?
- 11 A. One.
- 12 Q. How deep was it at the deepest point?

- 13 A. I don't recall.
- 14 Q. Did they allow four-year olds in their
- 15 swimming pool accompanied by staff of the club, to
- 16 your knowledge?
- 17 A. I have no information.
- 18 Q. Did they have any program where they took
- 19 custody of children and had the children in the
- 20 swimming pool without parental supervision?
- 21 A. I don't know.
- 22 Q. Have you been to any clubs anywhere at any
- 23 time during the time that they had a summer camp
- 24 program where you actually saw children in the pools
- 25 other than your own?

- 1 A. At Greenville Country Club.
- 2 Q. And where was that?
- 3 A. In Delaware.
- 4 Q. Did you work there?
- 5 A. Yes.
- 6 Q. Is that on your resume?
- 7 A. Yes, it is.
- 8 Q. How many pools did they have?
- 9 A. One.
- 10 Q. And what kind of -- did they have a summer
- 11 camp program?
- 12 A. Yes.
- 13 Q. And how long did you work for the Greenville
- 14 Country Club?
- 15 A. Just about six years.
- 16 Q. Were you responsible in any way for the
- 17 summer camp program?
- 18 A. Yes.
- 19 Q. In what way?
- 20 A. I assisted in setting it up when I arrived
- 21 in 1999, Spring of 2000. And the camp director
- 22 reported to me directly.
- 23 Q. Who was that?
- 24 A. There were four -- no, there were three
- 25 during the time that I was there. I -- sorry, I

- 1 don't recall their names. Charles was the man that
- 2 was there the last few years I was there.
- 3 Q. I'm sorry, I didn't catch his name.
- 4 A. Charles. If I sit here a little while, I'll
- 5 come up with it.
- 6 Q. Okay. Charles what?

- A. I can't remember his last name.
- 8 Q. And Charles reported directly to you?
- 9 A. Yes.
- 10 Q. Was he a friend?
- 11 A. No. He was -- He was an acquaintance that I
- 12 met through hiring him for the summer camp program.
- 13 Q. In setting up your program from '99 until
- 14 approximately 2000, did the Greenville Country
- 15 Club -- what was the minimum age of children?
- 16 A. I believe it was six.
- 17 Q. Why didn't you accept four-year olds?
- 18 A. I followed the guidelines of the local child
- 19 protective agency. And I don't recall the specific
- 20 name of the agency in Newcastle County, but they had
- 21 a lower age limit and a maximum number of hours per 22 day.
- Q. What was your understanding as to why thechild protective services had jurisdiction over your

1 A. They --

25 summer camp --

- Q. -- at Greenville Country Club?
- 3 A. They had jurisdiction over operations that
- 4 watched children, so -- and in order to not be
- 5 required to have a license, there were certain --
- 6 there were certain requirements to exempt out of 7 that.
- 8 Q. Okay. So you are aware at the Greenville
- 9 Country Club when you set up their summer camp
- 10 program that you had to have a license if you were
- 11 going to run a program where you accepted custody of
- 12 children in that program, correct?
- 13 A. Children under a certain age.
- 14 Q. Which was what?
- 15 A. I'm not sure. It was either -- it was
- 16 either four or five.
- 17 Q. Okay. Nonetheless, with respect to the
- 18 young children you accepted into your summer camp
- 19 program, the Child Protective Services did have
- 20 jurisdiction over that summer camp, right?
- 21 A. They didn't -- they didn't have oversight of
- 22 it since we didn't exceed more than four hours a day
- 23 and not under six years of age.
- 24 Q. I got you. Did you look at those CPS
- 25 requirements to make sure that Greenville Country 0143

- 1 Club was within its parameters?
- 2 A. No. I simply called the local agency and we
- 3 talked on the phone and they described what I needed 4 to do.
- 5 Q. Okay. And how did the Greenville Country
- 6 Club test children's swimming ability in that summer
- 7 camp program you set up?
  - MR. SNYDER: Objection, form.
- 9 A. I don't recall specifically testing the
- 10 ability of the children; however, I wasn't involved
- 11 in the -- directly in the swimming aspect of the
- 12 program.

- 13 Q. (BY MR. MARRS) How would they -- During
- 14 that summer camp program you set up, how would you
- 15 distinguish between children that could swim and
- 16 children that couldn't and their swimming ability?
- 17 How would a counselor or lifeguard be able to see
- 18 readily in the pool who had good swimming ability and
- 19 who didn't? Did you have any kind of system set up?
- 20 A. I honestly don't recall the specifics of
- 21 it. It was delegated to the lifeguards on staff and
- 22 the counselors to oversee the children at that point.
- 23 Q. In 1999, 2000 was there any kind of color
- 24 coding of children in the summer camp program at
- 25 Greenville?

- 1 A. To designate --
  - Q. To designate anything.
- A. Well, they all wore -- they all wore
- 4 identifying clothing as participants in the camp.
- 5 Q. Anything to indicate their age or swimming 6 abilities?
- 7 A. No. It was a relatively small camp.
  - Q. Prior to your -- At any time prior to your
- 9 2007 summer camp at the Racquet Club, did you or
- 10 anybody on your behalf simply call up the local CPS
- 11 office in Houston to find out whether or not you
- 12 would be subject to its rules just like you did back
- 13 in Greenville?
- 14 A. I did not.
- 15 Q. Did you ask anyone to?
- 16 A. No, I did not.
- 17 Q. Why not?
- 18 A. I arrived to a program that had already been
- 19 in place for 25, 28 years. I can't even tell you
- 20 when it started. I spent time with David. We

- 21 reviewed all the aspects of the program. It was
- 22 obviously well run and very well staffed and with the
- 23 other things that I was dealing with upon arrival, it
- 24 didn't occur to me to check.
- 25 Q. How long had the -- has the summer camp 0145
- 1 program at the Racquet Club been in place?
- 2 A. I don't know exactly; in excess of 25 years.
- Q. Well, who's responsible at the Racquet Club
- 4 for ensuring that its summer camp met all the state
- 5 and local requirements? Who do you have in place to
- 6 make sure that you were complying with the laws and
- 7 the rules?
- 8 A. I don't think we were aware that the laws or 9 rules existed.
- 10 Q. Well, it was no surprise to you that Child
- 11 Protective Services in Greenville had authority over
- 12 some aspects of the same kind of summer camps that
- 13 were going on at the country club where you were
- 14 general manager of, correct; you knew that?
- 15 A. It was told to me by a lady who ran a day
- 16 care facility, yes.
- Q Sure 17 18 A. Yes.
- 19 Q. So by the time you arrived at the Racquet
- 20 Club, regardless of how long their camp had existed,
- 21 you were aware the day you walked into the door that
- 22 CPS might have jurisdiction and rules and stuff that
- 23 apply to your club and your summer camp? You knew

- 1 Q. What about the summer camp program at
- Racquet Club are you involved in on a day-to-day

- 5 to -- I spend a great deal of time out on the
- 6 grounds. I wander -- I wander around, looking at the
- 7 different aspects of the operation. I've been --
- 8 I've been present at -- many times during drop-off
- 9 and pick-up back at the -- back at the Howe House. I
- 10 observe the children walking around the property. I
- 11 observe them under the -- you know, under the care of
- 12 the counselors, but I have no direct interaction with
- 13 them.

Q. And at any time during all those times

- 15 you've been there at drop-off, have you ever once
- 16 heard any parent being asked, "Does your son, child,
- 17 daughter need a flotation device?"
  - A. I did not personally hear that, no.
- 19 Q. You've never personally heard that at any
- 20 time at the Houston Racquet Club regarding any summer
- 21 camp there, whether it was 2000, 2001 all the way
- 22 through to 2007, have you?

- 23 A. I can't speak to anything prior to 2006.
- 24 But no, during that time there, no, I have not.
- 25 Q. If you want to make sure that children of a 0147
- 1 certain age are wearing life jackets or some kind of
- 2 flotation device, what would you do?
- 3 MR. SNYDER: Objection, form.
  - A. If I wanted to make sure?
- 5 Q. (BY MR. MARRS) Yes, sir. If you as general
- 6 manager of this club believed that kids four-years
- 7 old ought to have a life jacket if they are going to
- 8 be in my family pool, what would you do to make sure
- 9 that that happened?
- 10 MR. SNYDER: Objection, form.
- 11 A. I would have set it as a standard.
- 12 Q. (BY MR. MARRS) And how would you make sure
- 13 that it was a standard at your club?

- 15 A. I would have set it and made it -- made it a
- 16 requirement of my supervisors.
- 17 Q. (BY MR. MARRS) And how would you make it a
- 18 requirement? Would you put something in writing?

- 21 Q. (BY MR. MARRS) How?
- 22 A. I would have done it in memo form or E-mail
- 23 form.
- 24 Q. Would you make it a part of your
- 25 registration form that if your kid is four-years old, 0148
- 1 they must have a life jacket when you drop them off?
- 2 Would you state that so that the parents would know?
- 3 MR. SNYDER: Objection, form.
- 4 A. I would consider that as something to add to 5 the form, yes.
- 6 Q. (BY MR. MARRS) Okay. Otherwise, if you
- 7 don't put it in the form and they are pulling the
- 8 form off your web site or getting it in the mail,

- 9 they wouldn't know that they were required to do that
- 10 unless you told them as part of your summer camp,
- 11 right?
- 12 MR. SNYDER: Objection, form.
- 13 A. That's correct.
- 14 Q. (BY MR. MARRS) And if you, as the general
- 15 manager of Houston Racquet Club, want to make sure
- 16 that you're in compliance with any CPS or family
- 17 protective service type of requirements like
- 18 Greenville Country Club, then what would you do to
- 19 make sure?
- 20 MR. SNYDER: Objection, form.
- 21 Q. (BY MR. MARRS) What would come down from
- 22 the general manager and where would it go to make
- 23 sure for yourself and the club that you were in
- 24 compliance. What would you do?
- 25 MR. SNYDER: Objection, form.

- 1 A. I would probably take it upon myself to find 2 out those requirements.
- 3 Q. (BY MR. MARRS) How would you do that?
- 4 Where would you go?
  - MR. SNYDER: Objection, form.
- 6 A. Local resources. I don't know.
  - Q. (BY MR. MARRS) Pick up the phone and call
- 8 the CPS maybe?
- 9 A. More likely to go on the Internet.
- 10 Q. Okay. That's a good point. And you could
- 11 go on the Internet and search and Google and find out
- 12 what the requirements are probably, correct?
- 13 A. Yes.
- 14 Q. You could even find a phone number,
- 15 probably, of the local office and call them if you
- 16 have further questions, right?
- 17 A. I'm certain.
  - Q. But not only that, you had a number of
- 19 lawyers, even on your board of directors that you
- 20 could turn to, didn't you?
- 21 A. If I had thought to ask the question, I'm
- 22 sure they could have assisted me.
- 23 Q. Lawyers like who, HRCBM-S?
- 24 A. HRCBM-S is an attorney, yes.
- 25 Q. Who else?

- 2 Q. Yes, sir.

- 3 A. HT, HRCBM-X.
- 4 Q. Well, let's stick to the board that you had
- 5 as of July 18. Who could you have called --
- 6 A. Let me think.

- 8 A. HRCBM-Z.
- 9 Q. Uh-huh.

- 4 phone and called to ask to look into regs, codes,
- 5 statutes or laws that might apply to your summer

  - A. Had it occurred to me, yes, I could have.
- 8 Q. During all those times that you were at
- 9 drop-off where parents drop their children off for
- 10 summer camp, did you ever hear any employee of the
- 11 club tell the parent, "Now, you know, your child is
- 12 going to be in water above his chest", advising the
- 13 parents how deep the water is that they were going to
- 14 allow their children to venture into?
- 15 A. No.
- 16 Q. And you know that on your camp registration
- 17 form, you do not indicate that, correct?
- 18 A. I would have to review the form, but I don't
- 19 believe so.
- 20 Q. And you don't indicate anywhere on your camp
- 21 registration form that you had as of July 18, 2007
- 22 indicating that any child, regardless of age, would

- 23 need any flotation device, correct?
- 24 A. That's correct.
- Q. You don't put a notice on there that if you 0152
- 1 don't have a life jacket for your child when you drop
- 2 them off, he might drown?
  - MR. SNYDER: Objection, form.
- 4 Q. (BY MR. MARRS) You don't have that warning
- 5 on there, do you?

- 6 A. That language certainly would not have been 7 contained on any form.
- 8 Q. But we do know from looking at Exhibit 6,
- 9 which we looked at before, the four-year-old Boy Kids
- 10 Camp News that --
- 11 MR. PLETCHER: Schedule.
- 12 Q. (BY MR. MARRS) -- on the schedule that as
- 13 far as John Pluchinsky's group on that Wednesday,
- 14 July 18, 2007 at 10:45, it says "Show your Counselors
- 15 how you can SWIM," correct?
- 16 A. Yes.
- 17 Q. And doesn't that indicate that the
- 18 counselors were going to determine whether that child
- 19 can swim?
- 20 MR. SNYDER: Objection, form.
- 21 A. I don't think that's necessarily a
- 22 conclusion.
- 23 Q. (BY MR. MARRS) You don't?
- 24 A. No, sir, I do not.
- Q. Well, do you think that a parent reading 0153
- 1 that could conclude that they are going to require
- 2 the child to show the counselor how they can swim?
- 3 MR. SNYDER: Objection, form.
- 4 A. I don't necessarily agree with that.
- 5 Q. (BY MR. MARRS) You don't?

- 3 A. I don't know that.
- 4 Q. (BY MR. MARRS) And have you been present at
- 5 any pool where a group of children was color coded to
- 6 determine or to be able to identify their swimming
- 7 abilities? Have you ever seen that done?
- 8 A. I have not personally, no.
- 9 Q. Have you ever heard of that being done?
- 10 A. No, not specifically, but I imagine it

- 11 exists.
- 12 Q. Have you ever read a lifeguard training
- 13 manual?
- 14 A. No, sir, I have not.
- 15 Q. Ever?
- 16 A. No, sir.
- 17 Q. Have you ever read a Red Cross manual on
- 18 safety at your country club or health club?
- 19 A. No, sir.
- 20 Q. Have you ever read the Texas Administrative
- 21 Code requirements as they relate to pool activities
- 22 at clubs such as yours?
- 23 A. I've read sections of the Texas
- 24 Administrative Code, yes.
- Q. When? When was the first time you've done 0156
- 1 that?
- 2 A. Upon arrival and relative to the
- 3 construction of the pool. Specifically the enclosure
- 4 gates, the fences.
- 5 Q. And how did you know to go to the Texas
- 6 Administrative Code?
- 7 A. HRCBM-S made me aware of it.
- 8 Q. And how did you get a copy of all or a
- 9 portion of the Texas Administrative Code at that
- 10 time?

- 11 A. It's already in my office. I arrived a week
- 12 before the pools open, so those -- that reference was
- 13 already in place.
- 14 Q. Okay. In a paperback version?
  - A. Printed from the -- from the Internet.
- 16 Q. And what portions of the Texas
- 17 Administrative Code did you have that was printed
- 18 from the Internet that was in your office when you
- 19 arrived?
- 20 A. I believe it's the entirety of that
- 21 particular section pertaining to all aspects of pool
- 22 operation and design.
- 23 Q. Okay. And so that would have been in 19 --
- 24 A. I think this was printed out in early 2005,
- 25 if I recall the date on the bottom of the document. 0157
- 1 MR. MARRS: Have you produced that
- 2 entire document bound, that entire printed document?
- 3 I ask that you produce it to us if you haven't. I
- 4 don't think we have it, so...

MR. SNYDER: I'll certainly check into 6 it. 7 MR. MARRS: Okay. 8 MR. SNYDER: You're talking about the portions of the administrative code that he discussed 10 that he --11 MR. PLETCHER: That he just described. 12 MR. MARRS: That he just testified 13 about. 14 MR. SNYDER: Okay. Sure. 15 MR. MARRS: Thank you. 16 Q. (BY MR. MARRS) And other than the 17 provisions with respect to enclosure requirements, as 18 I think you just said, I mean, you knew there were 19 provisions that govern pools, right? 20 A. Yes. 21 Q. Is the pool, the family pool, considered a 22 Class A, B, C, D? What class pool is it considered? 23 A. Class C pool. 24 Q. Class C. Do any of the provisions of --25 that govern Class B pools apply to your family pool, 0158 1 to your knowledge? 2 A. No, not to my knowledge. 3 Q. And at what point in time did you ask HRCBM-S or 4 anyone else to make sure that your pools, as newly 5 constructed, met the provisions of the TAC, the Texas 6 Administrative Code? 7 A. It was just in discussion. And as I said, 8 it was -- it was practically all done by the time I 9 got there. The only part that was left in question 10 was where the current pool construction was to meet 11 the future construction of the fitness center and 12 what that fence would look like that separated the 13 two. We just reviewed it to make sure that that --14 that that fence was in compliance. 15 Q. Well, how about with respect to lifeguards 16 or safety equipment or, you know, procedures or 17 training or any of those things, did you review those 18 provisions at any time? 19 A. I did not. 20 Q. Have you ever reviewed any of those 21 provisions? 22 A. Since the drowning, yes.

Q. And have you found or learned that some of

24 those provisions do apply to the family pool?

25 A. Oh, yes.

- 1 Q. And have you found that you were not in 2 compliance with some of those provisions?
  - A. Possibly.

- A. In a different field.
- 5 Q. And what's your understanding of what that

- A. Working with a -- with an asphalt paving and construction company.
- 9 Q. Okay. Has Guillermo Palmer's duties changed
- 10 at all at the Racquet Club since July 18, 2007?
- 11 A. Yes.
- 12 Q. How so?
- 13 A. We, through necessity, went with a -- with
- 14 an outside agency to provide us with lifeguards

- 15 because we weren't able to supply sufficient
- 16 lifeguards to meet the needs of our members. So I
- 17 found that I had to go to the outside to get the
- 18 guards necessary and so that took Guillermo out of
- 19 that capacity.
- 20 Q. And you were doing that through a pool
- 21 company?
- 22 A. Yes.
- 23 Q. And what's the name of that pool company?
- 24 A. A Beautiful Pools.
- 25 Q. And it's not your testimony that that was 0170
- 1 your voluntary decision to do that, is it? You were
- 2 required to do that by your insurance company,
- 3 weren't you?
- 4 A. No, sir, I was not.
- 5 Q. Was it a recommendation by your insurance
- 6 company to do that?
- 7 A. No, sir, it was not.
- 8 Q. Well, whose recommendation was it?
- 9 A. Mine.
- 10 Q. When?
- 11 A. When I found that we couldn't -- we couldn't
- 12 adequately staff the pools once we -- once we went to
- 13 a fully guarded status.
- 14 Q. And when did you find that out?
- 15 A. When did I find that requirement?
- 16 Q. Yes, sir.
- 17 A. I found when our insurance policy renewed in
- 18 August, we found that it was a requirement of our
- 19 renewal that we be fully guarded any time the pool
- 20 was opened.
- 21 Q. And prior to that, you did not have a rule
- 22 or policy that you were to be fully guarded anytime
- 23 the pool was opened, correct?
- 24 A. I implemented that policy at my own
- 25 discretion immediately following the accident.

- 1 Q. That what? Can you just explain to the jury
- 2 what you mean --
- 3 A. Certainly.
- 4 Q. -- by that?
- 5 A. Yes. I went -- I went to a fully guarded
- 6 status, that is, the pool isn't open for swimming
- 7 unless sufficient guard staff were in place, which
- 8 was where my dilemma about guard staff began.

10 that, you still do not believe you need anymore than
11 two lifeguards at the family pool during summer camp;
12 is that right?

      A. Our staffing load at the summer-- at the
14 resort pool or any pool is determined by the bather
15 load. We keep seven guards on staff during every
16 shift when we are in season and guarding it
17 ourselves.

      Q. In terms of guards, lifeguards that are

20 summer camp next summer and you have the same number
21 of people in the pool that you had on July 18th, are

10 already -- I was already moving in that direction
11 because there's the expectation that the pools will
12 be open or the pool, at least, the lap pool will be
13 open year around. I don't have availability of
14 lifeguards year around, so I had to go to a

- 9 continuing education, provide supplemental written
- 10 materials for training, et cetera.
- 11 Q. Okay. Are they to -- is A Beautiful Pool
- 12 company tasked with the responsibility through a
- 13 contract with them to actually provide lifeguards to
- 14 the Racquet Club or not?
- 15 A. Yes.
- 16 Q. Yes, okay.
- 17 A. That's my sole relationship with them.
- 18 Q. They are to provide lifeguards to you. Are
- 19 they to provide lifeguard training to you?
- 20 A. Yes. They are to provide continuing
- 21 education for their guards.
- 22 Q. And just to clarify, did your insurance
- 23 company as a condition to renewing your policy
- 24 require you to hire a professional company to do
- 25 those things?

- 1 A. No.
  - Q. Okay. What was their recommendation?
- 3 A. To hire a private company to provide risk
- 4 assessment. It's an independent company.
- 5 Q. Risk assessment and audits?
- 6 A. Yes.
- 7 Q. And has such risk assessment and audit
- 8 occurred at the Racquet Club by the A Beautiful Pool
- 9 company?
- 10 A. The risk assessment and audits are performed
- 11 by NASCO.
- 12 Q. Okay.
- 13 A. And yes, they performed their first one
- 14 according to our annual schedule.
- 15 Q. Okay. And did they give you a written
- 16 report of that?
- 17 A. No, verbal.
- 18 Q. Why do you not have a written report from
- 19 NASCO?
- 20 MR. SNYDER: Objection, form.
- 21 A. That's just not their -- it's not their
- 22 practice.

- 23 Q. (BY MR. MARRS) And prior to the renewal of 24 your insurance policy, when your lap pool would be 25 opened, would it be at times when lifeguards weren't 0175
- 1 there at your own risk?
- A. Prior to the accident in the off season, wes.
- 4 Q. Okay. And did, to your knowledge,
- 5 Mr. Lamkin or yourself or anyone at the Racquet Club
- 6 suggest to Mr. Palmer he might look for other
- 7 opportunities?

- 8 A. Certainly not.
  - Q. You would be perfectly content and happy
- 10 with him staying at the Racquet Club, correct?
- 11 A. Yes, I would. And I would have been happy
- 12 in his -- in his previous capacity; however, his
- 13 responsibilities have changed.
- 14 Q. Okay. You would have been even after
- 15 July 18, 2007 happy for him to continue serving in
- 16 the same role he served in prior to July 18, 2007,
- 17 correct?
- 18 A. Yes.
- 19 Q. And what exactly are David Lamkin's
- 20 responsibilities as you understand them?
- 21 A. As I said, he wears a number of hats. His
- 22 official title is fitness director. He's also --
- 23 that would -- that would include oversight of all
- 24 fitness activities, aerobics activities, the physical
- 25 plant of the fitness center, the locker rooms. He 0176
- 1 has oversight of the aquatics operation through
- 2 Guillermo Palmer. He has oversight of the summer
- 3 camp. He has oversight of the ladies and the men's
- 4 locker rooms.
- 5 Q. Is the --
- 6 A. That's pretty much it.
- 7 Q. Okay. Is the same family pool considered to
- 8 be under the auspices of fitness?
- 9 A. Only through the aquatics director.
- 10 Q. Okay. Indirectly?
- 11 A. Yes, sir.
- 12 Q. And what was the criteria for -- did you
- 13 hire David Lamkin?
- 14 A. No. David was --
- 15 Q. He was already there?
- 16 A. Yes.

- 17 Q. And for a fitness director, what's the
- 18 criteria for someone to hold that position?
- 19 A. Well, David has a -- has a background in --
- 20 and he'll speak to that much better than I will, but
- 21 he's been a personal trainer and been involved in
- 22 fitness for many, many years. I believe David came
- 23 on as our fitness director and then subsequently
- 24 assumed additional responsibilities as people left
- 25 through the previous general manager. So, you know, 0177
- 1 the requirements for fitness director at the Racquet
- 2 Club, I think, are much more extensive than they
- 3 would be at most other places the way the position is
- 4 currently defined.
- 5 Q. You have to have good judgment?
- 6 A. Absolutely.
- 7 Q. Be able to deal with people?
- 8 A. Yes.
- 9 Q. Hopefully, have some background in health
- 10 fitness, right?
- 11 A. Yes.
- 12 Q. Be able to manage other people, such as your
- 13 aquatics director, right?
- 14 A. Yes.
- 15 Q. It's his responsibility to adequately retain
- 16 and train counselors, right?
- 17 A. Through the -- through the summer camp
- 18 director, yes.
- 19 Q. And to make sure -- it's his responsibility
- 20 to make sure that the counselors are doing their jobs
- 21 on a day-to-day basis, right?
- 22 A. Again, through the supervision of their --
- 23 of their immediate supervisor. So David's remained
- 24 very involved with the camp on a day-to-day basis.
- 25 Q. Well, I mean, who's ultimate -- or should I 0178
- 1 say, I mean, it's David that is responsible, I mean,
- 2 for the counselors. He's head -- he's considered to
- 3 be the head of the counselors, isn't he?
- 4 A. Technically, CD was the head of
- 5 the summer camp this year.
- 6 Q. In summer camp 2007?
- A. Yes.
- 8 Q. And since when? Was she in 2006?
- 9 A. No. In 2006 it was DS.
- 10 Q. Okay. And how did CD come to the club?

- 11 What's your understanding?
- 12 A. I don't have a great deal of understanding
- 13 of it other than David knew her. She had coached
- 14 sports, and I'm not sure which sports. She had a
- 15 couple years of coaching experience with a local
- 16 school and somehow David became acquainted with her
- 17 and offered her the position.
- 18 Q. And what experience does CD have in
- 19 running summer camps?
- 20 A. I can't speak to her previous experience.
- 21 Q. So was it David or was it CD that was
- 22 responsible for making sure that the counselors were
- 23 doing their job on a day-to-day basis at the 2007
- 24 summer camp?
- A. I would have to say CD had direct 0179
- 1 oversight of the counselors. But again, David can2 clarify that.
- 3 Q. What qualifications did Mr. Lamkin have as
- 4 of July 2007 to supervise the counselors?
- A. David -- and again, David can offer the
- 6 years and the specific experience, but David actually
- 7 ran the camp himself, I think, for several years upon
- 8 his arrival. He has had the camp under his direction
- 9 for, I believe, 13 years.
- 10 Q. And aside from the number of years he's done
- 11 it, my question is: What qualifications does he have
- 12 to do it?
- 13 A. I can't speak to his specific
- 14 qualifications.
- 15 Q. Do you know them?
- 16 A. No, sir, I do not.
- 17 Q. Do you know Guillermo Palmer's
- 18 qualifications to be aquatics director?
- 19 A. Guillermo's background was lifeguarding,
- 20 among other things. I know he was a tennis pro, also
- 21 personal trainer. But lifeguarded for us for either
- 22 two or three years prior to taking over as aquatics
- 23 director in 2006.
- 24 Q. So certainly, if someone was going to
- 25 understand the importance of scanning a pool 0180
- 1 adequately and continuously supervising young
- 2 children in the pool, he's the one that certainly
- 3 ought to understand the importance of that as being a
- 4 previous lifeguard; wouldn't you imagine?

- 5 A. He was very familiar with the procedure of 6 scanning, yes, and conveyed it to his lifeguards.
- 7 Q. And what were Guillermo Palmer's job
- 8 responsibilities as of July 18, 2007?
- 9 A. Hiring, firing of lifeguard staff,
- 10 scheduling of the staff, direct oversight of them as
- 11 well as all responsibilities for the physical
- 12 operation of the pool, chemicals, pumps, et cetera.
- 13 Q. How about training of lifeguard staff?
- 14 A. Yes, that would have been his responsibility 15 as well.
- 16 Q. And what experience did he have in those
- 17 areas prior to coming to the Racquet Club to your
- 18 knowledge, if any?
- 19 A. I can't speak to that.
- 20 Q. Is it true that after July 18, 2007 that
- 21 15 y/o LG #1 received a raise from the Racquet Club?
- A. You know, I don't think so, but I can't
- 23 confirm that for certain.
- Q. Well, let's look at Exhibit Number 11.
- 25 A. Okay.

- 1 Q. Now, this is from 15 y/o LG #1 's employee
- 2 history. And let's look at the third page, which is
- 3 document HRC 02847. That's just a stamp on the
- 4 bottom. But it indicates here that 15 y/o LG #1, at
- 5 least -- I don't really see a date on this page, but
- 6 it indicates that at some point in time she had a pay
- 7 rate of Privan hour. Do you see that?
- 8 A. Oh, yes. I see that, yes.
- 9 Q. Okay. And let's go to the second page. And
- 10 then we see on document HRC 02840, which is Page 2 of
- 11 Exhibit 11 that 15 y/o LG #1 as of August 24, 2007
- 12 had a change in her hourly compensation rate up to
- 13 Priv . Do you see that?
- 14 A. I do.
- 15 Q. And who signed off on that form? Does that
- 16 look like one of the signatures is Guillermo Palmer?
- 17 A. Guillermo's is the top one. I don't -- I
- 18 don't recognize the bottom one.
- 19 Q. Who do you suspect it would have been?
- 20 A. David Lamkin.
- 21 Q. And --
- 22 A. But I don't know that for sure.
- 23 Q. Okay. Does this indicate to you that
- 24 shortly after John Pluchinsky drowned, that the

- 25 lifeguard that was responsible for scanning his area 0182
- 1 of the pool where he was found floating facedown
- 2 actually received a pay raise from the Racquet Club?
- 3 A. It's not unusual at that time of the year.
- 4 Is that -- is that August 24th, sir?
- 5 Q. Yes.
- 6 A. Okay. We start running out of lifeguard
- 7 staff at that point. And it's not unusual for us to
- 8 have to offer them additional compensation to get
- 9 them to work at a time when they have so many other
- 10 things that they would rather be doing related to
- 11 school and other activities. So I would -- I would
- 12 speculate that 15 y/o LG #1 was given an increase in light
- 13 of her willingness to continue to work with us.
- 14 Q. You told me earlier in the deposition that
- 15 the last thing you wanted to do was speculate.
- 16 A. Okay.
- 17 Q. So I'm going to ask you not to speculate.
- 18 A. All right. Then I --
- 19 Q. And to --
- 20 A. -- retract my previous statement.
- 21 Q. And I just want you to answer my question.
- 22 My question is: Exhibit 11 shows that shortly after
- 23 John Pluchinsky drowned, the one lifeguard that was
- 24 responsible for scanning the area of the pool where
- 25 he was found floating facedown, 15 y/o LG #1, 0183
- 1 actually received a pay raise from the Racquet Club,
- 2 didn't she?
- 3 A. Yes, she did.
- 4 Q. Let's go to the fourth page of Exhibit 11 on
- 5 the top. And this document is a termination report
- 6 regarding 15 y/o LG #1, correct?
- 7 A. Yes.
- 8 Q. And let's go down -- let's go down a little
- 9 further. And who signed off on this termination
- 10 report?
- 11 A. Guillermo Palmer.
- 12 Q. Right. And this was February 18, 2008,
- 13 correct?
- 14 A. Yes, sir.
- 15 Q. And it indicates on the top that her last
- 16 day at work was actually August 2007, doesn't it?
- 17 A. Yes.
- 18 Q. And this was the immediate month following

- 19 John Pluchinsky's death, correct?
- 20 A. Yes.
- 21 Q. And Guillermo Palmer gave an employee
- 22 evaluation of this lifeguard that was responsible for
- 23 scanning the area where John Pluchinsky was found,
- 24 correct?
- 25 A. Yes.

- 1 Q. And he rated her in every single category:
- 2 Attendance, cooperation, initiative, job knowledge,
- 3 quality of work, job productivity, dependability,
- 4 work safety and management skills as not fair, not
- 5 satisfactory, not good, but excellent in every single
- 6 one of those categories, didn't he?
- 7 A. That's what it says.
- 8 Q. Not only that, but he says on this form that
- 9 he would recommend without reservation that she be
- 10 rehired, correct?
  - MR. MARRS: Go ahead and push it up --
- 12 A. I can't see that, sir.
  - MR. MARRS: -- so he can see the
- 14 recommendation.
- 15 A. Yes, that's correct.
- 16 Q. (BY MR. MARRS) What does it mean when the
- 17 Racquet Club says that it has a zero tolerance policy
- 18 for counselors and lifeguards that don't follow the
- 19 rules? Tell the jury what that means.
- 20 A. Well, the literal meaning of the word is
- 21 that we don't tolerate it even once.
- 22 Q. Not even once? Because if you don't follow
- 23 any of our rules even once, what will happen? What
- 24 does zero tolerance mean to you?
- 25 A. Well, I think that's open to interpretation.

- 1 Q. What's it generally mean?
- 2 A. Termination.
- 3 Q. Correct. It doesn't mean that we're going
- 4 to give you a pay raise if a kid dies on your watch,
- 5 does it?
- 6 MR. SNYDER: Objection, form. You
- 7 don't need to answer that.
  - THE WITNESS: Okay. Thank you.
- 9 Q. (BY MR. MARRS) Well, it doesn't -- zero
- 10 tolerance doesn't mean that I'm going to rate you as
- 11 being excellent in safety and every other category
- 12 even though on your watch a child drowned, does it?

- 13 MR. SNYDER: Objection, form. Same 14 objection.
- 15 Q. (BY MR. MARRS) After John Pluchinsky
- 16 drowned, who among all the counselors, lifeguards and
- 17 managers received any kind of reprimand at all?
- 18 A. No one.
- 19 Q. Who was terminated?
- 20 A. Terminated for which reason?
- 21 Q. Terminated as a result of John Pluchinsky
- 22 drowning?

- 23 A. As a result of John Pluchinsky drown --
- 24 Pluchinsky drowning, no one was terminated.
- 25 Q. Okay. Well, who was terminated? 0186
- 1 A. All of the lifeguards subsequently, but that
- 2 was simply -- they just stopped working for us.
  - Q. That happens --
- 4 A. Routinely.
- 5 Q. -- routinely?
- 6 But as a result of John Pluchinsky
- 7 drowning and the events under which he drowned, there
- 8 have been no reprimands, no terminations, no
- 9 consequences negative to any employee of the Houston
- 10 Racquet Club or manager or officer, correct?
- 11 A. That's correct.
- 12 Q. Pretty much business as usual even before
- 13 July 18, 2007?
- 14 MR. SNYDER: Objection, form.
- 15 A. I don't understand the question.
- 16 Q. (BY MR. MARRS) And what about CD's
- 17 daughter, CC-B, had she ever been a camp
- 18 supervisor of yours?
- 19 A. I don't know her or of her.
- 20 Q. And who is SC?
- 21 A. SC gives swim lessons at the
- 22 club. She's a contract employee.
- 23 Q. Have you talked to her about the incident on
- 24 July 18?
- A. We spoke briefly the day it happened, but 0187
- 1 not since then.
- 2 Q. And what did you -- What did she mention to 3 you?
- 4 A. I don't recall anything specific that she
- 5 mentioned. She accompanied us to the hospital. She
- 6 was one of the Racquet Club employees that came

- 7 along.
- 8 Q. Did she tell you anything about the incident
- 9 at the pool?
- 10 A. No, sir, she did not.
- 11 Q. Well, certainly you know as the general
- 12 manager that it is extremely important that your
- 13 lifeguards have current and valid CPR certifications
- 14 if they are going to be lifeguards on duty at your
- 15 pool, correct?
- 16 A. Yes.
- 17 Q. And it's also very important that your
- 18 counselor's have current and valid CPR certifications
- 19 if they are going to be counselors at your pool,
- 20 correct?
- 21 A. That's our standard.
- 22 Q. Who's in charge in making sure that that
- 23 standard is met?
- 24 A. For the counselors, David Lamkin; for the
- 25 lifeguards, Guillermo Palmer.

- 1 Q. Did either of those gentlemen fail in any
- 2 way with respect to making sure that the counselors
- 3 and/or lifeguards had current and valid CPR
- 4 certifications on July 18, 2007?
- 5 A. There was at least one counselor that day
- 6 whose certification had expired the month before.
- 7 Q. Who was that?
- 8 A. Supv CC #1.
- 9 Q. Anymore?
- 10 A. There may have been one more; however,
- 11 Supv CC #1 's card was issued by the American Red Cross.
- 12 The American Red Cross's standard is one year. The
- 13 other certifications that may have expired, I believe
- 14 it's -- that's a recommended renewal date. It's not
- 15 a -- it's not a hard and fast expiration date. But
- 16 again, I would need to review the cards to be
- 17 certain.
- 18 Q. Well, I'm talking about the CPR
- 19 certifications.
- 20 A. That's what I'm talking about, too, sir.
- 21 Q. Okay. So any lifeguards -- well, strike
- 22 that.
- 23 With respect to Supv CC #1 's CPR card being
- 24 expired as of July 18, 2007 when Supv CC #1 was acting as
- 25 a counselor, was he actually a counselor for John 0189

- 1 Pluchinsky?
- 2 A. He was a counselor supervisor.
- 3 Q. For John Pluchinsky?
- 4 A. Yes. And the other group in the water as
- 5 well.
- Q. And who failed to ensure that Supv CC #1, as a counselor for John Pluchinsky, had a valid and
- 8 current CPR certification?
- 9 MR. SNYDER: Objection, form.
- 10 Q. (BY MR. MARRS) Would that have been David 11 Lamkin?
- 12 A. Either David or Guillermo, I suppose.
- 13 Q. And were there any lifeguards that were on
- 14 duty on July 18, 2007 at the Houston Racquet Club
- 15 that did not have a valid CPR certification?
- 16 A. I think LG Supv certification had
- 17 also passed, but I'm not -- I can't confirm whether
- 18 his was recommended renewal or a hard expiration19 date.
- 20 Q. Well --
- 21 A. But it had just recently -- his anniversary
- 22 had just recently passed.
- 23 Q. But it is the policy of your club, at least
- 24 as of July 18, 2007, that whether or not it's a hard
- 25 expiration or a recommended expiration, that the card 0190
- 1 be valid and current for the time that they are
- 2 there, correct?
- 3 A. That's an interpretation of it. If it's a
- 4 recommended expiration date, I don't see it as such a
- 5 hard and fast requirement.
- 6 Q. So if it's a recommended expiration date for
- 7 a CPR certification from one of your lifeguards or
- 8 counselors, it's okay with you if it is not timely
- 9 brought current before it expires as long as it's a
- 10 recommended expiration date; is that your testimony?
- 11 A. Certainly --
  - MR. SNYDER: Objection, form.
- 13 A. -- I would prefer it if they would renew it
- 14 ahead of time. In this case there were a couple that
- 15 had not.

- 16 Q. (BY MR. MARRS) Well, what's the safe route
- 17 to take here? Isn't it safer to make sure that your
- 18 lifeguards and counselors have current and valid CPR
- 19 certifications?
- 20 MR. SNYDER: Objection, form.

- 21 A. All I can say is when that they were hired
- 22 for the season, their certifications were still in
- 23 place. They subsequently expired.
- 24 Q. (BY MR. MARRS) And that's a violation of
- 25 Texas law; you are aware of that now, aren't you? 0191
- 1 A. What's that, sir?
- 2 Q. To have a lifeguard on duty at your pool at
- 3 your club that doesn't have a valid and current CPR
- 4 certification. Are you not aware that that's a
- 5 violation of Texas law?
- 6 A. No, sir, I'm not.
- 7 Q. You're not aware that that's a violation of
- 8 the very TAC statute that's sitting in your office
- 9 that's printed out?
- 10 A. I would have --
- 11 Q. You're not aware of that?
- 12 A. I would have to review the documents.
- 13 Q. You'd have -- You didn't do that after
- 14 July 18 when this boy drowned in your pool with
- 15 lifeguards and counselors that did not have valid CPR
- 16 certifications?
- 17 A. Extensively, sir.
- 18 Q. But you didn't find that provision?
- 19 A. I just don't recall the specifics -- the
- 20 specifics of it.
- 21 Q. Let's go to Exhibit 13. And this would be
- 22 the Houston Racquet Club document Number 500,
- 23 Plaintiff's Exhibit 13.
- 24 MR. MARRS: Can you blow up the first
- 25 half of that for me?

- 1 MR. PLETCHER: Sure.
- 2 Q. (BY MR. MARRS) Now, was Sr LG #2, one of
- 3 the counselors on duty at the pool July 18, 2007, was
- 4 his CPR, AED card current as of July 18, 2007
- 5 according to this document?
- 6 MR. SNYDER: Can you see it?
- 7 A. I can see it. It appears to say "No Date",
- 8 so I don't know. It may or may not have been.
- 9 Q. (BY MR. MARRS) Okay. How about LG Supv,
- 10 the supervising lifeguard on duty somewhere
- 11 at the club, but not at the family pool directly on
- 12 July 18, 2007, was his CPR card current?
- 13 A. No, sir, it was not.
- 14 Q. It had expired, hadn't it?

- 15 A. Yes, it did.
- 16 Q. And how about LP LG, the lifeguard
- 17 that manned the lap pool at that time, was her CPR
- 18 card current or expired as of the time John passed 19 away?
- 20 A. I'm sorry, I can't see that one.
  - MR. PLETCHER: Who is that?
- 22 MR. MARRS: Can we blow it up a little,
- 23 LP LG?

- 24 Q. (BY MR. MARRS) It says 6-16-07.
- 25 MR. PLETCHER: Can you see her name 0193
- 1 there?
- 2 A. Yes, I do. Yeah. She had passed the
- 3 recommended renewal date.
- 4 Q. (BY MR. MARRS) Hers was expired as well, 5 correct?
- 6 A. She passed the recommended renewal date.
  - Q. Well, it says expiration date on the top
- 8 there, doesn't it?
- 9 A. It does, but that's just an internal
- 10 document. That's -- I think for the best evidence we
- 11 should take a look at the card itself, if you happen
- 12 to have it. I may be incorrect.
- 13 Q. Well, let's look at Page 4 of that same
